5. **Business Arising –**

- a) Budget Worksheet – Ron has completed a mark-up of a budget for the Hamlet for 2022. There was no recommendations made by Ron to increase the mill rate up from where it is currently sitting at 6. However, discussions regarding future planning for the Hamlet in the next 3-5 years, including considerations to recreation changes or upgrades, may see us look at potential changes to the mill rate for next year. 6. **Reports –**

- a) Finance – Ron has completed our budget for the year. Month to date we have no revenue to note. Total expenditures for the month of March are \$13,583.29.
- b) Transfer and Maintenance – Transfer site is clean and in good working order. The wood and trimmings piles will be burned sometime in the next month as we see the continued melt happening. We will continue to monitor the road to

the site to assess moisture levels and spring road conditions. A reminder to residents of the community that furniture is NOT to be dumped at our transfer site. If you have old furniture you would like to dispose of, please take it to the RM Transfer Site. To be clear it is an expense to our whole community when our Transfer and Maintenance crew has to clear these items.

Sometime this week there was a number of furniture pieces left at our site. If it was yours please arrange to have it removed.

- c) Lights and Lagoon – Lagoon road is clear and experiencing regular spring conditions, please slow down in soft areas. All lights in the community are in good working order.
- d) Roads and Water – So far no water issues to report as we are having a slow melt. Ron to talk to contractor in regards to road repairs for the year on Bayhill, as well as Capalano. We will continue to update as we have more information.
- e) Website – Regular maintenance and updates are happening to the website as needed. The RM Transfer Site hours and fees has been updated and we encourage the community to check out.
- f) RM Councillor – The grader came before the melt started to grade and push back snow for our transfer site as well as the south side of Capalano to help with drainage. RM budget meeting this past Monday discussed that there will be no changes to our mill rate, but there will be for areas of Burgis Beach and Canora Beach based on SAMA assessment. RCMP stats reviewed for the area. The RM has purchased a new mulcher and tractor for the purpose of rebuilding roads as opposed to contracting that work out.
