- b) RM Footwear safety allowance – The board discussed the request made by Linus Blackstock and in keeping with the RM Policy, we do not have a policy for footwear reimbursement. Steel-toed boots are required by maintenance staff, but they are to bring their own. Other safety equipment was purchased by the hamlet board for maintenance staff use.

- a) Finance – Members of the board reviewed the February Financial Statement. The Budget for the year will be put together sometime in March with input from all board members to ensure we are representing the needs of all taxpayers.

- b) Transfer and Maintenance – The transfer site is in good working order. Our thanks to the maintenance crew for their hard work keeping our community looking great.
- c) Lights and Lagoon – Lagoon road and all lights in the Hamlet are in good working order, with the exception of the light at the corner of Bayhill and Augusta as it is currently ponied to the adjacent light to ensure power until the Spring when the project can be completed to fix the light with some required trenching.
- d) Roads and Water – At this time the Hamlet has no water issues to report. The roads in the Hamlet are being cleared of snow on an as needed basis. Our many thanks to Dale Cherewyk for his timely work during the winter months.
- e) Website – Regular maintenance and updates are happening to the website as needed.
