Sales Contract and Health Guarantee

On this _____ day of _____, 20____, Round Table Bullies, herein referred to as the Seller, and _____, herein referred to as the Buyer, hereby agree to the conditions listed below.

The Seller hereby sells to the Buyer, for the amount of \$_____, the English Bulldog Puppy identified below. The Seller requires a \$500.00 non-refundable deposit to guarantee the purchase. Deposits will only be refunded if the puppy is injured, becomes sick or dies before the pick up date. The Deposit is required at the time the Buyer identifies and places a hold on the puppy. Full payment of the remaining amount due must be paid in full by at the time of delivery.

The Seller will provide AKC registration papers to the Buyer. It is the Buyers responsibility to complete the Registration. AKC papers will be Full AKC or Limited AKC (circle one).

If Full AKC breeding rights are being provided, Buyer understands and agrees that Round Table Bullies does not guarantee the breeding potential of this puppy. _____ (Buyer's Initials)

If Limited AKC Registration is being provided, Buyer agrees to provide Round Table Bullies with proof of spay/neuter before AKC registration paperwork will be provided. _____ (Buyer's Initials)

The Seller guarantees that the puppy is in good health now and will be on the date of pick up. The Seller will provide the Buyer with a current Florida Health Certificate.

- The Buyer agrees to pay for a licensed veterinary health examination within 7 days of taking possession of the puppy and to provide a receipt of those services to Round Table Bullies. The terms and conditions of this contract are not effective until the Seller has acknowledged receiving that receipt.
- The Buyer agrees to assume any financial responsibility for this exam. Veterinary expenses and/or medication are not covered under this contract.

- The Buyer agrees to maintain the puppy in good condition, including adherence to a regular immunization schedule, worming and heartworm prevention, a good diet and a clean and safe living environment. The Buyer agrees to provide adequate fresh water, quality food and rest to the puppy.
- The Buyer agrees to keep the puppy away from dog parks, grassy areas, pet stores, etc. until the puppy is at least 16 weeks of age and has received all required vaccinations.
- The Buyer agrees to keep the puppy away from lakes, rivers, oceans and other water areas where the puppy could be in danger of drowning unless proper safety protocols are followed.
- The Buyer assumes responsibility for protecting the puppy from loss, theft, danger, neglect and abuse.

If for any reason the original Buyer cannot keep the adopted puppy, they MUST return the puppy/dog to Round Table Bullies. The Buyer agrees NOT to resell any puppy/dog they purchase from the Seller. Buyer agrees that the puppy shall never be given to a rescue or shelter.

Round Table Bullies provides a Health Guarantee for the first full year of the puppy's life. This guarantee expires on _____.

1. This guarantee covers fatal and life altering congenital diseases only. Including severe hip dysplasia, as well as kidney, heart, pancreas, spine and liver problems of a severe or life threatening nature.
2. If the English Bulldog Puppy dies within this contract's effective period, the Buyer agrees to assume financial responsibility for an autopsy to be performed by a licensed veterinarian to determine cause of death.
3. Buyer agrees to forward the written autopsy report to the Seller. If the cause of death is found to be any affliction listed in the health guarantee of this contract, Seller agrees to replace the puppy with one of similar characteristics listed in this contract.
4. Buyer agrees there is no monetary refund of any kind, full or partial, guaranteed or implied.
5. The Puppy must exhibit the congenital defect within the effective date of this guarantee.
6. The Buyer agrees to notify the Seller of the problem and furnish veterinary reports by two (2) Licensed Veterinarians confirming the affliction within two (2) business days of discovery/diagnosis.
7. This guarantee does not apply to afflictions that are considered to be "common" in the Bulldog Breed including but not limited to: Cherry Eye, Entropion, Loose Hips, Skin Allergies, Elongated Soft Palate, and/or collapsed nostrils.
8. Any kind of parasites, bacteria or viruses, giardia and sickness that could be associated with the afflictions listed in this contract or environmental factors will not be covered by this guarantee.
9. The Seller does not assume responsibility for any medical expenses incurred associated with any health problem.
10. This guarantee does not apply to any physical problems that may be the result of an injury, abuse or neglect.

Refund/Return Policy

No Refunds under any circumstances. Any funds paid as a deposit, partial payment or full payment to Round Table Bullies or Owners before or after delivery of an animal are nonrefundable. Funds not used on a chosen animal may be used as an in-house credit at the discretion of Round Table Bullies.

This is the entire purchase contract; no other promise or stipulations are included or implied in this sale. In any and all Legal Action pertaining to this dog, this contract shall be considered legally binding. In the event of any dispute or disagreement under this contract, the laws of Florida will govern the resolution of the dispute. The venue for the resolution shall be Santa Rosa County, FL. To the extent that any provision of this contract may be invalid under any law of the state of the Buyer, all remaining provisions will be binding.
