# **Course Objectives**

- 1. Discuss the basics of tort law and its place in the U.S. legal system, pleadings, and the role of paralegals in client interviews and legal research.
- 2. Interpret intentional torts and how intent affects the legal outcome of an action.
- 3. Distinguish among defenses to intentional torts and remedies available to plaintiffs.
- 4. Define negligence, its elements, and damages.
- 5. Distinguish among the defenses to negligence and the remedies available to the plaintiff.

6. Examine strict liability as it pertains to harm caused by animals and other abnormally dangerous conditions.

- 7. Summarize products liability.
- 8. Describe strict liability defenses and remedies.
- 9. Explain and contrast defamation and disparagement; invasion of privacy, misrepresentation, tortious interference; and the *Prima Facie Tort Doctrine*.
- 10. Summarize the concepts of survival, wrongful death, birth, and life, joint tortfeasors, vicarious liability, and immunity from tort law.

# **SCANS Objectives**
