RV Site Rules & Local Armstrong Bylaws

Welcome to the RV sites at Overlander Golf & Event Centre. To ensure a safe, enjoyable stay for all guests, visitors must comply with site rules and City of Armstrong bylaws.

1. Quiet Hours & Noise Regulations


Quiet Hours: 10:00 PM – 8:00 AM

Please keep music, conversations, televisions, and generators at a reasonable volume.

Excessive noise may result in removal from the site.

Armstrong Noise & Good Neighbour Bylaws apply.

2. Pets & Animal Control

Pets must be always leashed.

Owners must clean up pet waste immediately.

Excessive barking or aggressive behaviour is not permitted.

Pets are not allowed on the golf course or inside clubhouse buildings.

Armstrong Animal Control Bylaws are enforced.

3. Parking, Traffic & Vehicle Rules

One RV and one additional vehicle per site unless approved.


Park only in designated RV spaces.

No parking on grass, roadways, or golf course areas.

Do not block fire lanes, exits, or service access.

City parking and traffic bylaws apply.

4. Garbage, Recycling & Waste Disposal

Use designated garbage and recycling bins.

Do not leave garbage outside overnight.

No dumping of household, automotive, or hazardous waste.

Improper disposal may violate Armstrong's Solid Waste Collection Bylaw.

5. Sewer, Water & Utilities

RVs must be self-contained.

Report leaks or utility issues to staff immediately.

Improper discharge may violate Armstrong's Sanitary & Storm Regulations.

6. Fires, BBQs & Fire Safety

Wood fires and open flame fire pits are not permitted on RV sites.

Guests may use CSA-approved propane fire pits only (portable, store-bought units).

Propane fire pits must:

Be in good working condition

Be always attended while in use

Be fully extinguished after use


Charcoal and propane BBQs are permitted.

Fires must comply with all local and provincial fire restrictions.

During fire bans, propane fire pits may also be restricted depending on current regulations.

Failure to comply with fire regulations may result in immediate removal from the site without refund.

7. Golf Course & Clubhouse Access

RV guests are welcome in the clubhouse, restaurant, and patio during operating hours.

Golf course access is restricted to golfers only.

Please remain aware of active play areas.

8. Children & Safety

Children must be always supervised.

Bikes, scooters, and play equipment must stay clear of roads and golf areas.

9. Prohibited Activities

No fireworks.

No weapons or illegal substances.

No commercial activity without written approval.

No open alcohol outside permitted areas.


10. Compliance & Enforcement

Armstrong Bylaw Enforcement may respond to complaints.

Management reserves the right to remove guests who violate site rules or bylaws.

No refunds for early departure due to rule violations.
