- 2. **Release of Liability:** I hereby release, waive, discharge, and covenant not to sue the Organizer, its officers, directors, employees, volunteers, agents, and representatives (collectively referred to as "Releasees") from any and all liability, claims, demands, actions, and causes of action whatsoever arising out of or related to any loss, damage, or injury, including but not limited to bodily injury, disability, or death, that I may sustain while participating in the League, whether caused by the negligence of the Releasees or otherwise.
- 3. Indemnification: I agree to indemnify, defend, and hold harmless the Releasees from and against any and all liabilities, claims, damages, costs, or expenses, including reasonable attorney's fees, arising out of or related to my participation in the League.
- 4. **Medical Treatment Authorization:** In the event of an injury or medical emergency, I authorize the Organizer and its representatives to obtain medical treatment for me, including transportation to a medical facility, if deemed necessary. I understand that I am solely responsible for any costs associated with such medical treatment.
 - 5. Rules and Regulations: I agree to abide by all rules, regulations, and policies set forth by the Organizer for the safe and fair conduct of the League.
 - 6. **Photographic Release:** I grant the Organizer the right to take photographs, videos, or other recordings of me during League activities and to use such materials for promotional purposes without compensation.
