

### PRESIDENT'S MESSAGE



#### TREASURER'S REPORT, INDIAN RIVER CHAPTER MOAA

March 2025

#### **MEMBERSHIP**

MOAA has recently rolled out a new Association Management System (AMS), with a portal for the chapter's use called the Committee Module (CM). The CM is used for maintaining our membership roster and recruiting new members. It's also a way to maintain the history of chapter membership and keep track of trends.

Additional updates will include managing current membership rosters and retrieving reports of former chapter members (called deactivated members). Moreover, it will allow the chapter to retrieve Near Real Time (NRT) reports for recruitment purposes with the ability to go back multiple months or years by using the filter option and applying dates in three-month increments.

Prior to the rollout of the new CM, our chapter had limited visibility and accessibility to the MOAA database. Thus, our chapter membership data was not always available for update. I have spent the past month or so getting this database up to date, as it is the source where we capture dues payment and develop the Social Roster. It primarily serves as the main source for our mailing list.

Bill Duffy is working on compiling an accurate 2025 Social Roster. We are both striving to keep member data current and accurate. I encourage all members to log into the National MOAA website, moaa.org, and verify/update their membership data if required.

#### CHAPTER AWARDS

In April, the 2024 MOAA awards were announced for the Councils and Chapters across the country. Units could apply for recognition for excellence and communication awards. The Indian River Chapter received two awards: the Five-Star Level of Excellence (LOE), which is the top recognition for excellence, and the Four-Star Colonel Marvin J. Harris Communications Award for Newsletter and Website.

In addition, we received approval for our request for a grant to continue our assistance to the veterans of Indian River County. The 2025 MOAA Community Outreach Grant will aid local veterans in need of economic assistance. This sustains the veterans helping veterans initiative begun over a decade ago.





#### JROTC AWARDS & SCHOLARSHIPS

Indian River Chapter MOAA board member Capt. Maryann Grodin, JAGC, USNR (Ret) presented two MOAA JROTC Awards and a \$1,000 MOAA Scholarship at the Navy JROTC Unit Sebastian River High School Awards Ceremony April 11.

The NJROTC unit, under Senior Naval Science Instructor Cdr. Peter Bissonnette, USN (Ret), nominated three outstanding cadets for these honors.

Cadet/Petty Officer 3 **Dereck Funez** and Cadet/Petty Officer 3 **Dago Rosales** received the MOAA JROTC Award, accompanied by a ribbon and medal. This award recognizes these cadets for their leadership, service, and academic achievement.

Cadet/LCDR **Abigail Ortiz**, the Cadet Commanding Officer, received the \$1,000 IRC Chapter MOAA Scholarship. An exemplary leader, she successfully completed the Leadership Academy Course and attended the American Legion Girls State Program. She will attend the University of Jacksonville and plans to be commissioned as a Navy Nurse Corps Officer.






