Bulldog track takes on county opponents

The Zephyrhills boys track and field team had the strongest showing of any east Pasco program. The Bulldogs managed to climb into second place behind Land O' Lakes. A few key runners and jumpers led the way.

Junior Maguire Neal posted 20 points on his own, just by sweeping both the 110 meter and 300 meter hurdles. Neal's times of 15.14 for the 110s and 39.22 for the 300s were tops among all hurdlers on Friday. The 110m time puts Neal in the top 10 of hurdlers

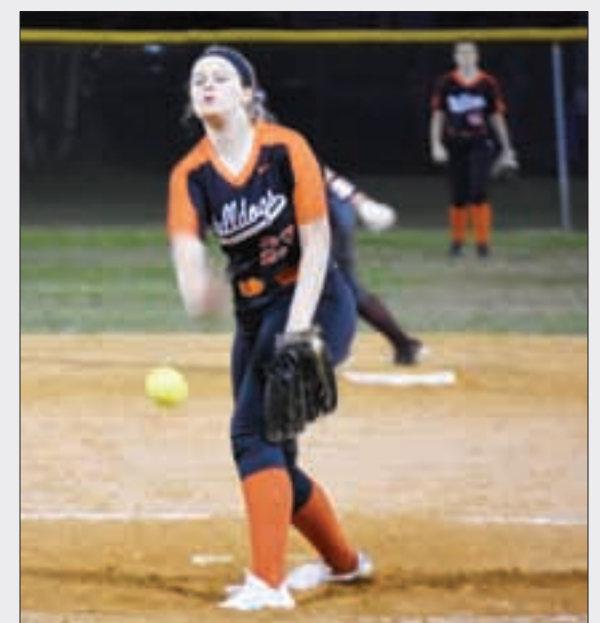
in Class 3A and the 300m time puts him in the top four. "We're happy with where he is but he could be much faster if we can break some bad habits," Zephyrhills boys coach Byran Thomas said. "He (Neal) has been able to get by with his athletic ability but we're moved up into 3-A this year and if he wants to get recruited (in the hurdles), he needs to be in the low 14s. He's on pace for it."

Neal also contributed a runner-up finish in the 100m sprint in 11.09, just missing out on the top spot by a 10th of a second. Football teammate and fellow sprinter TJ Jackson kicked in some big points for the Bulldogs. Jackson won the 200 meter dash in 22.64 and took third in the 100m dash in 11.18. He also won the long jump with a mark of 20 feet, 5 and a quarter inches (6.23m). The 200m time was Jackson's best time of his season and short career.

"Right now, he (Jackson) is at about 80 to 85 percent and getting stronger," Thomas said. "He takes coaching well and I can even see him giving other teammates tips."

Jackson has other company in the horizontal jumps with Tymar McKeever posting a 39 foot 2 and a half inch (11.95m) triple jump to

Season of blowouts for Bulldogs

Zephyrhills' softball team has been on both ends of a half-dozen lopsided games so far

The stage was set for a high-scoring blowout when Zephyrhills hosted Wiregrass Ranch last Wednesday. Only one team, however, remained hot at the plate.

Both teams were coming off dominating wins with the Bulldogs routing Anclote 17-1 and the Bulls dominating Tampa Bay Tech 19-2. The offense clicked for Wiregrass Ranch, which banged out 16 hits in a 12-0 victory that ended in five innings due to the Florida High School Athletic Association's 10-run mercy rule.

"The sticks are getting hot," Wiregrass Ranch coach Yamani Vazquez said. "That's what we've been looking for; the bats to stay hot."

On both sides of that game, however, Zephyrhills victimized a pair of opponents in lopsided wins. In addition to the Anclote game, the Bulldogs followed their disappointing loss to the Bulls with an impressive 15-2 rout of Fivay on Thursday.

Aside from a season-opening 12-10 loss to arch-rival Pasco, Zephyrhills has had a roller coaster ride so far. Six games have been decided by 12 runs or more with the Bulldogs coming out on the winning

Coyotes dominate Bulldogs on boys tennis court

No. 1 doubles thriller allows host Zephyrhills to salvage at least one match in a 6-1 defeat

Both teams entered Tuesday's boys tennis matchup with identical 1-4 records. Cypress Creek, however, showed it clearly was the better team with a 6-1 win. That is the complete opposite from last year's result between the Sunshine Athletic Conference rivals when Zephyrhills won 7-0.

"They're returning the favor from last year," said second-year Zephyrhills coach John Soellner, who also coaches that school's boys soccer team.

"We've got a long, long way to go," responded Cypress Creek coach Rob Patterson, who also coaches the

girls golf team at that school. Trailing 6-0, which included a forfeit at No. 5 singles due to Kamil Mehrab helping the Zephyrhills boys weightlifting team prepare for the conference meet the next day, the Bulldogs averted a shutout by notching their lone win.

In a No. 1 doubles match, David Castro hit a kill shot with a lot of back spin for an 8-6 win. Castro's partner with Yahir Torres to defeat Cypress Creek's Kai Penalosa and John Larsen.

"I mess it up and it still works," Castro said of his winning shot.

The Coyotes swept the top four singles matches to take a commanding 5-0 lead, which included the forfeit win, before the two doubles matches were played. Penalosa beat Torres 6-2, 6-3 at No. 1 singles, evening his season record to 3-3.

"I got smoked and I got down," Penalosa said of an early-season loss to perennial state contender Wiregrass Ranch.

A win over Gulf followed, but then came a 10-point loss to River Ridge's top player. That defeat helped Penalosa put things in perspective.

"Even though I lost I thought I played my best," said Penalosa, one of five juniors on the team.

For his part, Torres is making the adjustment of going from No. 4 singles last season — when the senior-laden Bulldogs got off to a 5-2 start before the coronavirus pandemic resulted in spring sports being cancelled — to No. 1 this year.

"It's a big upgrade," he said. "I play some good competition."

As the most seasoned player for Zephyrhills and being a senior, Torres often helps his teammates keep things in perspective.

"Don't get in your head," he said of the advice he imparts to them. "Just play your best the whole game. Just play like it's practice."

Soellner is proud of the way Torres has accepted his role on the team, yet reminisces about what could have been with last season's trio of district title contenders that included 2020 graduates Isaac Vincent, Braden Venger

and J.J. Rodriguez.

"They missed their chance at districts," Soellner said. "All three had a chance at districts. What a shame."

As for the rest of Tuesday's matches, Larsen and Castro lasted the longest of the singles matches. Competing at No. 2 singles, Larsen eventually pulled off a hotly contested 7-5, 7-5 victory.

At No. 3 singles, Ryan Ruiz, a promising freshman for Cypress Creek, beat sophomore Shawn Mcginley 6-3, 6-0. Marc Schwartz then won the No. 4 singles match, 6-1, 6-1 over Zephyrhills' Billie Boyd, another promising freshman.

Lastly, at No. 2 doubles, Cypress Creek's duo of Ruiz and Schwartz handily defeated Zephyrhills' Mcginley and Boyd 8-1.

While the Bulldogs have struggled for the most part this season, thanks in part four times being shutout, they did edge Hudson 4-3 for their lone victory. That came down to a No. 2 doubles match won by Castro and Boyd.

As for the Coyotes, their lone win before taking on Zephyrhills came against Gulf. That score was 5-2.

end in two of those. That left them with a 3-5 record.

"They came out (against Fivay) with a whole different attitude," said Zephyrhills assistant Chris Kauwala-Schultz, who also coaches the junior varsity team and previously coached the Pasco varsity softball team for two seasons. "The girls have just got to have the right mindset. I keep telling them I don't care what the score is, good or bad, you've got to finish."

Zephyrhills had no problem finishing against Fivay. Slugger and first baseman Brooke Lea slammed her team-leading second home run of the season and third baseman Gisele Navarra had three doubles with six RBIs against the Falcons. Also hitting doubles in that lopsided game for the Bulldogs were Bree Henagen, Izabella Mathis, Amberlyn Davis, Emma-Lei Buchanan and Alex Bowe-Wooton.

For her part, Navarra has been nursing a quad injury and has batted ninth in the lineup. As her health improves, she is expected to move up higher in the batting order.

Zephyrhills is expected to be challenged by some top-notch teams as the schedule gets tougher with perennial Pasco County powerhouses Sunlake and Mitchell ahead. The coaching staff is eager to see how the players

handle that higher level of talent.

"To me, they've been so used to getting beat by those upper schools that they expect to lose," said Kauwala-Schultz, who included Land O' Lakes and Cypress Creek in the aforementioned powerhouses. "It will be a test. We'll see."

As for Wiregrass Ranch, which also capitalized on three Zephyrhills errors in that rout, there were plenty of offensive standouts as the visiting team scored in every inning. That included five runs in the third that lifted the Bulls to an insurmountable 8-0 lead.

It all started with leadoff hitter Kylee Johnson, a standout shortstop who had three singles, reached on an error, scored twice and drove in a pair of runs. Coming up with two hits apiece were Isabella Amendolaro, Elise Eason and Abbey Vyas. Brianna Baer added a two-run single with Vyas driving in two and scoring twice.

While Zephyrhills starter Davis struggled in that game, allowing eight runs and 10 hits in three innings, Wiregrass Ranch pitcher Vyas breezed through three innings. She struck out all nine batters she faced before Ava Daly came on with two innings of scoreless relief.

Before facing Zephyrhills, Johnson had four hits with six RBIs and scored four runs against Tampa Bay Tech. Also in that game, Eason went 3-for-3 with four RBIs, and Amendolaro added three hits and scored three times.

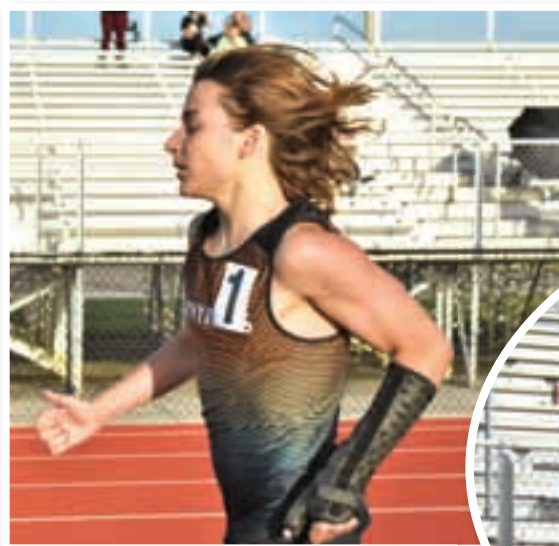

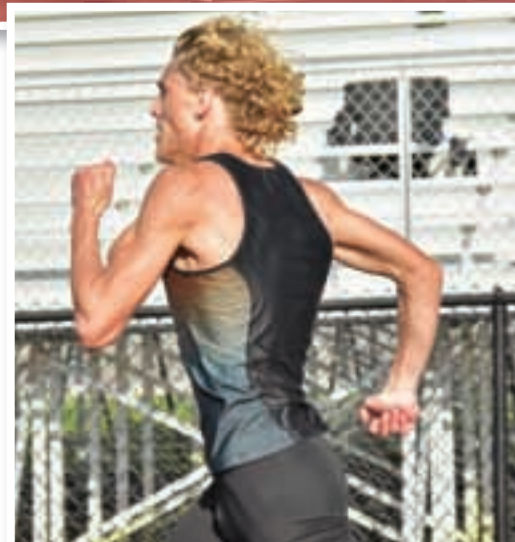

win the event for the Bulldogs. Teammate Jaylin Thomas took third in the event at 38-6 (11.73m). Again, it was the football players pumping up the team score. Senior Clayton Cornelius won the 400 meter in 50.25, a personal record. Teammates Christian Clemmens and Roberto Gomez took third and fourth, respectively. That trio, together with Neal, combined for the winning 4x400 meter relay that clobbered the field by more than 10 seconds (3:35.33). That time ranks them in the top 25 of all 4x400 meter relays in Class 3A.

"I've just been running, practicing running up hill," Cornelius said. "We run three-hundreds up the hill (next to U.S. Highway 301) near Advent Hospital."

We keep hearing this term, 3A and it's worth noting. Zephyrhills, for many years, competed in Class 2A. Not to take anything away from that classification but it was a classification for small urban schools or rural ones. Class 3A encompasses most public schools, all except the very largest, near major urban centers. It's widely accepted that Class 3A is one of the two toughest, perhaps the overall toughest classification in all of state track and field.

It will be even more difficult for the much smaller and younger Bulldog girls team to break through to states but they are not without prospects. Basketball star Maya Llanes is shaping up to be a solid sprinter and middle distance runner. She took second in the 100 meter (13.52), third in the 200 meter (27.99) and second in the 400 meter (1:04.15). Llanes has her sights set on the Zephyrhills school record in the 400m, the record just north of one minute. Llanes has a season best of 1:02 so far.

It would be other east Pasco ladies that really lit up the track Friday. Wiregrass Ranch, the girls team champion, saw junior Kat Fleming annihilate the field in both hurdle races. Fleming's 15.35 won the 100m hurdles by more than two seconds and her 47-flat in the 300 meter hurdles was almost four seconds faster than

the rest of the field. Those times put her in the top 10 among all female runners in Class 3A, for both events.

"I'm going for a personal record of 46 (seconds)," Fleming said. "I'm working more endurance now and on my form over the hurdles."

Cypress Creek's Tiffany Colin dominated the sprints, winning both the 100 meter in 12.75 and the 200 meter in 26.84. The sophomore has benefitted from sprint coach Steven Rivers joining the Cypress Creek coaching staff. Rivers trained a number of Division 1 sprinters both privately and while a coach at Pasco High School.

"We picked her (Colin) up during a rezoning from Wiregrass Ranch," Rivers said. "I told her during her first meet, that I wanted her to go sub-13. She did, in flats (not track spikes) on asphalt - and that was that."

Colin, just a sophomore, has a long runway to develop under Rivers.

"I love the fact that she (Colin) is both young and coachable," Rivers said.

The Coyote boys, feeding off their cross country success in the fall, have a tenacious tandem when it comes to distance events. Sophomore Zack Poekert and senior John Rowsell are a difficult combination to deal with. They crossed first and second place off the chart in the 1600 meter run, leaving the field a full 15 seconds behind them. Rowsell won it with a 4:29.12 and Poekert was second with a 4:31.27. Rowsell came back and won the 800 meter in 2:05.03 and then Poekert won the 3200 meter in 10:14.83. The pint-sized Poekert has a tall, a literal tall order, keeping pace with a lanky Rowsell, who covers about a stride-and-a-half to each of Poekert's strides.

"It's always my goal, is to try to beat him," Poekert said. "I just stare at his back and try to pace with him, even if it hurts."
