## ARTICLE VI CERTAIN RULES AND REGULATIONS

6.23 **Landscaping**. All landscaping and grass to be installed on each lot shall be set forth on a landscape plan which is approved by the ARC. No type or variety of grass other than St. Augustine or a hybrid thereof <u>or Zoysia</u> shall be planted on any Lot and such grass shall be fully planted on such areas where specified on a landscape plan approved by the ARC.
