I further agree, that in the event any suit is instituted against Jagge 07 Ranch or any of their officers, directors, employees, agents, owners and representatives, arising in any way from my negligence or the negligence of my guests, agents, employees or any other person using the facility with my permission or the negligence of any parties be indemnified. I agree to indemnify and hold Jagge 07 Ranch, Medina Valley Outfitters, Bexar County Bow Hunts and B&L Tschirhart Properties, its employees, owners, and representatives harmless from all liability in connection herewith, including, but not limited to, their attorney fees and cost involved in connection with defense of any such action. **I further agree to assume any and all liability for any and all claims that may arise during my use or occupation of the Jagge 07 Ranch or facilities.
