



## **Bourbon & Brushes Student Waiver & Release Agreement**

This Agreement is entered into between \*\*Bourbon & Brushes, LLC\*\* ("Company") and the undersigned participant ("Participant").

### **1. Acknowledgment of Activities**

Participant acknowledges that Bourbon & Brushes courses and experiences may involve:
