Bev Host has been coordinating potential updates to the Sherwood Loop Park. In my last newsletter, I had a request for feedback on the potential removal of buck thorn. I only received a couple responses and they were recommending to keep it as is. There does not appear to be interest one way or the other so I am removing the topic from the newsletter. If future ideas and plans evolve, they will be communicated. **Bev, thanks for your efforts and to those who helped with the gazebo renovation – It is appreciated!**

As mentioned, last month, Denny Niess would work with the granite contractor in the area to move debris from an HOA outlot and place granite along the shore of the quarries. Because the contractor was in the area and the material was free, we were only charged \$1,500. It is an improvement. Thanks, Denny!

I had stated in previous newsletters that we are working with our attorney on Covenants updates. One suggestion was that we confirm with a title company the properties legally assigned to our Quarry Woods Homeowners Association. I have been working with Sarah Dombrovski of Unique Title. She is conducting a search for us. I will provide updates as they evolve. We discussed fees and she stated that she has worked with many in our neighborhood and would not charge us unless exceptions are found which would require effort outside a search. That is nice!

Trail Resurfacing Update – We have placed a deposit with Done Right Contracting – They have resurfaced the trails in the past. We will be informed of the schedule. Stay tuned.

We are seeing a fair amount of trail use and hope the resurfacing is a minimal inconvenience. While on the topic, please ensure that you safely navigate the trails, be aware of others on the path and observe a reasonable speed on bikes and scooters.

I am not aware of any requests to the Architectural Review Committee (ARC) last month. Please keep in mind that additions, outbuildings, structural changes, fences or land alterations which may impact neighbors, are to go through the ARC. The ARC is headed by Denny Niess. Murray Mack coordinates the review and approval process.. If a review is not needed, the ARC will let you know.

Continuing Reminders

Remember to bring in or conceal your trash/recycling containers after they are emptied.

Drains - The City offers an "Adopt-A-Drain" program you can sign up for. You can monitor a drain(s) you sign up for and periodically clean debris. I have three I signed up for on Topaz Lane – Plenty more available to adopt. If you see a concern with a drain not functioning, please contact the City.
