#### **January 2026 Annual Meeting:**

Thank you to everyone who found the time to attend the annual meeting. It was a wonderful turnout, and a great chance to meet many of our new neighbors. For those of you that could not attend, there were no issues raised that were not included on the agenda. The minutes of the meeting are attached to this email. The meeting lasted only an hour, but many people stayed to socialize for an additional hour. Fantastic!

#### **2026 Voting results:**

There were two voting issues that needed to be decided for 2026. The neighborhood had to vote for a new member of the Quarry Woods HOA Board, and also committee members for the Quarry Woods Architectural Review Committee. Two weeks of online voting were available prior to the annual meeting. Paper ballots for those who had not voted electronically were used at the meeting. For a quorum to be met, we needed 25% (34 votes) of the total available votes (134 votes) in Quarry Woods HOA to be represented. Of the total votes available, 47 votes (35.07%) were cast in favor of the HOA open Board position, and 46 votes (34.33%) were cast in favor of the ARC. The results of the voting are as follows:

Bev Host was the lone nominee for the open Board position, and she garnered all 47 votes.

The vote for the Architectural Review Committee was taken as a unanimous consent vote for the slate of candidates. The slate consisted of Murray Mack, Jim Dahl, Bryant Fritz, Dennis Host, and Curt Nesse. There were 46 votes for approval and 1 vote against.

Bev, congratulations and welcome to the HOA Board, and congratulations to the ARC members.

#### **Lighting at 36th Street entrance:**

After several discussions with Xcel Energy about installing the street lighting on 36th Street, the Board decided to wait until spring for installation to avoid additional winter construction charges. We have now signed the contract as of last week and Xcel Energy will put us on the installation calendar for some time this spring. We will keep you up to date on the installation timing. The total for installing the lights is \$13,679.50 which has been paid.

#### **Sale of a portion of Outlot D:**

Thanks to all of you who took the time to vote regarding the sale of a small portion of Outlot D to the Jordet family. The measure passed with a majority in favor of the sale, and an email was sent out with the vote results. This small sliver of land will permit the Jordet family to abide by city code for the installation of their driveway. The contract to approve the sale has been signed, the plot of land surveyed, and the closing of the sale will occur soon.

#### **Neighborhood Watch:**

A member of the neighborhood suggested the idea of Quarry Woods utilizing Saint Cloud's Neighborhood Watch program as a useful tool to maintain the safety of our community. The Board discussed and agreed that it would be a valuable program to be a part of. Saint Cloud's Crime Prevention Specialist Emily Voigt will be our contact within the Saint Cloud Police Department. Emily

attended our annual meeting in January for a short, informative presentation. Emily left some educational material at the meeting. #### **Granite Company Activities Update:**

Communications continue to take place with the City of St. Cloud and the MPCA (Minnesota Pollution Control Agency) relative to compliance concerns with the activity taking place on Outlot F of the PUD (Planned Unit Development) that Quarry Woods is part of. The HOA will be updated with any news of substance as the review of the activity is taking place by the appropriate government bodies and agencies. #### **Placement of garbage/refuse containers:**

This is just a reminder and informational piece for our new residents. Our Quarry Woods covenants 6.12 read:

*Trash, garbage, or other wastes shall be kept in sanitary containers. All equipment for storage or disposal of such materials shall be kept in a clean and sanitary condition **and screened from public view.***

Please abide by the Quarry Woods covenants out of respect for your fellow neighbors. City garbage receptacles are to be stored out of sight from the street except on pick-up days.

#### **Keys for new residents for the combined mailboxes on 36th Street South:**

Craig Heurung, who lives on 36th Street South, has volunteered to be the facilitator of handing out keys to new residents as they move into their homes on 36th Street. Thank you, Craig, for taking on this task.

**Snow Shoveling:**

**This is just a friendly reminder that the City of Saint Cloud requires residents to clear snow from the sidewalks that front their property within 24 hours of a snow occurrence. Please note that this also applies to empty lots without a house. And if you have the ability to do so, please clear snow from around a fire hydrant that is close to your home.**
