## Program Overview, Registration Guide, & FAQs

### How & Where to Register:

#### Register with the PGA

The Golf Retirement Plus™ (GRP) program is administered by PGA Golf Enterprises, Inc. For enrollment information and program FAQs, contact a GRP Specialist at 833-PGA-PLUS (833-742-7587) or [click here](#). To receive GRP contributions in your retirement account, certain forms must be submitted and kept on file with the PGA of America each year:

#### Facility Authorization Agreement (FAA Form)

- This form authorizes the PGA to deposit partner contributions into your GRP account. It is required annually and must be on file for incentives to be distributed. Contributions are made at the end of each quarter.

#### Incentive Allocation Agreement (IAA Form)

- This form is only required if a PGA Member plans to share their contributions with another PGA Professional at the same facility. It must be completed and signed by all involved parties.

### Register with Imperial

### How to Earn with Imperial

To be eligible for a 3% contribution to your Golf Retirement Plus™ (GRP) account, you must purchase at least \$1,000 in Imperial products each calendar year. This includes licensed logoed items.

#### What is the minimum purchase requirement?

You must purchase a minimum of \$1,000 annually to qualify for GRP contributions.

#### Are there any restrictions to earning GRP contributions?

Yes. Only sales that are paid within terms are eligible for GRP contributions. Late or unpaid invoices will not count toward the annual purchase requirement or incentive calculation.

#### Is there a separate company enrollment form?

Yes. A company enrollment form must be submitted. You can complete the form on the following page or visit [imperial1916.com/pages/pgagrps](https://imperial1916.com/pages/pgagrps).

#### Am I required to enroll annually with Imperial?

No. You do not need to re-enroll with Imperial annually. Once enrolled, you will be automatically re-enrolled each year. However, if you change facilities or your PGA membership ends, it is your responsibility to notify Imperial promptly to ensure accurate disbursement of GRP incentives.

#### What is the program year?

The program year is January through December.

#### When are contributions deposited into my GRP account?

- Third Quarter: For qualifying sales invoiced January–June.
- First Quarter (of the following year): For qualifying sales invoiced July–December.

## New Program Enrollment & Current Member Information Update Form

To participate in the Golf Retirement Plus™ Imperial Program and earn GRP incentives, PGA Professionals must complete and submit the enrollment form to their Imperial sales representative, email it to [licensing@imperial1916.com](mailto:licensing@imperial1916.com), or fax it to (573) 679-2314.

Once enrolled, you do not need to re-enroll each year. Imperial will automatically renew your participation annually. However, if you change facilities or your PGA membership ends, it is your responsibility to notify Imperial promptly to ensure accurate disbursement of incentives.

To remain eligible, you must purchase at least \$1,000 in Imperial products per calendar year. Only sales that are paid within terms will qualify toward this total. Additionally, the PGA of America requires that a signed Facility Authorization Agreement be submitted each year in order for GRP contributions to be deposited into your retirement account.
