## Member Rules & Expectations

- (1) All Members must be over the age of 18.
  - (2) Members are responsible to update the Club if contact information changes. (Email and/or Mailing Address).
  - (3) New Members when accepted, will be on six-month probation period.
  - (4) New Members are noneligible to vote or be on any committees / sit on any Board elected position until one (1) year after the probation period ends.
  - (5) Members are not restricted to become a member of any other Car Club.
  - (6) Members will have the Oldsmobile Club of Ontario's best interest and will not benefit from the Club personally or financially without the written permission from the Board.
  - (7) All Members personal information will be for Club proposes only and will not be shared, unless requested on an individual basis from each member. (In order to contact another Member).
  - (8) No Member can gain from the club: financial gain, or head-hunting tactics.
  - (9) Members will not share (via email or paper copy) in whole or in part any; Emails, Monthly Flyer Updates and OCO Dispatch (Newsletter) sent out by the Oldsmobile Club of Ontario.
  - (10) No Member will reproduce OCO Logo (on clothing or any item) without the written permission of the Club.
  - (11) If membership does lapse – members will lose their OCO number (Discounts) and their member since date. If membership is renewed after loss of OCO number a new OCO # will be issued and a new member since date assigned.
  - (12) Members attending an OCO event must respect the venue property and neighbourhood. Purposely willful damage to venue or property including but not limited to stunt driving as described by Ontario law (O.Reg.455/07 section-172) (during cruises and car shows) will not be tolerated. Noncompliance can result in termination of membership and/or ban from OCO events.
