

The Kennel Budget is in good shape. The Kennel Finance Committee met on 28 FEB 2025 at the National Mid-Winter Conference. The Kennel Budget for the coming fiscal year has been worked out. It will be published in the Woof-O-Gram, before the Supreme Growl.

OPERATION CHOW HOUND:

The OCH Program has been a tremendous success and continues to grow. OCH is a voluntary program. You may collect food, supplies, and/or Big Bones to donate to your local no kill shelter. This may be done on every level, Pound, Pack, and Kennel. Many Detachments are currently supporting local Pounds with Chow collections. Go to the Kennel Website for the OCH Reporting Form, Receipt of Donation Form, and Logo. There is no requirement to report your donations to the Kennel at this time. All Pounds and Packs who would like to track their donations and send in the report are encouraged to do so. These reports should be emailed to the Honorable Jr. Vice Chief Devil Dog no later than 1 June, prior to the Supreme Growl. Please compile all donations into one total 12 month report, for the period 1 June – 31 May. The Honorable Quartermaster has "Pound K-9" kits for your pets. The cost is 20 Big Bones. PDD Sal Cenicacelaya has once again designed a beautiful OCH Patch for 2025. DD Scott Egan has done a fantastic job having them made. This 2025 OCH Patch is currently available in the Kennel Store for 6 Big Bones. The Big Bones made from Pound K-9 Kits and OCH Patches will be included in the annual donation for OCH, at the 85th Supreme Growl. As of 13 MAR 2025, we have collected 3,832 Big Bones for the Annual OCH Donation.



## Dog Robber: PDD Helen Breen

**W**OOF WOOF Dogs of the Order! It was great to see all the Dogs who attended the Mid-Winter Conference. I had some great conversations with many of you about the Kennel Management Application. It is awesome to hear how you are starting to use the system!

Speaking of the KMA – here are a few highlights since my last article:

- We have opened the use of the KMA to all Pound and Pack officers because we know that not all Dog Robbers are as tech-savvy. We need ALL Pounds and Packs to use this system for it to be as successful as possible!
- Pack elections across the Kennel are starting soon, it is **CRITICAL** that the Dog Robber team receive your ROIs as soon as the installations are complete!! You can enter the ROIs using the KMA – they can be signed electronically and submitted at the same time, no muss, no fuss! Be sure to confirm the officers you are electing are up to date on dues BEFORE you nominate and elect them!
- The Dog Robber Team has been working very hard to continue updating the Kennel Roster, working with the Bits & Bytes Team on the Kennel Management Application and are working on a project that we are VERY excited about and we think you're going to be excited about, too!
- The Kennel Management Application has been updated so now ALL Dogs can print their own membership cards or save to their phones. If you save your membership card to your phone, the Kennel Board of Trustees has authorized the saved card on your phone as a valid membership card for entry to Growls. Pounds and Packs can print membership cards for their members as well, and as always, the Kennel can print the cards for Pounds, if requested.
- Remember that Passport fees are due after each Grawl held! Do NOT hold Passport Fees, mail them in right away! Complete the Passport Transmittal Fees form on the KMA to keep the tally of your Growls for Compliance.
- We currently have 20.76% of our membership outstanding / past due as of March 15. We are still receiving Transmittals, so that number is adjusting every few days, but is still higher than we'd like it to be. We are also bringing members back from the archived list, which is a good thing! You can create your Transmittals using the KMA, print and send them with your check to your Pack Dog Robber.



If you have any questions on the status of a Dog in your Pound, please reach out to the Dog Robber team. We are here to answer those questions and help make sure every Dog's records are accurate.

## Operations Dog: PDD Lynn Sabel



**W**oof-Woof to all Dogs of the Order! If you did not go to the Mid-Winter Conference in Arlington, Virginia you missed a great Growl. There were 166 Dogs that registered. All Dogs regardless of degree can attend the Mini-Growl at Mid-Winter.

For all Devil Dogs who plan on advancing to Pedigree in Grapevine, Texas, NOW is the time to get your paperwork into your Pound Dog Robber. Make sure you keep a copy of the paperwork to bring with you (the Pack Dog Robber should send back to you). If he/she does not, contact them for a copy. All paperwork needs to be into the Kennel Dog Robber prior to July 1st. The process is - have your Pound Dog Robber and you complete the advancement form and mail it to your Pack Dog Robber. The Pack Dog Robber will forward it to the Kennel Dog Robber. All of that takes time. You cannot wait till the last minute to fill it out. If it comes in late, you will not be able to advance.

**Before you come to the Doghouse you will need to receive your credentials on the League side.** Also, it is recommended you check into the Doghouse on Sunday, August 10th. The latest you can register in the Doghouse is 5 PM on Monday, August 11th. Please bring the correct fees with you. Registration is 5 Big Bones and the Passport Stamp is 1 Big Bone. Make sure to have extra Big Bones with you in case you get fined before you reach us. If you do not bring in the correct amounts, there will be a donation to the Children's Fund.

## Veterinarian: PDD Howard Koontz

**W**oof Woof! Well, we Dogs survived the Mid-Winter Conference, and we are looking forward to an exciting year full of fun and games. I know the Convention seems far away, but August comes before you know it. Here is just a reminder of what you need to have done before you leave for Grapevine, Texas.

There will be Dogs and their families from all over the nation. Since we will be strangers, I would like you to get the following documents together and bring them with you. If you have a living will, end-of-life directive, or you are an organ donor, make a copy of the documentation and please bring it with you. That information should be on your person or in your room.

In the past five years, we have had some Dogs and their family members taken to the local hospital. Take time to put the following information on



a paper where it can be easily found (wallet, passport). This information will help if you are unable to talk for yourself.

- 1.) Emergency contact: name and phone number, including area code;
- 2.) Doctor or Primary Care Provider: name and phone number. If a VAMC, name of the facility and phone number;
- 3.) Pacemaker or history of heart problems, diabetic;
- 4.) Hip or knee replacement, etc. (in short, a brief medical history);
- 5.) List of all medications: name of drug, dosage. Bring enough meds and a prescription in case you lose your medicine;
- 6.) Living will, end-of-life directive, or are an organ donor;
- 7.) The name of the person that is with you and room number;

If you think you need an exception and cannot travel to Texas, you need to go through your Chain of Command to request one. Sorry, I cannot help you.



# Compliance Dog: PDD Steve Seyller



**W** OOF WOOF Dogs of the Order!

Just a few compliance topics to mention:

We still have some Pounds that are on a fiscal year filing with the IRS that have not filed their 990n's. These were due the 15th of November and are now past due. Any calendar year filers, your 990n's are due the 15th of May. Your Division Vice Chiefs have been emailed a copy of their Pack/Pound rosters. So, if you are not sure, you can reach out to me at the below email.

Just a note, the Bylaws Section 501 states:

**“The fiscal year of the MODD shall be for the same time and identical to the fiscal year of the MCL.”**

The MCL uses the fiscal year (1 July – 30 June). In the near future we need to attempt to get all Packs and Pounds in compliance with the Bylaws.

When you file your 990n make sure the receipt you send me is the “Accepted” receipt. If you send the notice you filed or a pending receipt I cannot mark you as compliant until the IRS updates their listing under your Pack/Pound. This sometimes may take months before they update their database. You can get the “Accepted” receipt about 10 minutes after you file.

1. To get back to your filing login as if you were going to file originally and login under Login.gov or ID.me
2. Select the right box “Manage 990-N submissions”
3. Select the appropriate year
4. Right click and either Save As or Print the accepted page. This is the receipt I need to mark you as current. IRS says it takes about 7 minutes from when you file before the accepted copy shows up. You may have to refresh the page to get it to change.

## Kennel Historian: PDD Greg Ciesielski

### **M**ODD History Events

One of the interesting facets of history is to go back and look at the key moments and facts of our organization. Here are a few tidbits to gnaw on.

**1939** – Our birth year and Gerald Bakelaar (NJ) is elected the first Chief Devil Dog.

**1940** – Our Kennel Charter is issued.

**1945** - Marine Joseph Probst (Chicago IL) reported that he had started the largest Pound in the west, Chicago Pound No. 12, and also coined the phrase “It’s An Honor To Be A Devil Dog”. This Pound also designed and manufactured the first “dog tag” and the Kennel officially approved them for Order use.

**1948** – The Kennels use of the dog tag was approved and started at the 1948 Supreme Growl.

**1950** - Passed by resolution at the convention, MODD members were authorized to wear the MCL cover as their official headgear with MODD patch. Past Chief Devil Dogs were authorized to wear the gold cover.

**1953** - The MODD Bylaws were adopted at the Supreme Growl. All Devil Dogs in the MODD, at this time, automatically became Pedigree Devil Dogs (PDD).

**1967** - A motion was made by PDD Hugh Maus (PA) that colored ribbons be worn to designate the different degrees. Seconded by PDD Charles Moser (CT). Motion carried. The ribbons to be worn will be Gold for PDD’s; Red for DD’s; Black for Pups.

**1969** - PCDD Jay Kacsan proposes a new ribbon be created for all Past Chief’s. This new ribbon is a braided tri-colored ribbon, black, red and gold, that replaces the gold ribbon currently worn by all Past Chief’s and PDD’s.

**1978** - PDD Ruetz (WI) told the body that the Jim Beam Corp is willing to issue a Devil Dog bottle for the 1979 Convention, at no expense to the Military Order of Devil Dogs. Motion by PDD Ruetz/2nd by PCDD Kacsan, Motion carried.

PCDD John P. “Jay” Kacsan (PA) is selected as the first Kennel Dog of the Year, MODD.

**1982** - The Chief’s “Badge of Office” was presented to the Kennel by PDD Edwin F. Gallagher, PCDD on 27 August 1982 at this Supreme Growl. This silver medallion and chain is to be passed down to each succeeding Chief Devil Dog. It was proposed by motion, seconded and passed unanimously.

CDD Paul Sutton had the “Chief’s Badge of Office” gold plated (Nov 1982) and the chain replaced with a gold braided chain. The silver badge was retired and stored for safekeeping.

**1987** - At this Supreme Growl, initiated by PDD Bill King, it was passed on the floor to create a “Passport” to be designed and issued at cost to all members of the MODD regardless of their rank or degree held. All Bones



(money) over actual costs of procuring the passports and rubber stamps shall be given to the National Kennel's Children Ward Hospital Fund. Fines will be levied to those Dogs that do not have their Passport with them at every Pound, Pack, or Supreme Growl. These fines can be designated, along with other fines, to be for the Children's Fund.

PCDD Gilbert Gray spoke to the body regarding the creation of a Hospital Fund at the Kennel level. The money donated to this fund would be given to a children's hospital annually in the city where the National Convention and Supreme Growl were held. A Motion was made by PCDD Gray to establish the fund. Motion was approved.

**1988** - Motion by PCDD Paul L. Sutton to establish a Past Chiefs Society which would establish awards for various purposes. Motion Approved.

**1989** – 50th Anniversary of the MODD. A special 50th Anniversary Dog Tag is created and issued to all Dogs that attended this Supreme Growl.

PDD George E. Williams pens the "Devil Dog's Creed".

The Children's Hospital Foundation of Dallas TX received a check from the MODD for \$2,000.00.

**1990** - CDD Mary Krauss presented miniature Chief Devil Dog Badge of Office to all living Past Chief's at this Supreme Growl. This "tag" replaced the gold dog tag that elected/appointed Kennel Officers wear. It hangs on the tri-colored braided ribbon that was first presented in 1975.

**1994** - PDD John J. Jarabek is selected as the first Honorary Chief Devil Dog (HCDD).

**1995** - CDD William C. Taylor receives a staff ("Mace of Office"), a gift from the late PDD Howard Goslin.

**2007** - The Past Chief's cover (Gold cover, black crown and red piping) was officially recognized in 2007 and approved by the MCL in 2008.

**2013** - The Chief's Staff. A new chief's staff has been presented to the 54th Chief and will be passed on to all future Chiefs. CDD Mike English has worked diligently on this project to ensure it happened. The wood was acquired by the Kennel Koncierge PDD Terry R. Hightower from the Belleau Wood (France) forest in 2012 and carved by Marine Bill Howrilla of Pennsylvania. The design was drawn by the Kennel Staff Artist PDD Jack Severn. The staff was anointed with water from the Devil Dog fountain just outside the woods in France obtained by PDD Ben Cero. The staff rests in a stand that has encased dirt that was also picked up from the Belleau Wood grounds by PDD Ben Cero.

**2014** – 75th Anniversary of the MODD. A special 75th Anniversary Dog Tag is created and issued to all Dogs that have attended this Supreme Growl.

**2024** – The new Chief's cover is black with gold piping so the Chief has a distinctive cover for better recognition. PDD Charles Minton makes a motion to adopt, PCDD English seconds. PCDD Hazlett amends the motion "to wear upon approval", PDD Minton seconds the amendment. The Amendment passes and the Amended motion passes. CDD Sanning changes gold cover to the new Chiefs cover after the passing of this motion. (Tuesday, 13 August 2024)

These are just some of the highlights of the Military Order of the Devil Dogs and I hope it brings a better awareness to the history of the Order.

If your Dogs are going up for advancement to PDD in Grapevine, Texas, then make sure they are in the Kennel Dog Robber's paws by 1 July. Once it is sent in it will be on the Kennel Website. If you do not see it near the deadline then contact your Pack Dog Robber to see if he/she signed it on the KMA (it does need their signature).

If you have been reading the WOGs, you have started to see almost constant references to the KMA or Kennel Management Application by the senior staff of the Kennel, including our Honorable Chief Devil Dog. I am glad to see everyone so excited about the application and have truly enjoyed building it for you. With all that said, what is the Kennel Management Application (KMA)?

The KMA is our new database system designed to be used by the officers of the Pounds, Packs, and Kennel to make running our organization more efficient and less burdensome so that even the Dog Robbers will have more time for Fun in our Fun and Honor Society.

This application is still under active development with new features being added and other features being refined. Feedback from the users and members of the Dog Robber Facebook Group has contributed greatly to the current application. We (the Dog Robber Team and Bits

& Bytes Team) also have a couple of exciting features about to start the testing phase, and we cannot wait to share them with you at the Supreme Growl in Grapevine, Texas. Currently, the application allows for the creation and submission of Notices of Death, Address (Information) Changes, Passport Transmittal Forms, Dues Transmittal Forms, Reports of Installation, Advancement Applications, Transfer Requests, and Membership Cards. Ref: Kennel Bylaws Article II Section 208

I would like to recommend the following proposed Bylaw change for consideration.

Article II Section 208- Eligibility to Hold Office section A sub paragraph 3.

Currently reads:

- A. All members of the Pound shall be eligible for election, or appointment, to any office in the Pound, Subject, however, to the following limitations and restrictions:
  - 1. The Pound Keeper must have the Degree of Devil Dog or Pedigreed Devil Dog, with the Degree of Pedigreed Devil Dog being preferred.
  - 2. It is preferable that the Pound Dog Robber has the Degree of Devil Dog or Pedigreed Devil Dog.
  - 3. To be eligible for an elective or appointive office, a Pup must have been a faithful Pup for at least one calendar year. This restriction may be waived ONLY when the fifth person making application for a Pound Charter is a Pup, who may be a proper Charter Applicant, and the Pup Charter Applicant may hold any Appointive Office other than that of the Pound Dog Robber. A Pup will be eligible to hold any office in the Pound that is elective other than the Pound Keeper and Pound Dog Robber.
  - 4. All officers must be currently paid up in membership dues in the Marine Corps League, Inc., and in the Order.
  - 5. Any officer permitting their membership dues and good standing in the Marine Corps League, Inc., and in the ORDER, to lapse, shall forthwith surrender their office, and the office be declared vacant.
  - 6. Any nominee for any elective office must be present at the time their name is placed in nomination and shall accept the office, except for valid reasons. The DOG ROBBER provided they have stated by written word their acceptance of the office if elected, may be nominated and elected in absentia.

Change to read

Section 208- Eligibility to Hold Office section A sub paragraph 3.

- A. All members of the Pound shall be eligible for election, or appointment, to any office in the Pound, Subject, however, to the following limitations and restrictions:
  - 1. The Pound Keeper must have the degree of Devil Dog or Pedigreed Devil Dog, with the degree of Pedigreed Devil Dog being preferred.
  - 2. It is preferable that the Pound Dog Robber has the degree of Devil Dog or Pedigreed Devil Dog.

Bylaw #1

3. To be eligible for an elected or appointed office, a Pup should be a faithful Pup for at least one (1) calendar year. This restriction may be waived ONLY when the fifth person making application for a Pound Charter is a Pup, who may be a proper Charter applicant, and the Pup Charter applicant may hold any appointed office other than that of the Pound Dog Robber. A Pup will be eligible to hold any office in the Pound that is elected other than the Pound Keeper. or if there are no other eligible Dogs to accept the nomination to an Elected or Appointed position during regular elections within the Pound, then a PUP who has attended a minimum of two Growls may be nominated and elected or appointed to a position within the Pound except for the position of Pound Keeper or Pound Dog Robber.
4. All Officers must be currently paid up in membership dues in the MCL, and in the MODD.
5. Any Officer permitting their membership dues and good standing in the MCL and in the MODD, to lapse shall forthwith surrender their office, and the office be declared vacant.
6. Any nominee for any elected office must be present at the time their name is placed in nomination and shall accept the office, except for valid reasons. The Dog Robber, provided they have stated by written word their acceptance of the office if elected, may be nominated and elected in absentia.

Rational:

By changing this too SHOULD be a faithful Pup for 1 calendar year, would allow those Pups who are wanting to step up and accept a position within the Pound, have a chance to do so. If they feel like they are involved and have a purpose in the Pound, they will continue to attend Growls and be a productive Dog in the Order.

I would like to recommend the following proposed Bylaw change for consideration.

Article IX Section 901 Pounds

Currently reads:

- A. The Officer installing the new Officers of a Pound should be a Pedigreed Devil Dog if possible, or shall be a Past Pound Keeper, or an incumbent elected Pound Officer, or past elected Pound Officer, or current/past Pack elected Officer, or current/past Kennel elected Officer.

Immediately following the Installation, the Installing Officer shall make a full report to the Pack Dog Robber, the Honorable Dog Robber and the Vice Chief Devil Dog of the Division. The report shall include the date and place, names, addresses and titles of all Officers installed.

Change to read

Article IX Section 901 Pounds

- A. The Officer installing the new Officers of a Pound should be a Pedigreed Devil Dog if possible, or shall be a Past Pound Keeper, or past elected Pound Officer, or current/past Pack elected Officer, or current/past Kennel elected Officer. Immediately following the Installation, the Installing Officer shall make a full report to the Pack Dog Robber, the Honorable Dog Robber and the Vice Chief Devil Dog of the Division. The report shall include the date and place, names, addresses and titles of all Officers installed.

Rationale

There is not a proper way for an incumbent elected Pound Officer to properly swear themselves in. By removing "or an incumbent elected Pound Officer" ensures that the Pound Officers are properly installed.

Immediately following the Installation, the Installing Officer shall make a full report to the Honorable Dog Robber, via the Vice Chief Devil Dog of the Division, including the date and place, names and addresses and titles of all Officers installed and the current condition of the Pack.

There is not a proper way for an incumbent elected Pack Officer to properly swear themselves in. By removing "or an incumbent elected Pack Officer" ensures that the Pack Officers are properly installed.

I would like to recommend the following proposed bylaw change for consideration.

Article V Section 505 Passports / Visa Stamps

Currently reads:

- A. All Devil Dogs shall procure a the MODD Passport at a cost regulated by the Kennel, which will distribute them to the Packs and the Pounds. The fine for attending any Kennel, Pack, or Pound Growl will be one dollar (\$1.00) without a Passport in any attending Devil Dogs possession.
- B. The Kennel, Packs, and Pounds will procure a Visa Stamp to stamp all Passports with the date of all Growls attended by said Devil Dog presenting their Passport. Cost of visa stamping shall be one dollar (\$1.00).
- C. All monies collected for Passport or visa stamping shall be forwarded after each Growl to the Honorable Dog Robber, who will hold these monies in a special Passport account.
- D. All monies collected will be used each year at the MCL National Convention, where a check for a sizable portion of that account will be presented first, to a children's hospital in the convention city, or to another suitable local charity as the Executive Board of the MODD, may select. The check shall be accompanied by a letter stipulating that the MODD's contribution is to be used for special equipment purchases only and for no other purpose.
- E. Any Devil Dog Passport that is lost, or misplaced, not stolen, if turned into either the Kennel, Pack, or Pound Dog Robber, shall be stamped four times and returned at a cost of two dollars (\$2.00), as a finder's fee.

Change dollars to Big Bones and add sub paragraph F.

- A. All Devil Dogs shall procure a the MODD Passport at a cost regulated by the Kennel, which will distribute them to the Packs and the Pounds. The fine for attending any Kennel, Pack, or Pound Growl will be one big bone (\$1.00) without a Passport in any attending Devil Dogs possession.
- B. The Kennel, Packs, and Pounds will procure a Visa Stamp to stamp all Passports with the date of all Growls attended by said Devil Dog presenting their Passport. Cost of visa stamping shall be one big bone (\$1.00).

Bylaw #4

- C. All monies collected for Passport or visa stamping shall be forwarded after each Growl to the Honorable Dog Robber, who will hold these monies in a special Passport account.
- D. All monies collected will be used each year at the MCL National Convention, where a check for a sizable portion of that account will be presented first, to a children's hospital in the convention city, or to another suitable local charity as the Executive Board of the MODD, may select. The check shall be accompanied by a letter stipulating that the MODD's contribution is to be used for special equipment purchases only and for no other purpose.
- E. Any Devil Dog Passport that is lost, or misplaced, not stolen, if turned into either the Kennel, Pack, or Pound Dog Robber, shall be stamped four times and returned at a cost of two big bones (\$2.00), as a finder's fee.
- F. The minimum required items that are to be presented with a Dogs Passport are, their current MCL and MODD membership cards, either the hard copy or an electronic copy. Pounds and Packs may add additional items at their discretion.

Rationale:

We do not use dollars in the MODD, we use Bones. There is not a current list of items that are required to be in the Passport. Dog Robbers always ask to see these items, but they were never officially listed anywhere in our By Laws, Ritual or Handbook that a Dog must have these items in their Passports. This change will list the bare minimum items that are required to be in every Dogs Passport and still give the Pounds and Packs a chance to add their own required items to the passports.

#### Current Language:

2. The Honorable Chief Devil Dog after assuming office may appoint such other Kennel Officers and Honorable Vice Chief Devil Dogs of Divisions and Aides as he/she may see fit may also be appointed as may be fit and proper and such appointed Officers shall serve only at the convenience and pleasure of the Honorable Chief Devil Dog.

#### Proposed Language:

2. The Honorable Chief Devil Dog after assuming office may appoint such other Kennel Officers and Honorable Vice Chief Devil Dogs of Divisions and Aides as he/she may see fit may also be appointed as may be fit and proper and such appointed Officers shall serve only at the convenience and pleasure of the Honorable Chief Devil Dog.

3. The Honorable Vice Chief Devil Dog of the Division may be appointed provided that such appointees are not currently holding office as Worthy Pack Leaders.

**Rationale:** It is important to have a clear chain of command and separation of powers so if an issue arises there is no conflict of interest, leaving the only option from Pack issue to Kennel being official complaints.

2. The Honorable Chief Devil Dog, after assuming office may appoint such other Honorable Kennel Officers, and Vice Chief Devil Dogs of the Divisions.

Suggested rewrite as Paragraph 3

Vice Chief Devil Dogs of the Division shall be elected during the Division Conference to serve a term of two (2) years and may stand for re-election of one (1) subsequent term.

Rationale:

The Division Vice Commandant is elected in this manner as is the Assistant Vice Commandant. This puts the Kennel in line with National.

This suggested change gives the Dogs of the Division someone they elect to represent them to the Kennel that they know and are familiar with, rather than someone they may not know. It also gives the elected Vice Chief more "clout" to get things done per Kennel (Chief) Officers direction. Further, it gives the elected Vice Chief an easier path to counsel Pack Leaders and Pound Keepers and/or members when needed. The recognition will ensure there is a direct path to Kennel for questions, reports, and items that need to be completed to be in compliance with Kennel.

In accordance with MODD Constitution and Bylaws (Revised 2023), Article IV, Section 403 and Article XIII, Section 1301 the following is submitted for consideration.

**Proposed bylaw changes to Section 410: Nomination / Election / Installation / Tenure**

**Section 410: D Tenure. 4.**

**CURRENT:**

The Honorable Executive Director shall be a permanent, compensated position, subject to the annual approval of the Honorable Chief Devil Dog. The Honorable Executive Director shall be appointed from the ranks of qualified Pedigreed Devil Dogs who are extremely knowledgeable in the administrative affairs and duties of the MODD. The Honorable Executive Director shall be paid an annual honorarium as defined in the Kennel's annual budget. Should the Honorable Executive Director decline the position for another term, he/she must, within thirty (30) days after the Supreme Growl of the Kennel turn over all monies and records to the newly appointed Honorable Executive Director.

**PROPOSED:**

Section 410: Nomination / Election / Installation / Tenure.

D Tenure. 4.

- a. The office of Kennel Executive Director shall be a permanent compensated position.
- b. The Honorable Executive Director shall be nominated from the ranks of qualified Pedigreed Devil Dogs who are extremely knowledgeable in the administrative affairs and duties of the MODD by the Chief Devil Dog and approved by a simple majority vote of the Kennel Board of Trustees.
- c. The Honorable Executive Director shall be paid an annual honorarium as defined in the Kennel's annual budget.
- d. The Honorable Executive Director may succeed him/herself for as many terms of office as they are reappointed. The Honorable Executive Director may be reappointed by successive Honorable Chiefs Devil Dog.
- e. The Honorable Executive Director may be removed from office, with or without prejudice, by the Honorable Chief Devil Dog.
- f. Should the Kennel Executive Director (KED) decline the position for another term or be removed from office by the Honorable Chief Devil Dog, he/she must, within thirty (30) days after the Supreme Growl or date of removal, turn over all monies, records, passwords, and

- g. other items necessary for the day-to-day operation of the Kennel, to the newly appointed or interim Honorable Kennel Executive Director.

RATIONALE:

There is a conflict between being in a permanent compensated position yet requiring annual appointment. Separating the office from the person (Dog) removes any ambiguity.

It is understood that the Honorable Chief Devil Dog should have the prerogative to select his/her Kennel Executive Director. However, the constant churning of KEDs could undermine the Kennel's operations. Requiring the consent of the Board of Trustees provides incentive to conduct due diligence on the nominee's qualifications.

The duties and responsibilities of an executive director are to manage the day-to-day operations of an organization. The KED works closely with the Board of Trustees, the Kennel Dog Robber, Webmaster, and Quartermaster. The KED also works closely with the Honorable Senior Vice Chief Devil Dog and Webmaster to create and maintain Kennel membership rosters. Additionally, the KED maintains the Kennel's checking and savings accounts. The KED is the single collection point for funds raised by the Operations Dog, Lucky Dog, and others. The KED makes all bank deposits following a Supreme Growl.

Such duties require a high level of training, experience, and education in areas such as book and record keeping, insurance, and overall business acumen. Continuity and "corporate (Kennel) knowledge" are essential to the smooth running of the organization. A constant turnover in KEDs would be detrimental to the stability of the Kennel.

This bylaw change would allow the KED the ability to plan ahead with the Kennel Board of Trustees, Past Chiefs Society, and others, and see those plans to completion without the uncertainty of yearly turnover.

I would like to recommend the following proposed bylaw change for consideration.

Article I Section 101 B: The Degrees of Membership in the MODD

Currently reads:

1. The degree of Pup to be granted to all qualified candidates at any Growl of the Pound; by limitation hereinafter set forth, may also be granted the degree at the Pack and Kennel level.
2. The degree of Devil Dog to be granted to all qualified candidates at any Growl of the Pack; by limitation hereinafter set forth, may also be granted at the Kennel level.
3. The degree of Pedigreed Devil Dog to be granted to all qualified candidates ONLY at the Supreme Growl of the MODD

4. The degree of Chief Devil Dog (CDD), be granted to all those who are properly elected and installed by vote of the Order Only during the Annual Supreme Growl.
5. The degree of Past Chief Devil Dog (PCDD), be granted to any CDD that has completed their duties as Chief Devil Dog of the Order immediately at the election and installation of the new CDD.

Rationale:

The Honorable Chief Devil Dog and the Honorable Past Chief Devil Dogs will never again wear the Gold Collar which is symbolic of the Pedigree Devil Dog; nor will they ever again hold the title of PDD. The Honorable Chief Devil Dog will be referred to, addressed as and identified as "The Honorable Chief Devil Dog" and will wear the appropriate Medallion representing the Honorable Chief Devil Dog.

The Honorable Past Chief Devil Dogs will be referred to, addressed as and identified as "Honorable Past Chief Devil Dog" and will wear the appropriate Medallion representing an Honorable Past Chief Devil Dog.

**Proposed Wording:**

- A. Any member of the MODD who has not paid their membership dues in the MODD for the next membership year by September 1, as stipulated in ARTICLE V – FISCAL AND FINANCE, Section 503, shall be determined to be delinquent.
- B. The delinquent member may remain in delinquent status for a maximum of one year, during which time the member can return to good standing by paying delinquent dues with no reinstatement penalty.
- C. Should the member remain delinquent at the end of one year, he/she shall be removed from the active membership roster. If the member wishes to reactivate his/her membership after being removed from the active roster, he/she must pay a reinstatement fee as stipulated in Section 108: Reinstatement.

**Rationale:**

The Supreme Growl of the Kennel does not end the Membership Year and we have not dropped members at that point for a number of years. This amendment clarifies the delinquency of past-due members and when members are removed from the active roster.

## CONSTITUTION ARTICLE I – MEMBERSHIP

### ***Existing Wording:***

#### SECTION 101: Eligibility

B. Any such other candidate who is in failing health, and to whom the trip to the Grand Growl of the Pack or the Supreme Growl of the Kennel would cause undue hardship and/or physical endangerment, shall, by written request of the Pound with the approval endorsement of the Pack, and with the written permission of the Honorable Chief Devil Dog, be permitted elevation to the next higher degree at a Growl of the Pound, or at a Special Growl of the Pack permit. Pounds that are not part of a functioning Pack may petition the Honorable Chief Devil Dog directly. The written request from the Pound on behalf of a Pup or Devil Dog in failing health shall be accompanied by a statement from competent medical authority specifically addressing the condition of the individual for whom the exemption is being sought. The Pound Keeper's written request shall be countersigned by the Worthy Pack Leader in states where there is a functioning Pack; or, sent directly to the Honorable Chief Devil Dog where there is not a functioning Pack in the state, with a copy of the request sent directly to the Honorable Vice Chief Devil Dog of the respective Division. All requests for medical, World War II, and Korean War service exemptions shall be sent directly to the Honorable Dog Robber for factual verification. Once the Honorable Dog Robber validates, both, the faithful service of the Devil Dog for whom the medical exemption is sought and has determined that the medical evidence provided is compelling and complete; the Honorable Dog Robber shall obtain from the Honorable Chief Devil Dog such approval (either in hard copy or digitally) of the request of either the Pound or the Pack as determined to be sufficient for record-keeping purposes and, by direction, notify the Pound or the Pack as soon as possible that the request for World War II, Korean War Veteran wartime service and/or medical exemption has been granted. Once the written approval has been received from the Honorable Chief Devil Dog, the Pound Keeper, or Pack Leader, as appropriate, shall appoint an Installation Officer and Installation Team appropriate for the degree to be conferred, with the express understanding that said Growl will be held within ninety (90) days of the receipt of the written permission of the Honorable Chief Devil Dog. The Honorable Chief Devil Dog and, in the case of a Growl of the Pound, the Worthy Pack Leader should ensure that there is a representative from their respective Staff, whenever possible.

### ***Proposed Wording:***

B. Any other member who is in **long-term** failing health, and to whom the trip to the Grand Growl of the Pack or the Supreme Growl of the Kennel would cause undue hardship and/or physical endangerment, may request a special advancement at a Growl of the Pound or Special Growl of the Pack. Requests for special advancement must be submitted via the member's Pound, endorsed by the Pack, and approved by the Honorable Chief Devil Dog. Pounds that are not part of a Pack may petition the Honorable Chief Devil Dog directly.

**ADD**

C. A request for advancement of an eligible member who is a World War I, World War II, or Korean War Veteran as referenced in Section 108 (4) (a) should be submitted to the Honorable Dog Robber with an endorsement letter from the Pound Keeper and a copy of the member's DD-214.

D. A request for special advancement due to medical exemption must be submitted to the Honorable Dog Robber and must include the following:

i. Request letter from the Pound Keeper, endorsed by the Pack Leader, stating the involvement of the member in the Pound.

ii. Letter from the member's doctor stating that due to the member's long-term medical condition, travel in any manner is not possible (note: the specific medical condition does NOT have to be shared, only that the member will not be able to travel for the foreseeable future)

E. Once the Honorable Dog Robber receives and validates the information Exemption; he/she shall obtain from the Honorable Chief Devil Dog approval for the Advancement. Once the written approval has been received from the Honorable Chief Devil Dog, the Pound Keeper, or Pack Leader, as appropriate, shall appoint an Installation Officer and Installation Team appropriate for the degree to be conferred, with the express understanding that said Grawl will be held within ninety (90) days of the receipt of the written permission of the Honorable Chief Devil Dog. The respective Division Vice Chief Devil Dog and, in the case of a Grawl of the Pound, the Worthy Pack Leader should ensure that there is a representative from their respective Staff, whenever possible.

***Rationale:***

The current wording the Bylaws is a long run-on sentence that is unclear and hard to read. By breaking up Paragraph B into more management bits and explaining the requirements, we give the Pounds better guidance on how to proceed to advancing those Dogs who may never be able to join us at a Supreme Grawl due to age, infirmities, or medical issues.

**Proposed Wording:**

ELECTED - The elected Officers of the Pound shall be the Pound Keeper (who shall not concurrently hold the office of Pound Dog Robber), Senior Vice Pound Keeper, Junior Vice Pound Keeper, Pound Smart Dog, Pound Dog Trainer, Pound Police Dog, and Pound Mad Dog. **No member may hold more than one elected office but may serve in an elected and appointed office concurrently, except as otherwise stated.**

**Rationale:**

Each member of the Board of Trustees has one vote. Each Pound should want as many voices on the Board making the decisions as possible. While some Pounds have challenges filling positions, there are Pounds with large memberships that simply don't have members filling elected positions, which is not acceptable. There is no elected or appointed position at the Pound level that is a high-demand role, other than Pound Keeper and Dog Robber. Educating Pound members on the responsibilities of the positions may help increase interest in filling those roles.

Section 319 of the Kennel Bylaws gives the Packs until 30 June to submit ROIs before falling into default, which for some Packs may be less than 30 days, depending on when they hold.

This proposed change will still give Pounds more than adequate time to complete and submit the ROI and more of a grace period than we give Packs in submitting the Report of Installation, especially with the implementation of the Kennel Management Application, which gives the Pounds and Packs the ability to submit the ROI immediately upon the completion of installation.

SECTION 1209: Life Memberships:

E. PLMs shall be made available at a cost of \$150.00 each for those members of the MODD who are up to and including age 60 years, and for \$125.00 for those members who are age 61 years and above. All applicants shall meet the following criteria. NOTE: Because the PLM is classified as dues (Section 104), the current flat rate of \$100.00 will remain in effect until the close of the Supreme Growl of the Kennel in 2005 and the increase shall become effective at that time.

1. The member shall be a Pedigreed Devil Dog, shall be a PLM of the MCL, and shall have no outstanding obligations to either the MODD or the MCL.

2. Life Memberships in the MODD are to be ultimately transmitted to the Honorable Dog Robber. Life membership dues are based on age. Members up to including 60 years of age, the dues are \$150; Members age 61 and older, the dues are \$125.00. Payment for life membership dues shall be as follows:

a. The Pound Dog Robber shall remit a check deducting \$30.00 (*e.g., members of the MODD up to and including 60 years of age, the Pound Dog Robber shall remit a check in the amount of \$120.00. For members of the MODD 61 years and older, the check amount shall be \$95.00*)

i. If the member belongs to a Pound in a state with NO established Pack, the life membership transmittal, along with the appropriate payment will be forwarded to the Honorable Dog Robber

ii. Checks referred to in section 1209-E-2.a shall be made payable to the MODD Kennel. No further actions will need to be taken if there is NO established Pack in the state where the Pound exists.

iii. Pounds in a state WITH an established Pack shall continue to instructions listed below.

b. If the member belongs to a Pound in a state WITH an established Pack, the life membership transmittal, along with the appropriate payment will be forwarded to the Pack Dog Robber.

i. The Pound Dog Robber shall remit two checks; one check of the required amount made payable to the MODD (state) Pack, and one check of the required amount (*based on the applicant's age*), made payable to the MODD Kennel. The Pack Dog Robber shall retain the Pack's portion, then forward the other check, along with the Life

Membership transmittal to the Honorable Dog Robber. Refer to the MODD Dog Robber's Manual for the current Life Membership amounts for the Pack and the Kennel.  
c. In the event of Kennel Strays purchasing life memberships, the Stray shall remit payment directly to the Honorable Dog Robber.

i. If the Stray is up to and including 60 years of age, the amount shall be \$150.00. If the Stray is 61 years and older, the amount shall be \$125.00. Checks shall be made payable to the MODD Kennel.

ii. The Honorable Dog Robber will process the PLM transmittal for the Stray.

3. The transmittal of PLMs shall be the responsibility of the Pound, via the Pack, to the Honorable Dog Robber. Pounds in states having no established Pack shall transmit directly to the Kennel.

4. Permanent metal PLM plates and cardboard type membership cards will be issued to the Pedigreed Devil Dog only at the time of their original transmittal.

5. Pedigreed Devil Dogs holding PLM status in the MODD are exempt from future Kennel, Pack, and Pound membership dues in that Pound.

**Proposed Wording:**

E. PLMs shall be made available based on age. Members up to including 60 years of age, the dues are \$150; Members aged 61 and older, the dues are \$125.00. All applicants shall meet the following criteria. NOTE: Because the PLM is classified as dues (Section 104), the current flat rate of \$100.00 will remain in effect until the close of the Supreme Growl of the Kennel in 2005 and the increase shall become effective at that time.

3. The transmittal of PLMs shall be the responsibility of the Pound, via the Pack, to the Honorable Dog Robber. Pounds in states having no established Pack shall transmit directly to the Kennel.

4. *A MODD Life Member Number*, Permanent metal PLM plates and cardboard type membership cards will be issued to the Pedigreed Devil Dog only at the time of their original transmittal. *A single Life Member number shall be issued, regardless of the number of Pounds a member may be a Life Member of.*

5. *Life Membership applies only to the Pound to which it is paid. Should a member wish to be a Life Member in more than one Pound, PLM fees must be paid for each Pound.* Pedigreed Devil Dogs holding PLM status in the MODD are exempt from future Kennel, Pack, and Pound membership dues in that Pound.

**Rationale:**

This edit shortens the section in the Bylaws regarding the payment of the PLM fees, clarifies the payment of the PLM fees to each Pound, makes the main paragraph less verbose, and removes a wording redundancy. The breakdown of how the PLM fees should be submitted is better placed in the Dog Robber Manual / Admin Procedure as the "how" it should be done.

#### CONSTITUTION ARTICLE I – MEMBERSHIP

**Existing Wording:**

SECTION 101: Eligibility

B. Any such other candidate who is in failing health, and to whom the trip to the Grand Growl of the Pack or the Supreme Growl of the Kennel would cause undue hardship and/or physical endangerment, shall, by written request of the Pound with the approval endorsement of the Pack, and with the written permission of the Honorable Chief Devil Dog, be permitted elevation to the next higher degree at a Growl of the Pound, or at a Special Growl of the Pack permit. Pounds that are not part of a functioning Pack may petition the Honorable Chief Devil Dog directly. The written request from the Pound on behalf of a Pup or Devil Dog in failing health shall be accompanied by a statement from competent medical authority specifically addressing the condition of the individual for whom the exemption is being sought. The Pound Keeper's written request shall be countersigned by the Worthy Pack Leader in states where there is a functioning Pack; or, sent directly to the Honorable Chief Devil Dog where there is not a functioning Pack in the state, with a copy of the request sent directly to the Honorable Vice Chief Devil Dog of the respective Division. All requests for medical, World War II, and Korean War service exemptions shall be sent directly to the Honorable Dog Robber for factual verification. Once the Honorable Dog Robber validates, both, the faithful service of the Devil Dog for whom the medical exemption is sought and has determined that the medical evidence provided is compelling and complete; the Honorable Dog Robber shall obtain from the Honorable Chief Devil Dog such approval (either in hard copy or digitally) of the request of either the Pound or the Pack as determined to be sufficient for record-keeping purposes and, by direction, notify the Pound or the Pack as soon as possible that the request for World War II, Korean War Veteran wartime service and/or medical exemption has been granted. Once the written approval has been received from the Honorable Chief Devil Dog, the Pound Keeper, or Pack Leader, as appropriate, shall appoint an Installation Officer and Installation Team appropriate for the degree to be conferred, with the express understanding that said Growl will be held within ninety (90) days of the receipt of the written permission of the Honorable Chief Devil Dog. The Honorable Chief Devil Dog and, in the case of a Growl of the Pound, the Worthy Pack Leader should ensure that there is a representative from their respective Staff, whenever possible.

**Proposed Wording:**

B. Any other member who is in **long-term** failing health, and to whom the trip to the Grand Growl of the Pack or the Supreme Growl of the Kennel would cause undue hardship and/or physical endangerment, may request a special advancement at a Growl of the Pound or Special Growl of the Pack. Requests for special advancement must be submitted via the member's Pound, endorsed by the Pack, and approved by the Honorable Chief Devil Dog. Pounds not part of a Pack may petition the Honorable Chief Devil Dog directly **via the process described below**.

**C. WARTIME SERVICE EXEMPTION:** A request for advancement of an eligible member who is a World War I, World War II, or Korean War Veteran as referenced in Section 108 (4) (a) should be submitted to the Honorable Dog Robber with an endorsement letter from the Pound Keeper and a copy of the member’s DD-214.

**D. MEDICAL EXEMPTION:** A request for special advancement due to medical exemption must be submitted to the Honorable Dog Robber and must include the following:

- i. Request letter from the Pound Keeper, endorsed by the Pack Leader (if the Pound is part of a Pack), stating the involvement of the member in the Pound.
- ii. Letter from the member’s doctor stating that due to the member’s long-term medical condition, travel in any manner is not possible (note: the specific medical condition does NOT have to be shared, only that the member will not be able to travel for the foreseeable future)

**E. CAREGIVER EXEMPTION:** A request for special advancement due to full-time caregiver duties for an immediate family member must be submitted to the Honorable Dog Robber and must include the following:

- i. Request letter from the Pound Keeper, endorsed by the Pack Leader if the Pound is part of a Pack), stating the involvement of the member in the Pound.
- ii. Letter from the member’s doctor stating that travel in any manner is not possible for an immediate family member requiring continuous care due to chronic illness, cognitive impairment, or end-of-life conditions where no other long-term caregiver is available. (note: the specific medical condition does NOT have to be shared, only that the member will not be able to travel for the foreseeable future due to the family member’s health condition)

**F.** Once the Honorable Dog Robber receives and validates the information Exemption; he/she shall obtain from the Honorable Chief Devil Dog approval for the Advancement. Once the written approval has been received from the Honorable Chief Devil Dog, the Pound Keeper, or Pack Leader, as appropriate, shall appoint an Installation Officer and Installation Team appropriate for the degree to be conferred, with the express understanding that said Growl will be held within ninety (90) days of the receipt of the written permission of the Honorable Chief Devil Dog. The respective Division Vice Chief Devil Dog and, in the case of a Growl of the Pound, the Worthy Pack Leader should ensure that there is a representative from their respective Staff, whenever possible.

***Rationale:***


The current wording the Bylaws is a long run-on sentence that is unclear and hard to read.

This amendment consolidates all advancement exemptions into a single, clear, and standardized policy. It ensures fairness while preventing system abuse, maintaining the integrity of the advancement process, and preserving the final authority of the Honorable Chief Devil Dog.

### CONSTITUTION ARTICLE I – MEMBERSHIP

***Addition to Bylaws:***

**SECTION 112: Resignation**

- A. If a member voluntarily resigns his/her membership in the MODD, he/she must resign in writing via Pound Dog Robber. The Pound Dog Robber shall submit the written resignation notification to the Kennel Dog Robber.
  - 1. Should a resigned member wish to return, the most recent edition of the Dog Robber Manual will outline the procedure.
- B. Involuntary resignation of membership shall fall under ARTICLE X – DISCIPLINE.

***Rationale:***

We currently do not have specific guidance on what to do for a member who wishes to voluntarily resign. This addition gives a directive on those who may wish to voluntarily resign their membership in the MODD.

Proposed Bylaw

ARTICLE I – MEMBERSHIP

Currently Reads:

Section 101: Eligibility

B. The degrees of membership in the MODD and the time and place the degrees will be conferred are herewith and hereby established as follows:

4. EXCEPTIONS:

a. Any qualified candidate who has otherwise complied with paragraphs D and E of this Section and who is also a World War I Veteran, World War II Veteran, Korean War Veteran (service between 27 June 1950 to 27 July 1954 - dates eligible for the Korean Service Medal: ref DOD), and any service prior to 27 June 1950 would also qualify for advancement to the rank of Pedigreed Devil Dog. The aforementioned candidates would not be required to attend the Supreme Growl of the Kennel to be elevated.

Add the following sub paragraph:

1) For any Devil Dog with (1) year time in Degree that does not meet the above Conflict criteria and is Eighty-Two (82) human years old would also qualify for advancement to the rank of Pedigreed Devil Dog. The aforementioned candidates would not be required to attend the Supreme Growl of the Kennel to be elevated.

Rational: In the near future we are going to have 20-year span of Cold War Veterans that will be advancing in age and will not be eligible to advance to Pedigree under the conflict exceptions.
