Do yourself a favor now and go to the Kennel website and look at the helpful information under the "2024 Supreme Growl" tab and related links. One of the most important items is the list of "Applications Processed By the Kennel Dog Robber" near the bottom of the page. If your name is not on that list by July 5th or 6th it likely means that no application was received for you by the deadline and while you should check with your Pound Dog Robber to see what happened to your Advancement Form, don't expect to be allowed to

advance. An exception would be very rare, as we have been passing the word for years to get your forms in early and check to see that your application has been received and processed. Now look back at the top and select the "Library" tab and then "Publications", scroll down and you will find the recently updated "Obedience School". While all the sections have good information, the first three along the top may prove to be most beneficial to you for advancement. Some may already be familiar with the info, and that may be a help to you.



This year at the convention there will be no MODD and Flea Luncheon and Awards on Thursday in anticipation of many Dogs and Fleas taking the trip to

Marine Corps Air Ground Combat Center. We have therefore combined the awards with a Wednesday evening dinner and awards open to all with tickets and followed by the MODD's traditional auction. Dinner tickets must be purchased in advance, online at the convention website, https://www.mcldeptca.org/event-exursion for \$15.38. You must have tickets to join us during dinner and the award presentations. However, following the awards all are invited to join us for the rest of the evening where you may congratulate the new Pedigreed Devil Dogs, and of course the 61st Chief Devil Dog and the rest of the Kennel Staff. I expect that we will once again have many excellent auction items for everyone to bid on too.

Writing this last article as Chief Devil Dog, I pause to reflect on all of the great programs and projects I have encountered that the Dogs around the country are involved in. From helping our own members in need of assistance, fundraising for local community efforts, the Kennel Children's Hospital Fund, Operation Chow Hound, running fun and productive Growls, and on and on. 

Using them online you can rapidly search for key words and phrases like, "eligibility to hold office".

Finally, thank you to all of the Kennel Staff, you are talented beyond measure, simply the best! I appreciate the advice and support I have received from many corners particularly the 59th CDD PCDD Hazlett and the rest of the PCDD's. The camaraderie and esprit de Corps I have experienced at Pound and Pack Growls and their corresponding departments and divisions around the country has been outstanding and always made me feel welcome, I appreciate that as well as all of your efforts locally and within the Kennel. 



Download each PDF and use the information to train your Mongrels or refresh the memories of your entire Pound. Class numbers 10 & 11 will be posted soon.

March 15th was the deadline for all Proposed Bylaws Changes to the Kennel Bylaws. This year we received a total of 5 proposed changes. These are posted in their entirety, on the Kennel Website and in this issue of the Woof-O-Gram. Please take the time to read these and share them with your Pounds and Packs. Only the Dogs in attendance at the Supreme Growl will be able to vote on these proposed changes.

2024 Proposed Bylaws Changes for the 84th Supreme Growl

- #1. FMF Navy Personnel. This change simplifies the language for MOD
- D Membership requirements to cover all current and future changes to the requirements for MCL Regular Membership.
- #2. Pound Keeper / Dog Robber. This change clarifies that the Pound Keeper and Pound Dog Robber cannot be the same Dog.
- #3. MODD Life Membership Checks. This change calls for two checks to be written from the Pound and simplifies the language to cover any future changes to the cost of MODD Life Membership or distribution of Big Bones.
- #4. Executive Director Appointment. This change clarifies the process to appoint the Kennel Executive Director. #5. Advancement Exemptions. This change would add to the list of exemptions for Degree Advancement. If you plan to Advance to PDD at the Supreme Grow, you need to get your Application for Advancement, filled out, signed by the PACK dog Robber and sent to the Kennel Dog Robber ASAP! The Kennel Dog Robber must receive these by July 1st. Only 47 Applications are currently listed on the Kennel Website. Looking forward to the Marine Corps League National Convention and 84th Supreme Growl in Rancho Mirage (Palm Springs), California. 11-16 AUG 2024. I have announced my intention to run for the office of Honorable Jr. Vice Chief Devil Dog and would appreciate your support.

MEMBERSHIP

Current Verbiage:

A. All Officers and enlisted personnel on honorable active duty with the U. S. Marine Corps (USMC) and all Officers and enlisted personnel honorably separated from the USMC who are bona fide, paid-up, active members of the MCL, and all qualified Navy personnel shall be eligible for consideration for and election to membership in the MODD.

- B. The MODD supports the MCL decision of 2001 to authorize qualified Fleet Marine Force (FMF) corpsmen to be regular members of the MCL. Thus, qualified FMF corpsmen members shall enjoy the same rights and benefits as other regular members of the MCL.
- C. The MODD supports the MCL's decision of 2013 to authorize qualified FMF chaplains to be regular members of the MCL. Thus, qualified FMF chaplain members shall enjoy the same rights and benefits as other regular members of the MCL.

Proposed Verbiage:

A. Only Regular Members of the MCL in good standing are eligible for membership in the MODD. Associate and Honorary MCL members are not eligible.

B. Potential candidates must have at least 12 months of membership in the MCL and be in good standing to be eligible for consideration for and election to membership in the MODD. Additional membership requirements are listed in Article I of the Kennel bylaws.

Rationale:

Combining subsections A, B, and C simplifies Article IV of the MODD Constitution, and brings the MODD in line with current (and future) MCL regular membership requirements.

Current Verbiage:

A. ELECTED - The elected Officers of the Pound shall be the Pound Keeper, Senior Vice Pound Keeper, Junior Vice Pound Keeper, Pound Smart Dog, Pound Dog Trainer, Pound Police Dog, and Pound Mad Dog.

B. APPOINTED - The appointed Officers of the Pound shall be the Pound Dog Robber, Pound Watch Dog, Pound Barking Dog, and such other subordinate Officers as the Pound Keeper, in his/her discretion, may choose to appoint. It is preferable that the Pound Keeper make all appointments following the election so as to permit the Installation of the appointed Officers with the elected Officers. The appointed Officers shall serve only at the convenience and pleasure of the Pound Keeper.

Proposed Verbiage:

A. ELECTED - The elected Officers of the Pound shall be the Pound Keeper (who shall not concurrently hold the office of Pound Dog Robber), Senior Vice Pound Keeper, Junior Vice Pound Keeper, Pound Smart Dog, Pound Dog Trainer, Pound Police Dog, and Pound Mad Dog.

B. APPOINTED - The appointed Officers of the Pound shall be the Pound Dog Robber (who shall not concurrently hold the office of Pound Keeper), Pound Watch Dog, Pound Barking Dog, and such other subordinate Officers as the Pound Keeper, in his/her discretion, may choose to appoint. It is preferable that the Pound Keeper make all appointments following the election so as to permit the Installation of the appointed Officers with the elected Officers. The appointed Officers shall serve only at the convenience and pleasure of the Pound Keeper.

Rationale:

This change will align Section 209 with Section 309: Pack Officers – Elected / Appointed Staff, which reads similarly. It will also codify in the Bylaws that the Pound Keeper cannot also be the Pound Dog Robber, eliminating a possible conflict of interest, and creating a separation of duties in these critical positions.

Subj: PROPOSED KENNEL BYLAWS CHANGE FOR 2024 - SECTION 1209: LIFE MEMBERSHIPS,

PARAGRAPH E.2.B.

Current Verbiage:

If the member belongs to a Pound in a state WITH an established Pack, the life membership transmittal, along with the appropriate payment will be forwarded to the Pack Dog Robber. The Pound Dog Robber shall remit a check in the amount listed in (2)(a), made payable to the MODD (state) Pack, and forward the payment along with the life membership transmittal to the Pack Dog Robber.

The Pack Dog Robber shall remit a check made payable to the MODD Kennel, deducting \$30.00 (e.g., Members of the MODD up to and including 60 years of age, the Pack Dog Robber shall remit a check in the amount of \$90.00. For Members of the MODD 61 years and older the check amount shall be \$65.00)

The Pack Dog Robber shall then forward the check, along with Life Membership transmittal to the Honorable Dog Robber.

Proposed Verbiage:

If the member belongs to a Pound in a state WITH an established Pack, the life membership transmittal, along with the appropriate payment will be forwarded to the Pack Dog Robber. The Pound Dog Robber shall remit two checks; one check of the required amount made payable to the MODD (state) Pack, and one check of the required amount (based on the applicant's age), made payable to the MODD Kennel. The Pack Dog Robber shall retain the Pack's portion, then forward the other check, along with the Life Membership transmittal to the Honorable Dog Robber. Refer to the MODD Dog Robber's Manual for the current Life Membership amounts for the Pack and the Kennel.

Rationale:

This will streamline the process for the Pack Dog Robber, and simplifies the accounting. Instead of depositing the single check from the Pound for the full amount, then having to write another check to send to the MODD Kennel for its portion, the Pack Dog Robber can simply deposit the first check for the Pack's portion, and forward the second check to the MODD Kennel, along with the transmittal.

In accordance with MODD Constitution and Bylaws (Revised 2023), Article IV, Section 403 and Article XIII, Section 1301 the following is submitted for consideration.

Proposed bylaw change to Section 409: Kennel Officers-Elected/Appointed Staff

CURRENT:

Section 409 B. APPOINTED – After the election, the Kennel Board of Trustees will appoint, with the approval of the Chief, an Honorable Executive Director.

PROPOSED:

Section 409 B. APPOINTED – After the election, the Honorable Chief Devil Dog will appoint, with the approval of the Board of Trustees, an Honorable Executive Director.

RATIONALE:

As written, the process is backwards from standard practice. For instance, the President nominates a person for a position and the US Senate confirms the person. Additionally, the PDD who wrote the current bylaw has stated that it is worded incorrectly from his intent. The proposed change fixes it.

Subj: Proposed Change to Kennel By-Laws

Ref: Kennel By-Laws Article I Section 101

I would like to recommend the following proposed Kennel By-Law change for consideration and adoption.

Article I Section 101, Paragraph B, Sub Paragraph 4. Exceptions

Currently Reads:

4. EXCEPTIONS:

a. Any qualified candidate who has otherwise complied with paragraphs D and E of this Section and who is also a World War I Veteran, World War II Veteran, Korean War Veteran (service between 27 June 1950 to 27 July 1954 - dates eligible for the Korean Service Medal: ref DOD), and any service prior to 27 June 1950 would also qualify for advancement to the rank of Pedigreed Devil Dog. The aforementioned candidates would not be required to attend the Supreme Growl of the Kennel to be elevated.

b. Any such other candidate who is in failing health, and to whom the trip to the Grand Growl of the Pack or the Supreme Growl of the Kennel would cause undue hardship and/or physical endangerment, shall, by written request of the Pound with the approval endorsement of the Pack, and with the written permission of the Honorable Chief Devil Dog, be permitted elevation to the next higher degree at a Growl of the Pound, or at a Special Growl of the Pack permit. Pounds that are not part of a functioning Pack may petition the Honorable Chief Devil Dog directly. The written request from the Pound on behalf of a Pup or Devil Dog in failing health shall be accompanied by a statement from competent medical authority specifically addressing the condition of the individual for whom the exemption is being sought. The Pound Keeper's written request shall be countersigned by the Worthy Pack Leader in states where there is a functioning Pack; or, sent directly to the Honorable Chief Devil Dog where there is not a functioning Pack in the state, with a copy of the request sent directly to the Honorable Vice Chief Devil Dog of the respective Division. All requests for medical, World War II, and Korean War service exemptions shall be sent directly to the Honorable Dog Robber for factual verification. Once the Honorable Dog Robber validates, both, the faithful service of the Devil Dog for whom the medical exemption is sought and has determined that the medical evidence provided is compelling and complete; the Honorable Dog Robber shall obtain from the Honorable Chief Devil Dog such approval (either in hard copy or digitally) of the request of either the Pound or the Pack as determined to be sufficient for record-keeping purposes and, by direction, notify the Pound or the Pack as soon as possible that the request for World War II, Korean War Veteran wartime service and/or medical

exemption has been granted. Once the written approval has been received from the Honorable Chief Devil Dog, the Pound Keeper, or Pack Leader, as appropriate, shall appoint an Installation Officer and Installation Team appropriate for the degree to be conferred, with the express understanding that said Growl will be held within ninety (90) days of the receipt of the written permission of the Honorable Chief Devil Dog. The Honorable Chief Devil Dog and, in the case of a Growl of the Pound, the Worthy Pack Leader should ensure that there is a representative from their respective Staff, whenever possible.

Change to Read:

4. EXCEPTIONS:

a. Any qualified candidate who has otherwise complied with paragraphs D and E of this Section and who is also a World War I Veteran, World War II Veteran, Korean War Veteran (service between 27 June 1950 to 27 July 1954 - dates eligible for the Korean Service Medal: ref DOD), and any service prior to 27 June 1950 would also qualify for advancement to the rank of Pedigreed Devil Dog. The aforementioned candidates would not be required to attend the Supreme Growl of the Kennel to be elevated.

b. Any such other candidate who is in failing health, and to whom the trip to the Grand Growl of the Pack or the Supreme Growl of the Kennel would cause undue hardship and/or physical endangerment, shall, by written request of the Pound with the approval endorsement of the Pack, and with the written permission of the Honorable Chief Devil Dog, be permitted elevation to the next higher degree at a Growl of the Pound, or at a Special Growl of the Pack permit. Pounds that are not part of a functioning Pack may petition the Honorable Chief Devil Dog directly. The written request from the Pound on behalf of a Pup or Devil Dog in failing health shall be accompanied by a statement from competent medical authority specifically addressing the condition of the individual for whom the exemption is being sought. The Pound Keeper's written request shall be countersigned by the Worthy Pack Leader in states where there is a functioning Pack; or, sent directly to the Honorable Chief Devil Dog where there is not a functioning Pack in the state, with a copy of the request sent directly to the Honorable Vice Chief Devil Dog of the respective Division. All requests for medical, World War II, and Korean War service exemptions shall be sent directly to the Honorable Dog Robber for factual verification. Once the Honorable Dog Robber validates, both, the faithful service of the Devil Dog for whom the medical exemption is sought and has determined that the medical evidence provided is compelling and complete; the Honorable Dog Robber shall obtain from the Honorable Chief Devil Dog such approval (either in hard copy or digitally) of the request of either the Pound or the Pack as determined to be sufficient for record-keeping purposes and, by direction, notify the Pound or the Pack as soon as possible that the request for World War II, Korean War Veteran wartime service and/or medical exemption has been granted. Once the written approval has been received from the Honorable Chief Devil Dog, the Pound Keeper, or Pack Leader, as appropriate, shall appoint an Installation Officer and Installation Team appropriate for the degree to be conferred, with the express understanding that said Growl will be held within ninety (90) days of the receipt of the written permission of the Honorable Chief Devil Dog. The Honorable Chief Devil Dog and, in the case of a

Growl of the Pound, the Worthy Pack Leader should ensure that there is a representative from their respective Staff, whenever possible.

c. Any such other candidate who does not fall under exemptions (a), (b), and has otherwise complied with paragraphs D and E of this Section and who has provided sufficient evidence that their travel to the Grand Growl of the Pack or the Supreme Growl of the Kennel is hindered by significant circumstances including but not limited to being the caregiver to immediate family member/s who may need ongoing 24 hour 7 days a week care shall, by written request of the Pound with the approval endorsement of the Pack, and with the written permission of the Honorable Chief Devil Dog, be permitted elevation to the next higher degree at a Growl of the Pound, or at a Special Growl of the Pack. Pounds that are not part of a functioning Pack may petition the Honorable Chief Devil Dog directly. The written request from the Pound on behalf of a Pup or Devil Dog hindered by significant circumstances shall be accompanied by a statement from a competent medical authority specifically addressing the condition of the immediate family member/s whose care is deemed ongoing 24 hour 7 days a week. The Pound Keeper's written request shall be countersigned by the Worthy Pack Leader in states where there is a functional Pack; or, sent directly to the Honorable Chief Devil Dog where there is not a functioning Pack in the state, with a copy of the request sent directly to the Honorable Vice Chief Devil Dog of the respective Division. All requests covered by exemptions listed in (a), (b), or (c) shall be sent directly to the Honorable Dog Robber for factual verification. Once the Honorable Dog Robber validates, both, the faithful service of the Devil Dog or Pedigree Devil Dog for whom the significant circumstances exemption is sought and has determined that the medical evidence provided is compelling and complete; the Honorable Dog Robber shall obtain from the Honorable Chief Devil Dog such approval (either in hard copy or digitally) of the request of either the Pound or the Pack as determined to be sufficient for record-keeping purposes and, by direction, notify the Pound or the Pack as soon as possible that the request for either (a), (b), or (c) exemption has been granted. Once the written approval has been received from the Honorable Chief Devil Dog, the Pound Keeper, or Pack Leader, as appropriate, shall appoint an Installation Officer and Installation Team appropriate for the degree to be conferred, with the express understanding the said Growl will be held within ninety (90) days of the receipt of the written permission of the Honorable Chief Devil Dog. The Honorable Chief Devil Dog and, in the case of a Growl of the Pound, the Worthy Pack Leader should ensure that there is a representative from their respective Staff, whenever possible. The conditions that qualify for a significant circumstance exemption are as follows:

aa. Chronic Health Conditions including Diabetes, Heart Disease, Respiratory problems, or anything deemed a Chronic Health Condition by a competent medical authority.

bb. Cognitive Impairments including Alzheimer's Disease, Dementia, Brain Tumors, Stroke, or anything deemed a Cognitive Impairment by a competent medical authority.

cc. Complex Medical Needs including Ventilators, Individuals with Severe Disabilities, Individuals considered Special Needs, Patients recovering from major surgeries, or anything deemed a Complex Medical Need by a competent medical authority.

dd. End of Life care including patients in Hospice or Palliative care, or anything deemed End of Life care by a competent medical authority.

ee. Other Significant Medical or Physical conditions including Moderate cerebral palsy, Paraplegia, Spina bifida, Hydrocephalus, Partially controlled seizures, Hearing or vision impairment, which affects the ability to communicate or function, or anything deemed a significant medical or physical condition by a competent medical authority.

Rational:

The first two exemptions cover the dogs with their service in WWI, WWII, Korea, or their own medical issues. They do not cover the other significant circumstances that some dogs deal with daily. Caring for their immediate family members including spouses, children, grandchildren, parents, sisters, brothers, or others who may have a medical condition whether mental or physical that fully encompasses their lives. They may get lucky and be able to attend a Pound Growl, but attending a Grand Growl or Supreme Growl is out of the question. Every dog across all Pounds, Packs as well as Kennel staff either knows someone in this predicament or they themselves are in it. This change would hopefully cover those dogs to get them their respective collars, which may be years in the waiting. The MODD is the Fun & Honor society, I do not think there is any better way to Honor those dogs who would fall under this exemption than to adopt this amendment and get them Advanced.


All Dog Food and other items collected at the Growl will be donated to a local shelter in Rancho Mirage CA along with any monetary donations that we receive.

For those of you who are planning to advance this year in Rancho Mirage CA please look at the requirements and this helpful information.

- 1- All Advancement forms should have been sent to the Kennel Dog Robber and received by July 1st.
- 2- All advancing Dogs need to first register with the MCL then proceed to the Kennel Doghouse to Register. All Dogs Must be at the Doghouse no later than 1700 on August 12th, 2024. It is recommended to arrive on Sunday if possible or as early as you can on Monday.
- 3- Each Dog Needs to Bring \$50.00 \$75.00 big bones with them to the Doghouse for registration. There is a \$30.00 big bone fee for your dog collar which \$25.00 of that is refundable at the end of your initiation if you don't want to keep your collar. You'll have your passport fee and registration fee, there will be a Growl specific coin and patch that you can purchase, your Dog Bones and possible fines that may be given.
- 4- You need to have a list of your Medicines and any specific medical issues that you might have so they can be given to the Kennel Vet and your Platoon Handler. Please put this on a 3X5 index card if possible. If you need to use more than one card that's fine.
- 5- DD's need to make sure they do not book any trips from August
 12th 14th. If you miss too much of the training, we won't be able to

Many of our PDD's witnessed firsthand how important the MODD was to her, whether having her as your Dog Handler as you were preparing for PDD or just


seeing her raise funds as our Charity Dog. She was a true stalwart of an individual, often working herself until she reached exhaustion. When I last spoke with her on the morning of her

If for some reason you do not get your card, please reach out to me so I can confirm that I had received you information and have indeed made your card. With that, after this years Supreme Growl, I will be picking up a new Deputy.

With this new Deputy, and many of his talents, we have been working on a new front end database that will replace our current cloud based database that the

Division Vices and Pack Dog Robbers have been pulling rosters from. Our access to that system will end on July 18th. There will not be anything else in its place until we release it at the Supreme Growl. This new system will also grant a whole host of new functionality for those that use it. With that being said, once we open it up, it will be available to Division Vices, Pack Leaders, and Pack Dog Robbers once again. We will work on adding more as we go. Please if you are not currently in one of those positions, do not send a request. We will be having a class on this system On Monday of the Convention week. It will be from 1600 to 1700 in the main room. If you are a Vice Chief, A Pack Leader, Pack Dog Robber, or someone who is interested in seeing how we are implementing this, please come join the class. We will also be giving a class at the Gathering of the Dogs that will be held October 10th thru October 13th hosted by the South Carolina Pack. Please look for that information in the events page on our website.

As some others may have also noticed we implemented a new fundraising platform, one that we are now using for our Raffles and a new way of gathering donations and having a competition. This new platform allows us to receive monies for raffles and donations and is much more cost effective that our previous platforms.

The Donation To Make A Difference Campaign and Competition. OK so who doesn't like raising bones for a good cause? And who doesn't like to have fun while doing it? With the new platform we pushed out this campaign and competition to see what we could do with it. We only had it up and running for about a month and a half, and I have to say, it was worth it.

And just think, I pack can use it at their level and have a Pound Competition, the Division could have a Pack competition. All using the same platform and campaign, all going into the same fund. I would love for our Dogs to blow the lid off of this and bust beyond that limit. We will have more information on that as we sort it out more and finalize everything.



The Supreme Growl is fast approaching. It's time to start sending advancements for PDD in – remember they need to be in my paws NLT 1 July. **Hint- Hint**, they can be emailed to me after your Pack Dog Robber signs them. Per the updated bylaws the candidates for PDD must be in attendance by 1700 on Monday the 12th of August. If possible, arrive on Sunday for the full benefit of advancing. You will have

to pick up your credentials from the MCL Registration desk prior to reporting to the Doghouse.

At the Supreme Growl, awards will be given out. To date I have received only one submission. Really, are there no other Dogs deserving recognition for a job well done? I can't believe that! Time is running out for nominations for the Kennel Pack Dog Robber of the Year and Kennel



Pound Dog Robber of the year. The nominations must be in either the Executive Director's Paw or mine prior to early June. Kennel Dog of the Year, per the bylaws, can still be hand carried and given to me NLT the Monday prior to the Supreme Growl.

Passport stamping fees and donations to our Childrens Hospital Fund continue to arrive. Remember the bylaws require each pound to have a minimum of four growls each fiscal year and those bones collected for the stamping and donations to the Childrens Hospital are to be sent into me within a few days after the growl – so don't wait until the end of the fiscal year. All checks received by 30 June 2024 and prior will go to this year's donation to the Children's Hospital Fund.

We have all new forms out on the website to be used! There is also an updated Dog Robber Manual. Start using them or expect the old forms to be returned to you unprocessed! **DO NOT USE THE OLD 5- PART CARBON FORMS!**

I continue receiving ROIs done on **OUTDATED** forms and with everyone living in the same **PO Box or all** with the same email address!!! We need the physical address that your officers live at plus phone number and email address. Also many pounds are still holding their elections prior to the Supreme Growl. Bylaws require the Pound election and installation to be done within **90 days after** the Supreme Growl. Only the Pack can hold elections prior to the Supreme Growl since their Grand Growls generally are held right around the end of the Fiscal Year (30 June). We are also finding many officers are not current, therefore making the ROI not valid. Remember, the election is held for the new fiscal year (2025), therefore the officers elect/appointed should have their 2025 dues paid or be life members. We are also finding brand new PUPs being elected/appointed into office – PUPs must have one year in the MODD – the only exception is if this is a brand newly chartered pound.

The Kennel Compliance Dog is still finding many pounds and packs that are not incorporated and/or using incorrect EINs. We need to get this corrected ASAP – if you need help, just ask. We have many dogs that can assist you.

The Mini Growl held on 22 February in Arlington, VA is on the website under private library. Also, last year's Supreme Growl Scratchings are located there. Read them prior to coming to California – they will be voted on for approval or corrections so check them out.

When you send in your transmittals, applications for membership, advancements and NOD, you need to only send one copy of each. I don't need three copies of everything! If you are not getting your endorsed copies back, the reason is either your email isn't correct, you've blocked my email, or you do not have one. In which case, you need to provide me with a valid email address.

Have a safe and enjoyable summer and I hope to see many of you in Palm Springs in August.

By the time you read this article, the summer heat is upon us, we will be only four to six weeks from real heat in Palm Springs, CA and the National Convention and Supreme Growl.



Kennel Compliance Dog: PDD Steve Seyller



We are getting very close to this year's Supreme Growl at the Westin in Rancho Mirage, California. The Kennel as a whole is doing much better as far as 990's, State Registrations, and getting their ROI's turned in. However we still have way too many that are not in compliance with the Kennel Bylaws on submissions. As of the beginning of June there are 31 packs/pounds delinquent on 990 submissions, 18 currently in revocation, and 13 that I don't have or can't find and information on. I will be sending a division report to the Division Vice Chiefs before the convention. Please respond to their requests so we can get the Kennel squared away. I will also be at the convention so if you have any questions see me.

Reminders as we get into the new fiscal year:

- 1. Pack ROI's are due immediately after their Grand Growl in which nominations and elections should take place.
- 2. Pound ROI's are due within 90 days AFTER the Supreme Growl. NOT BEFORE
- 3. 990's for fiscal year filers (all should be filing fiscal according to the Kennel Bylaws) are due starting 1 July and need to be done by the 15th of November.
- 4. Since every state is different on Article of Incorporation filings, make sure you are in compliance with your states requirements.

DO NOT hesitate to reach out if you have any questions. My email is listed below. If I do not have an answer there are many dogs in the order who will.

37th Chief Devil Dog: PCDD Paul Sutton

Woof-woof brother and sister Devil Dogs:

On 8 June 2024, I observed my 50th "official" anniversary of membership in the Military Order of Devil Dogs. I say "official" because I was really initiated as a Pup in June 1973. On 11 June, I celebrated 54 years as a member of the Marine Corps League. More on my Pup adventure further on in this narrative.

But first, I need to make a statement and take a stand as both a Pedigreed Devil Dog (once a PDD, always a PDD) and as a Past Chief. Recognizing that there was a "dust-up" at the February 2024 "Mini" Supreme Growl over a long-overdue and needed change to the MODD Ritual, I applaud the Kennel Board of Trustees for "sticking to its guns" and allowing the changes to the MODD Ritual approved at the Kennel Board of Trustees in Oklahoma City in August 2023 to remain in place without change.

A "few" take exception to "not reciting the Pledge of Allegiance as we always have." Unfortunately, we have been doing it wrong since 1976, when the US Flag Code was revised by Congress. It seems to me that most of our membership is "OK" with the change. The "few" misrepresent a select, exceedingly small group of Dogs. Others say, "we're not the American Legion". That is true, we're the Military Order of Devil Dogs, 5,500+ strong. Those other VSOs have their own way of doing things. As a life member of the American Legion, I can tell you that this same revision engendered great debate within the rank-and-file of the American Legion. As far back as recruit training in 1962, I remember being instructed that the only thing that can be spoken or uttered while rendering the hand salute is a command (like, "eyes right" or "ready to"). So, in other words, keep your "pie hole" shut while rendering a hand salute. I also hear that this revision may become an issue under either Old or New Business during the Supreme Growl in California. That's unfortunate and I hope that that discussion will be ruled out of order by the incumbent Honorable 60th Chief Devil Dog or by a "Point of Order" during the 2024 Supreme Growl when the subject is raised. This hullabaloo is – to me – like chasing a ghost in a hall of mirrors. Paraphrasing Socrates: "...the secret of change is to focus all of our energy, not on fighting for the old; but, on building the new..."

OK, back to some ancient history.

Since New Jersey had only one functioning Pound (which no longer exists) from the mid-'60s to 1976, that Pound assumed responsibilities for Devil Dog functions in the state, with the blessing of the Department – apparently Kennel wasn't paying attention – and conducted Growls and Initiations at the Department convention only in those years. So, despite becoming a Pup in June 1973, the paperwork for all the 1973 Pup initiates was not processed until late June 1974, which is how I entered up with a 1974 Dog Tag number. The New Jersey Pack was re-charted in 1978 after having lost its charter in the early 1960s for "non-compliance". Incidentally, my Dog Tag number is 74-115; anyone else living out there in Dogdom with a more senior Dog Tag number? If so, I'd like to hear from you. You can reach me at **ssgtusmc6169@gmail.com**.

My other distinct memory of the 1973 NJ Dept. convention was participating in the "Initiation" of new Pups and the elevation of Pups to Devil Dog. This was overseen by probably 6 or 7 Pedigree Devil Dogs and Devil Dogs who immediately reminded me of those "salty PFCs" we all remember from our first days in the Corps. The initiates were insulted, egged, smeared with lipstick, and generally turned into the worse mess you'll ever see, short of a tar and feathering.

Oh, there was also a "**coup de grace**" I never forgot. One of the PDDs was a perfumer by occupation. He had concocted some God-awful-smelling mess out of what I can only surmise was work mistakes and which were liberally applied to the initiates. And, all this was carried out in the hotel parking lot – in full view of the New Jersey Turnpike – and to the amusement of anyone staying in the hotel, whether associated with the Department Convention or not.

At that evening's convention banquet, you knew immediately who had been initiated that afternoon! There was talk around the hotel that two wives (or maybe a wife and a girlfriend) evicted their respective newly initiated Pup/Devil Dog from the hotel room and roomed with each other, forcing the two god-awful smelly initiates to share the room vacated by one of the offended women. I heard some days later that nearly all those initiates did not relieve themselves of that odor for 5 – 7 days. Can you imagine what their family members who stayed behind at home or co-workers must have thought? One of those new Pups developed an eye infection from the perfume which did not abate for several weeks.

That's how it was in the "Good Ole Days."

Looking briefly into the future, I see only outstanding leadership on the horizon over at least the next six to eight years. Two of those future Chief Devil Dogs are well known to me and to many others across the Order for their already demonstrable talents in proven leadership, recognized camaraderie, and absolute commitment to listening to and learning from all of our members.

Now, more history from a "Really Ole Dog." Prior to 1975, Past Chiefs were just that – Past Chiefs. Other than being introduced and recognized at Supreme Growls, they didn't do much and weren't called on (well, maybe occasionally in a few instances) to really do anything. For most members of the Order who may have not ever encountered one of us really Ole Dogs; here's some information:

Beginning with the 36th Supreme Growl in 1975 in Philadelphia, PA; the incumbent Chief Devil Dog, PDD Virginia McDougall, presented each living past Chief in attendance with their Gold Life Member Plate and the Past Chief's Collar as approved by the Kennel Staff at that same Supreme Growl. However, the Past Chief's Collar was not officially authorized until the 42nd Supreme Growl in 1981 in Tucson.

The miniature Dog Tag, worn with the Past Chief's Collar was officially authorized for wear at the 51st Supreme Growl in Sacramento, CA in 1990. I had been "commissioned" by Her Imperial Majesty, PDD Mae Kraus – the 42nd Chief Devil Dog in late May of 1990 to procure Past Chief Devil Dog miniature Dog Tags for the PCDD Collars, based on the design of the "Chiefs Badge of Office". In early July that year, I picked up thirty of the Past Chief Devil Dog miniature sterling silver Dog Tags from the same vendor that had re-plated the "Chiefs Badge of Office" in Haddonfield, NJ, which were distributed to all living Past Chiefs at or following the 51st Supreme Growl in Sacramento, California. The Past Chief's Cover (Gold cover, black crown, and red piping) was officially authorized at the 68th Supreme Growl in 2007 and approved by the Marine Corps League in 2008. As of this writing (mid- 2024), there are twelve living Past Chief Devil Dogs and two Honorary Chief Devil Dogs.

During the 49th Supreme Growl in Cincinnati, Ohio in 1988, the Order approved formation of the **Past Chief Devil Dogs Society**, which was ultimately incorporated in the MODD By-Laws, Section 421, as a recognized component of the Order. According to our current rules, the only role of the Past Chief Devil Dogs Society is to select and present the Past Chiefs awards. During the 49th Supreme Growl in Cincinnati, Ohio in 1988, the Order approved formation of the Past Chief Devil Dogs Society, which was ultimately incorporated in the MODD By-Laws, Section 421, as a recognized component of the Order. According to our current rules, the only role of the Past Chief Devil Dogs Society is to select and present the Past Chiefs awards.

In the first twelve years of its existence (1989 – 2000), the **Past Chief Devil Dogs Society** presented 65 awards to deserving Pedigreed Devil Dogs, ultimately "capping" the number of annual awards at five deserving Pedigreed Devil Dogs, beginning in 2001.

The Future of the Military Order of Devil Dogs

For the future, upward positive movement is the only way the Order can survive and continue to grow and prosper. It is the unspoken mission and obligation of every Pedigreed Devil Dog to take under their wing the Pups and Devil Dogs in their Pound or Pack. All too often, over the past 50 years, I've observed Pedigreed Devil Dogs (including some ol' Past Chiefs) sit back and watch the Pups and Devil Dogs in their Pound or Pack and even the Kennel sort of "flounder around", finding their way through this "maze" we call the Order.

I challenge every Pedigreed Devil Dog (including some ol' Past Chiefs) to take Pups and Devil Dogs "under their wing" and teach them our ways. Teaching and leading by example is the best way to impress on these Pups and Devil Dogs the "right way" to move up and succeed in our Order. The Order, now in its 85th year, is unique and innovative and its "politics" are as fervent and passionate as anywhere else in the veterans' community.

The "mood" of the Order in 1939 was totally different than that which we face today. Yes, we are still the "Fun and Honor Society of the Marine Corps League." Oftentimes, I often wondered where the "honor" was, having dealt with some of the "Old Salts" who were our founders. Surely, we have always had "fun"; but, the "honor" was sometimes left in the dust; although, I have to admit that the "honor" has retaken its rightful place in our internal and external dealings, as evidenced by both the good deeds the Order has accomplished over the past 30 or so years and its support of the less fortunate of our world. By the middle of the 1990s, the "hostage-taking" (outright thievery) of what are now recognized as "Sacred Articles" (Holy Bible, Charter, Bone, covers and Passports) in our Order had become so widespread that the Kennel By-Laws (Section 1107) had to be revised to prohibit their being taken and held for ransom. And the initiation process that had been in place for decades underwent a positive change at all levels of the Order around the same time.

In the old days, we thought we were "hot stuff" if we could donate \$2,000 or \$2,500 to outside organizations at a Supreme Growl; now, we're getting close to \$100,000 in annual contributions for the betterment of the community, especially the children's hospitals we donate to annually. The institution of, growth and close management of the Kennel Passport Fund is one of the primary reasons the Order finds itself in the position to make sizable annual contributions. One of the best Pedigreed Devil Dogs I've ever been privileged to call friend and brother Marine – PDD Charles D. Fields – when assessing fines at Pound and Pack Growls - would say, if a Dog objecting to a fine they had been assessed, was "what's a matter, don't you love the children?"

What I've shared here isn't my story alone. It belongs to every Devil Dog, living and dead. And every Devil Dog living and dead owns it. And to add to the story of the Order; we are blood and bones, legends, guns, and dreams, Catholics, Protestants, Jews, (perhaps even a Muslim or two) horses, Marines and poets and lovers.

Conveniently for me, I liken our Order to good whiskey (even though I've been sober for 43½ years) in a glass - a cone of amber, a self-contained passage of time, a place apart, reaching out to the world with sometimes an acrid taste, a definite excess of personality, telling its story to all who will listen, hauling them forward by the lapels of their coats until they hear, whether they want to or not. But always, - the story is the teller, and the teller is the story. In the "Pilgrim's Progress," we mark these words: "...my marks and scars I carry with me..." The one joy that has kept me going through life has been the fact that stories unite us. As I once told my grandchildren, a story has only one master.

No matter what you are, a Past Chief, a Pedigree Devil Dog, a Devil Dog or "just" a Pup; always remember: you should not be defined by what you are; but, rather by who you are. Are you doing your best to enhance and expand the Military Order of Devil Dogs? Are you working towards advancement until you become a Pedigreed Devil Dog or seeking to gain Pound, Pack or Kennel office? As an **Ole Past Chief**, I see my role as that of a mentor to those coming up through the ranks, nothing more.

If you are a new Pup, Devil Dog or Pedigreed Devil Dog going forward into the 21st century - do you have the "fire in your belly" and the "healthy ego" necessary to one day become a Chief Devil Dog?

For the Good of the League/Order

There has been discussion on the proper procedures for displaying proper respect to the Flag during saying the Pledge of Alliance. Some of you may be aware of these changes that are taking place, and some may not be aware of the changes. Either way I would like to set the record straight on the proper procedures for Marines to display towards our flag. Once a Marine, Always a Marine! We should be conducting ourselves as Marines as we show proper respect to our Flag

First let me repeat the United State Code for Patriotic Customs Title 36, Sec 172:

Pledge of Allegiance to the Flag, "I pledge allegiance to the Flag of the United States of America, and to the Republic for which it stands, one Nation under God, indivisible, with liberty and justice for all.", should be rendered by standing at attention facing the flag with the right hand over the heart. When not in uniform men should remove any non-religious headdress with their right hand and hold at the left shoulder, the hand being over the heart. Persons in uniform should remain silent, face the flag, and render the military salute. Members of the Armed Forces not in uniform and veterans may render the military salute in the manner provided for persons in uniform.

I want to thank our leadership for researching this issue, finding that we are doing the Pledge incorrectly, and working at correcting the issue. However, I believe along with many others, (I have discussed this with many members of the MCL/MODD, PCDD's, Senior active-duty Marines, Senior Retired Marines, and Legal lawyer), about the proper respect that Marines share when respecting the flag is the military salute. Most all want to maintain the military salute, we have earned a right of passage as veterans that civilians do not understand or even know the proper method of saluting. We fall under the last highlighted section as persons in uniform and also as veterans to have the privilege to render the salute during the Pledge of Allegiance as we do with the Nation Anthem. However, we should remain silent during the Pledge as we do with the Anthem. The MCL has not really worried about members chiming in during the Anthem and if the MODD has issues with Dogs reciting the Pledge while saluting; well, those Dogs may be fined!

After discussing with years of active service Marines the following is the best procedure for our MCL/MODD members to follow:

The person Singing the Anthem or reciting the Pledge will go to the microphone

The Sgt of Arms/Police Dog will call the body to attention

The Sgt of Arms/Police Dog will give the Command Hand Salute

All members will face the flag, in uniform salute the colors, (not in uniform place their hand over their heart), remain silent

The member reciting the Pledge/singing the National Anthem will then drop their salute and recite the Pledge/sing the Anthem standing at attention

Kennel Veterinarian: PDD's Howard Koontz, Paul Gunther, Douglas Essinger

We the Kennel Veterinarians (medical staff) for the good of the MODD and ALL Marine Corps League members (and their families) do propose and recommend the following suggestions be implemented by the League and MODD. Before listing these, we would like to offer some pertinent information about the three current active Veterinarians. We have a former Corpsman who is also a certified EMT, another former Corpsman who is also a Registered Nurse, the third member is a Registered Nurse. Between us, we have two Bachelors' degrees, a Masters' degree and a PhD. Combined, we have over 100 years of experience including ER & ICU, Cardiac Surgery stepdown, Respiratory and to add some variety, throw in

Pediatrics, Labor & Delivery. We wear the white labs coats to be easily recognized, not to look good (although we do!)

We are NOT Medical Doctors and cannot diagnose a condition nor prescribe or give out medicine, even Tylenol or Aspirin. However, with our combined experience, we can recognize when a condition is or can become serious, even critical, and the person needs more urgent care then we can provide. We can stabilize the person, get vital signs, etc., and all pertinent information to pass onto EMS. We can do this, but only if EVERY member of the League helps us, even if you do not take prescription medicines or have any known problems. If you have a living will, end of life directive or are an organ donor, that information should also be on your person. You never know when something may happen. This can be easily done by typing or clearly printing your name on a piece of paper with the following information:

- 1.) Emergency contact, name, and phone number including area code;
- 2.) Doctor or Primary Care Provider, name, phone number. If a VAMC, name of the facility and phone number;
- 3.) Pacemaker or history of heart problems, diabetic;
- 4.) Hip or knee replacement, etc. (in short, a brief medical history);
- 5.) List of all PRESCRIBED medications, name of drug, dosage;
- 6.) Living will, end of life directive or are an organ donor.

EXAMPLE OF INFORMATION - Last name first, first name last

Sawyer, Dennis

Dr. Myers, VAMC Mountain Home, TN 423 926-1171

Pacemaker

Left knee replacement

Drug alpha 25mg

Drug bravo 50mg

Drug Charlie 100 mg

Etc., etc. with all prescription drugs.

I have a living will, end of life directive or am an organ donor.

Keep a copy of this information in your wallet, staple it to the inside back page of your passport, and for those advancing to PDD, a copy to the Veterinarians. Even if you not a member of MODD but have a pacemaker, take prescription medications or other notable health problem, this information should be passed on the veterinarians as it applies to you.

Having this information makes our job easier and may SAVE YOUR LIFE!!




