Registration: This dog is being sold as a pet only with American Kennel Club (AKC) limited registration and will not be granted full registration at any point.

Seller's Guarantee: Health records will be provided by the Seller which includes information on any treatments given to this dog. Due to the unpredictable nature of Parvovirus and Distemper, no guarantee is made for these illnesses unless the dog is found to be afflicted with the illness within 48 hours from the date and time of transfer listed above; the dog must be returned to the Seller within 24 hours of diagnosis for a full refund of purchase price. If the dog is not returned within 24 hours, no refund will be issued.

1 Year Guarantee: If it is found by a state licensed veterinarian and confirmed by a specialist that this dog has a life ending and untreatable congenital defect resulting in euthanasia within 365 days from the date of birth, the Seller will issue a full refund of purchase price. If this dog passes away due to a congenital defect as the sole cause within 365 days from the date of birth, it must be confirmed by necropsy, paid for by the Buyer; results must be made available to the Seller before Seller will issue a full refund of purchase price.

Lifetime Return to Breeder: If for any reason the Buyer cannot keep this dog, the Seller should be notified immediately. The Seller agrees to aid the Buyer in rehoming this dog to another individual. If a suitable and mutually agreed upon home cannot be found, the dog should return directly to the Seller. When the dog is returned to the Seller, ownership is transferred, the purchase price is forfeited, and the dog's AKC registration certificate is signed over to the Seller.

Acceptance: The undersigned Buyer hereby acknowledges having read the terms of this sales contract and does hereby agree to abide by each of the provisions set forth above. It is understood that under no circumstances will the Seller be held responsible for any Veterinary or other expenses for any reason whatsoever after Buyer purchases the dog. The Seller will not be held responsible for any injury or damages caused by this dog. When the dog leaves the care of the Seller, it becomes the sole financial responsibility of the Buyer. No other warranties are expressed or implied other than what is written in this sales contract. In the event of any legal actions arising from or in connection with this contract, Buyer will be responsible for all attorney and legal fees. Jurisdiction and/or venue of any litigation arising out of or related to this contract or dog shall lie exclusively in the county of Bradley, state of Tennessee.
