#### **Eligibility Criteria:**

- The nominee's service to youth must have been provided within Catawba County
- The nominee must be recognized as directly responsible for empowering youth to make healthy life choices

#### **Nomination Process:**

- 1) Complete the attached nomination form.
- 2) Include (1) letter of recommendation from a person **other** than the nominator who is familiar with the nominee's service. The letter must explain:
  - **How** and **Why** the service rendered by the nominee is extraordinary
  - List the Results as they relate to the impact of service for the community
- 3) **ALL** application materials for the JoAnn Spees Youth Advocacy Award must be sent to the Council on Adolescents of Catawba County office by either mail or email to [JLedford@coacatawba.org](mailto:JLedford@coacatawba.org) by **Friday, March 27<sup>th</sup>**.
