


- Carrier will automatically be assigned to the order and sent an electronic rate confirmation if the Accept Offer is chosen


Counter Option View




- If Carrier chooses the Counter Offer option, they can counter with their offer amount and the Broker will receive notification of a Counter Offer

Accepted Loads View






View when the drop-down toggle is selected. Carriers can add check calls, add images, view rate confirmations, and enter dispatch information.






- Carriers can upload any documentation related to the order, as well as indicate what type of document it is. These Documents transfer over to DocumentPower.

View Rate Confirmation








