

BOARD AND TRAIN AGREEMENT

THIS BOARD AND TRAIN AGREEMENT ("AGREEMENT") IS ENTERED INTO BETWEEN THE UNDERSIGNED DOG OWNER ("OWNER") AND THE TRAINING FACILITY ("TRAINER") FOR THE PURPOSE OF PROVIDING PROFESSIONAL BOARD AND TRAIN SERVICES FOR THE OWNER'S DOG(S).

1. SERVICES PROVIDED

TRAINER AGREES TO PROVIDE BOARD AND TRAIN SERVICES, WHICH INCLUDE HOUSING, FEEDING, CARE, AND PROFESSIONAL TRAINING OF THE OWNER'S DOG(S) DURING THE AGREED TRAINING PERIOD.

2. TRAINING PERIOD

- **THE MINIMUM TRAINING PERIOD IS TWO (2) WEEKS.**
- **ADDITIONAL WEEKS MAY BE ADDED UPON MUTUAL AGREEMENT BETWEEN OWNER AND TRAINER.**
- **THE START AND END DATES OF THE TRAINING PERIOD WILL BE SPECIFIED IN WRITING PRIOR TO COMMENCEMENT.**

3. FEES AND PAYMENT

- **THE WEEKLY FEE FOR BOARD AND TRAIN SERVICES IS \$1,050 PER WEEK.**
- **A MINIMUM OF TWO WEEKS (\$2,100) IS REQUIRED AND MUST BE PAID IN FULL PRIOR TO THE START OF TRAINING.**
- **ANY ADDITIONAL WEEKS MUST BE PAID IN ADVANCE BEFORE THE EXTENSION BEGINS.**
- **PAYMENTS ARE NON-REFUNDABLE ONCE TRAINING HAS COMMENCED.**

4. OWNER RESPONSIBILITIES

- **OWNER MUST PROVIDE PROOF OF CURRENT VACCINATIONS, INCLUDING RABIES, DISTEMPER/PARVO, AND BORDETELLA.**
- **OWNER MUST DISCLOSE ANY KNOWN BEHAVIORAL ISSUES, MEDICAL CONDITIONS, ALLERGIES, OR SPECIAL NEEDS OF THE DOG(S).**
- **OWNER MUST PROVIDE SUFFICIENT FOOD FOR THE DURATION OF THE TRAINING PERIOD UNLESS OTHERWISE ARRANGED WITH TRAINER.**

5. TRAINER RESPONSIBILITIES

- **TRAINER WILL PROVIDE SAFE HOUSING, DAILY CARE, AND STRUCTURED TRAINING SESSIONS FOR THE DOG(S).**
- **TRAINER WILL USE HUMANE, PROFESSIONAL TRAINING METHODS.**
- **TRAINER WILL PROVIDE PROGRESS UPDATES AND A GO-HOME SESSION TO TRANSFER TRAINING KNOWLEDGE TO THE OWNER.**

6. HEALTH AND SAFETY

- **IN THE EVENT OF ILLNESS OR INJURY, TRAINER WILL MAKE REASONABLE EFFORTS TO CONTACT OWNER. IF OWNER CANNOT BE REACHED, TRAINER IS AUTHORIZED TO SEEK VETERINARY CARE AT OWNER'S EXPENSE.**
- **TRAINER IS NOT LIABLE FOR INJURY, ILLNESS, OR DEATH OF THE DOG(S) DUE TO PRE-EXISTING CONDITIONS, NATURAL CAUSES, OR CIRCUMSTANCES BEYOND TRAINER'S CONTROL.**

7. LIABILITY

- OWNER AGREES TO HOLD TRAINER HARMLESS FROM ANY CLAIMS, DAMAGES, OR EXPENSES ARISING FROM THE DOG'S BEHAVIOR DURING OR AFTER TRAINING.
- OWNER ACKNOWLEDGES THAT WHILE TRAINING CAN SIGNIFICANTLY IMPROVE BEHAVIOR, NO GUARANTEES CAN BE MADE REGARDING FUTURE BEHAVIOR.

8. TERMINATION

- TRAINER RESERVES THE RIGHT TO TERMINATE THIS AGREEMENT IF THE DOG POSES A DANGER TO STAFF, OTHER ANIMALS, OR ITSELF. IN SUCH CASES, OWNER MUST RETRIEVE THE DOG IMMEDIATELY, AND NO REFUND WILL BE ISSUED.

9. ENTIRE AGREEMENT

THIS AGREEMENT CONSTITUTES THE ENTIRE UNDERSTANDING BETWEEN OWNER AND TRAINER. ANY MODIFICATIONS MUST BE MADE IN WRITING AND SIGNED BY BOTH PARTIES.
