Regular Council Meeting
December 10, 2024 6:30 p.m.

Members present: Councilman Michael Dorman, Councilwoman Paula Floyd, Councilwoman Lori Beatty, Councilman Landon Johnson, and Mayor Gardner were present.

Mayor Gardner called the meeting to order. Councilwoman Lori Beatty gave the invocation and led the pledge of allegiance. Mayor Gardner asked for a motion to approve the agenda and minutes. Councilman Dorman moved to approve, and Councilwoman Floyd seconded the request. Motion passed to approve the minutes and agenda.

In Discussion: A.) Town Manager Mrs. Work shared that The First Annual Jingle Jam Christmas event raised \$3000.00 for Aynor area families in need. B.) 
