Regular Council Meeting August 27, 2024, 6:30 p.m.

Members present: Councilman Michael Dorman, Councilwoman Paula Floyd, Councilwoman Lori Beatty, Councilman Landon Johnson, and Mayor Gardner were present.

Mayor Gardner called the meeting to order. Councilwoman Beatty gave the invocation and led the pledge of allegiance. Mayor Gardner asked for a motion to approve the agenda and minutes. Marcia Cooper requested the town postpone the rezoning meeting until signs have been put out for the public to be made aware.
