Regular Council Meeting
November 12, 2024 6:30 p.m.

Members present: Councilman Michael Dorman, Councilwoman Paula Floyd, Councilwoman Lori Beatty, Councilman Landon Johnson, and Mayor Gardner were present.

Mayor Gardner called the meeting to order. Councilman Johnson gave the invocation and led the pledge of allegiance. Mayor Gardner asked for a motion to approve the agenda and minutes. In Public Comments: No one signed up for comments






