Minutes of meeting on Feb 5, 2015

Location - Rwitti's home

Present – all board members except Puja Tanwani.

1. Welcome

2. Yoga – Malathi and Veena are interested in continuing to teach Yoga. Day and timing of class to be discussed with them. Some members wanted the class to be on Sunday evenings instead of Mondays; however, the monthly rental (for 4 classes) is higher (\$75) on Sunday evenings vs \$60 on weekdays.

Funds generated from this class will be donated to whichever cause is determined as the top priority at a given time. The name "Yoga for a Cause" for a cause can continue without specifying any particular charity.

Rashmi mentioned we get 15% of the revenue from Bollywood class, which is available on a quarterly basis. This revenue will be added to general IWA funds for taking care of expenses.

5. Directory

- 7. Outreach Mahashweta contacted Rwitti to explore the possibility of a partnership between IWA and Kathryn Weil Center. Rwitti suggested that this Center can offer workshops in CPR and Heimlich Maneuver, especially if they can do them free of cost. Mahashweta will check with the Center.
