**New Business**

**CCJBA Updates:**

- Jason Simon selected as CCJBA South Field Representative. Role will be funneling info to area heads, similar to current position. One year term.
- July state tourney, July 17-19, county is July 10-12.
- All games done by July 3 (Minors, Juniors). No TBD games this year. Last day of league play for Seniors is July 10.
- March 1<sup>st</sup> need to have rosters, teams, coaches, background checks, concussion protocol
- April 1<sup>st</sup> all paperwork due to JBO
- Pitch count: Juniors 85 pitches total per day. Max per day regardless of number of games.
- April 15 start of season
- Increase team fees to \$175
- All rules voted on Nov 10

**CCJBA Rule Proposals:**

The Board will draft statements/emails for Jason Simon to submit to CCJBA Board by Sunday, Oct 12.

- Silverton to host Minor American and Junior American County Tournaments
- Move kids up if team needs players, pull from National to American and they can't pitch
- Require all Minor American or higher (at all levels) fields to have portable pitching mounds
- Noise makers: Don't allow, penalize

**Key Dates:**

- Registration: Opens Jan 1<sup>st</sup> and closes last day of evaluations, Feb 9
- Set Rosters – Sunday, Feb 16, board gathers to determine teams
- Evaluation Dates: Confirmed eval dates of Sat, Feb 1 and Sunday, Feb 9. These are the two primary dates that will be published.

- Blinn checking on one additional week date (either Thurs, Jan 30 or Thurs Feb 6). This will be for anyone who absolutely can't attend a weekend date.
- Proposed language for FAQ and website:
  - Players are highly encouraged to attend at least ONE evaluation date.
  - Players are welcome to attend both weekend evaluation dates. Evaluators will take the highest scores.
