## $ALABAMA^1$

## ALASKA<sup>2</sup>

### **Staff Interpreters**

None anywhere in the state.

### Independent Contractor Court Interpreters

There are no official rates. The policy for compensating court interpreting services for "oral language interpreters"<sup>3</sup> is cited below<sup>4</sup>:

- a. For a language interpreter provided by the Language Interpreter Center (LIC), the court system will pay the fee charged to the court system by the LIC.
- b. For use of the language line, the court system will pay the fee charged by Language Line Services (LLS).
- c. For a court-certified or trained interpreter obtained through the federal courts, another state court, or a government agency, the court system will pay the same fee that the other court or government agency would have paid.
- d. For a freelance interpreter, the court system will pay the fee charged by the interpreter, but no more than 125 percent of the fee charged by the LIC for an interpreter with similar credentials.
- e. For a bilingual person with no formal interpreter training, the court system will pay half the fee charged by the LIC for a trained interpreter.
- f. For standby time during which the interpreter is required by the court to be in attendance at the court facility, the court system will pay the fee charged by the interpreter, but no more than \$25.00 per hour.
- g. For travel time between the interpreter's regular place of business and an out-oftown court, the court system will pay the fee charged by the interpreter, but no more than \$25.00 per hour. The court system will calculate travel time and pay travel expenses (air fare, ground transportation, lodging, and per diem) according to the rules that apply to court employees.
- h. For emergency services requested and performed outside regular business hours, the court system will pay the fee charged by the interpreter, but no more than an additional \$15.00 per hour. Regular business hours are 8:00 a.m. to 4:30 p.m., Monday through Friday, except judicial holidays."

## ARIZONA<sup>5</sup>

#### **Staff Interpreters**

Certified foreign language interpreters are reimbursed for travel time at the rate of \$20/hour and mileage at \$0.42/mile only when the distance from the contractor's residence to the location of the assignment exceeds 40 miles round trip. Travel time is paid for actual time of travel, not in 15-minute increments.

Non-certified foreign language interpreters are reimbursed for mileage at the same rate, but are not ordinarily eligible for travel time; however, on a case-by-case basis, travel time at \$10/hour may be offered.

### CALIFORNIA9

#### **Staff Interpreters**

The Superior Court of California employs three types of staff interpreters, but employees of the Superior Court are not state employees (see Chapter 4 for details). The Judicial Council of California reimburses most of the costs of both staff and contract interpreters incurred by the Superior Court of California from funds appropriated annually by the Legislature.

- 1. A morning session, beginning no earlier than 8:00 a.m. and ending by 2:15 p.m;
- 2. An afternoon session, beginning no earlier than 1:00 p.m. and ending by 5:15 p.m.; or
- 3. A night session, which is a separate session, as determined by the court, beginning no earlier than 5:15 p.m. and ending by 10:00 p.m.
- b. A full-day session is defined as a morning session and an afternoon session." (at p. 1)

#### Multilingual interpreters

An amount above the daily rate may be provided for interpreters who render services in more than one language on the same day.

#### Mileage reimbursement

Actual mileage is reimbursed when the interpreter travels 60 miles or more roundtrip from his or her place of business (address used for tax purposes). The rate of reimbursement is the rate as authorized by the state (\$0.51/mile in 2011 and \$0.565/mile in 2013<sup>11</sup>).

Extraordinary travel costs such as airfare may be reimbursed only with advanced approval of the court executive officer, or his or her designee.

#### Unusual circumstances

An amount above the daily rate, and/or a cancellation fee may be provided under unusual circumstances. Unusual circumstances are defined as follows:

- There are limited or no available interpreters in the needed language; and
- The alternative is to continue the proceeding.

A trial court and the interpreter may negotiate an amount for travel time in unusual circumstances." (at p. 3) The policy also provides a framework for cancellation fees.

"**Two-hour minimum.** Interpreting services for assignments other that [sic] those remunerated at a half-day/full-day rate will be compensated at a two-hour minimum. Any additional time beyond the two hour minimum will be invoiced **in fifteen-minute increments.**" [emphasis in original]

"Evening work. Work performed for calendars scheduled after 5:00 p.m. will be invoiced at a two-hour minimum and at a rate increase of \$5.00 over the established hourly fee."

"**Mileage reimbursement.** There will not be mileage reimbursement for assignments involving a round trip of **twenty-five miles** or less (round trip is defined as travel from the place of residence to the courthouse and back to the place of residence)." When mileage is paid, the rate is \$0.40/mile.

## GEORGIA<sup>24</sup>

### Staff Interpreters

#### **Contract Interpreters**

The Georgia Administrative Office of the Courts has not established uniform rates to be followed in the trial courts. The Supreme Court has issued a rule, "Use of Interpreters for Non-English Speaking Persons," <sup>25</sup> the pertinent parts of which follow:

#### V. COMPENSATION OF INTERPRETERS

There shall be no uniform, state-wide compensation system at this time. Local courts will have the responsibility for developing and testing a variety of approaches to compensation consistent with guidelines that may be established by the Commission [Georgia Commission on Interpreters created in §II of the rule] and by statute. The Commission shall evaluate the approaches to compensation developed by the local courts and determine the need for a statewide flexible compensation system. Subject to Supreme Court approval, the Commission shall implement such a system. *Commentary:* Although the contribution of volunteers to interpreter programs throughout the country is inestimable, the Georgia Supreme Court believes that the comprehensive system of statewide interpreter services envisioned by these rules cannot be handled entirely by unpaid volunteers. This court is convinced that in order to build and maintain a statewide system of interpreter services of the extent and quality desired, there must be mechanisms for compensating interpreters at appropriate levels. This court also believes that the Georgia interpreter program will require a combination of volunteers, salaried in-house interpreters, and free market interpreters in order to meet the highly varied demands and circumstances of courts in urban, rural, and suburban areas.

Appendix A, "Uniform Rule for Interpreter Programs," provides the following:

#### VI. Interpreter's Fees and Expenses.

- (A) Any interpreter providing service under this rule shall be compensated as directed by the local court or appropriate governing body.
- (B) The expenses of providing an interpreter in any legal proceeding will be borne by the local court or appropriate governing body.

The Judiciary, State of Hawai'i, adopted an internal document, "Revised Court Interpreter Fee Schedule with Payment Guidelines" effective January 1, 2004.<sup>29</sup> The major features of the policy include the following:

- A cancellation policy describing when payment may and may not be made, §4;
- Definitions of when payment periods begin and end and what is included (e.g., waiting time and traveling between proceedings), §§5-8;
- Mileage reimbursement @ \$0.35/mile, increased effective July 1, 2013 to \$0.55/mile, \$9;
- A lump sum of four hours' pay for travel time when traveling between islands (but not within an island), \$10; and
- Travel expenses when traveling from another island or an overnight stay is required, including air and ground transportation, lodging, and meals, §11.

The suggested guidelines for compensation for the country district courts include the following recommendations:

- A two-hour minimum (§6.1 in the General Guidelines for Compensation [GGC])
- Payment of any services provided beyond two hours in 15-minute increments (sample contract, §3 in the *GGC*)
- Mileage reimbursement at the current state rate, which is currently \$0.555/mile, "for each mile necessarily traveled in excess of 30 miles one-way" (§6.3 in the *GGC*)
- "Airfare, hotel accommodations, and per diem for meals for out-of-town interpreters should also be paid by the county." (§6.3 in the *GGC*)
- "After 40 miles of travel one-way, court interpreters should receive compensation for travel time at half the hourly rate." (§6.4 in the *GGC*)
- For telephonic interpreting, payment at the same hourly rate listed above with a one-hour minimum (§6.2 in the *GGC*)
- Payment for assignments canceled with less than 48 hours notice for the time reserved at the corresponding hourly rate (§4 of the sample contract and §6.6 in in the *GGC*)

No reimbursement is recommended for cancelled appearances if the interpreter was notified by telephone (notice by telephone includes answering machine, voice mail, e-mail and beeper message) by the court of the cancellation at least one day (24 hours) or more prior to the start time of the assignment. If the interpreter has traveled some distance to the assignment and did not receive the message regarding cancellation due to the required travel, it is within the court's discretion whether or not to pay the interpreter....

C. Cancellation By The Court With Payment To The Interpreter

In the event an interpreter accepts an assignment for a full day which is cancelled less than one day (24 hours) before the date of the trial was to begin, it is recommended that the court approve reimbursement of the interpreter for four hours service, provided that the court was unable to secure work for the interpreter in other cases or in other courts for the canceled time period.

In the event that an interpreter accepts an assignment for more than one day which is cancelled less than one day (24 hours) before the trial was to begin, it is recommended that the court approve reimbursement to the interpreter for eight hours of service, provided that the court was unable to secure work for the interpreter in other cases or in other courts for the cancelled time period."

Payment for Travel Time.** At the discretion of the judge, an interpreter may be paid the State of Wyoming's allowable mileage reimbursement rates [\$0.565/mile in 2013] and/+or half the hourly interpreter rate for travel time. In extraordinary circumstances, the interpreter may be paid the full hourly interpreter rate when round trip travel exceeds 150 miles.
- A.III.D. Overnight Travel. In the case of trials or hearings exceeding one day duration, language interpreters may be compensated for food and lodging at the standard rate established by the Wyoming Supreme Court when round trip travel of 120 miles or greater is required to secure a professionally certified Spanish language interpreter, or the best qualified interpreter in the case of languages other than Spanish. To receive reimbursement for food or lodging expenses, the language interpreter must receive authorization form the court for the expenses in advance of the actual expenditure. Reimbursement of allowed food and lodging expenses through the court will be made only if itemized receipts are provided and expenses are within the allowable ranges as defined by the State of Wyoming fiscal procedures.
- **A.III.E.** Cancellation Policy. Contract interpreters whose assignment is cancelled within seventy-two (72) hours of the assignment start time shall be paid for the schedule time up to a maximum of sixteen (16) hours at the discretion of the judge presiding in the cancelled matter. If the assignment is cancelled with more than seventy-two (72) hour notice, the scheduling District is under no obligation to pay the cancellation fee."
