VENDOR AGREEMENT

Set-up may begin at 7am Saturday, April 27, 2024 and should be completed a by 9 AM. The event lasts until 4:00 PM. You may not begin vacating the vendor space any earlier than 3PM. All vendors must be vacated by 5PM.

All vehicles must be off Main Street no later than 9am. Only Car Show vehicles with the proper credentials will be allowed on the street. You may park at 9th and Willow (one block south of Main on the 900 block).

Main Street Duncan will assign vendor spaces and notify all merchants via email 1 week prior to the event about your booth location.

This is a family event - any promotional material deemed questionable may be prohibited.

All trash, waste, banners, signs and other materials must be properly disposed of in a public waste receptacle.

Vendors are responsible to pay Oklahoma Tax Commission sales tax.

Sharing of booth space is not permitted; one vendor/business/organization per space only.

Water will not be provided and is unavailable.

Vendors are responsible to provide their own equipment (i.e. extension cords, canopies, tables, chairs, weights, etc.).

If the event is canceled due to weather, natural disaster, or emergency, no refunds will be given. A rain date has been scheduled for the following weekend, May 4, 2024.

Exclusive rights for the sale of any item will not be guaranteed; Main Street Duncan, Inc. tries not to have more than two vendors selling like items.
