## **IMPORTANT! NEW RULE FOR 2023**

In the event of non-uniform regional representation, to determine a playoff format, preference for "byes" will be given to teams who have submitted their entry forms and fees to the board prior to the deadline, as well as those teams who have entered the tournament in prior consecutive years. These factors will be considered by the board to determine the playoff pairings, as well as geographic locations, and which teams drew byes the previous year. The board also reserves the right to reduce the size of a region that happens to produce more teams than other regions.
