**Workshop Title:** Protective Systems, Perpetrator Dynamics, and Aggression in Children with Complex Trauma  
A Sandtray and Play Therapy Clinical Approach

#### **Presenter Information**



**Ana M. Gómez** is a leading expert in the field of complex trauma, dissociation, and intergenerational trauma, with a particular focus on children and adolescents. She is the founder and director of the AGATE Institute in Phoenix, AZ, a psychotherapist, author, and international speaker who has trained thousands of clinicians worldwide through her workshops, advanced trainings, and keynote presentations. With 30 years of clinical practice, Ana is a recognized authority in EMDR therapy and its application with children, adolescents, and families. She is a fellow of the International Society for the Study of Trauma and Dissociation (ISSTD) and the author of *EMDR Therapy and Adjunct Approaches with Children: Complex Trauma, Attachment, and Dissociation*, as well as her most recent book, *EMDR-Sandtray-Based Therapy: Healing Complex Trauma and*

*Dissociation Across the Lifespan*. In addition, she is the co-editor of *The Handbook of Complex Trauma and Dissociation in Children: Theory, Research, and Clinical Applications* and has contributed numerous book chapters on EMDR therapy, complex trauma, dissociation, and intergenerational trauma. Her work has been recognized with distinguished honors such as the Francine Shapiro Award (EMDRIA, 2023), the Hope Award from Sierra Tucson (2012), and the Distinguished Service Award from the Arizona Play Therapy Association (2011).

#### **Workshop Description**

This two-day training explores how children and adolescents exposed to early and chronic relational trauma develop systems of self-protection and internalized perpetrator dynamics that shape behavior, affect regulation, aggression, and therapeutic engagement. Using an integrated Sandtray Therapy framework with play therapy engagement, participants will learn to recognize defensive adaptations, dissociative self-states, and victim-perpetrator dynamics as they emerge symbolically and relationally through sand worlds and play therapy interaction. The training emphasizes developmentally paced, attuned, and play therapy interventions that support stabilization, regulation, safety, and agency while preparing children and adolescents for gradual trauma integration and reprocessing.

#### **Learning Objectives**

By the end of this training, participants will be able to:

1. Explain how early and chronic relational trauma shapes the development of child and adolescent self-protective systems using frameworks informed by Polyvagal Theory and Attachment Theory.
2. Identify state-based defense patterns — particularly avoidance, dissociation, control, and compliance — as they emerge symbolically and relationally in the tray and play process.
3. Track behavior, pacing, proximity, posture, movement, and autonomic shifts in sand scenes to support clinical hypothesis-making and moment-to-moment treatment decisions.
4. Apply attunement-led engagement strategies that enter defenses safely without confrontation or destabilization, preserving safety and therapeutic agency.
5. Use integrated play-and-sandtray interventions to scaffold emotion regulation, sensory rounding, and relational flexibility before trauma reprocessing begins.
6. Use psychoeducation to support the child and adolescent in unblending from defensive self-states and reorganizing their relationship with protective parts.
7. Ground the child and adolescent in present-moment safety using the sand and miniature collection to foster sensory regulation, self-compassion, and self-protection that feels agency-led and resourced.
8. Describe how idealization of the perpetrator and internalized perpetrator dynamics develop in children and adolescents who have experienced chronic relational trauma and abuse.
9. Identify ego states, dissociative parts, defensive identities, and relational roles in which children protect the abusive caregiver, silence vulnerability, or direct aggression toward self or others.
10. Explain key concepts involved in perpetrator internalization, including identification, introjection, trauma bonds, betrayal trauma, and attachment-based loyalty conflicts.
11. Recognize overt, subtle, and implicit expressions of victim–perpetrator dynamics as they emerge in sand worlds and play interactions, including various forms of aggression toward others and toward the self.
12. Use a multimodal and transtheoretical clinical lens grounded in Sandtray Therapy and play based engagement to organize case conceptualization and guide treatment planning.
13. Observe and track how patterns of aggression and internalized perpetrator dynamics relate to shifts in arousal, activation, withdrawal, and other autonomic patterns during sand and play based work.
14. Formulate treatment goals that support regulation, safety, and agency while promoting a gradual and developmentally appropriate path toward trauma integration and reprocessing.

#### **Required Materials, Participation, and Activities**

GAPT will provide each participant with workshop supplies. Participants have the option to bring their own note taking equipment (computer, paper/pen). Participants are encouraged to bring miniature figures they already have to support symbolic expression and scene-building. A diverse assortment is recommended (people, animals, structures, nature elements, objects).

#### **Who Should Attend**

This conference is intended for play therapy, mental health, school counseling, marriage and family, social work, rehabilitation counseling, alcohol and drug abuse, psychiatric, psychology, pastoral care, nursing, art therapy, drama therapy, and child life specialist professionals and students. There is no prerequisite for this conference other than being a mental health professional with an advanced degree in a mental health-related field or a student working on such a degree.

#### **Registration, Fees, and Deadline**

Participants are required to complete the conference registration online along with paying the applicable fee(s) at [www.gapt.org](http://www.gapt.org). The [conference registration](#) and continuing education payment deadline is **Saturday, February 28th, 2026 or when the workshop reaches maximum capacity**. Registration will not be available thereafter or at the door. Related links for payment(s) are embedded within the e-registration process. Completed forms and payments must both be submitted in order to confirm a seat and/or table space reservation. *Procrastinators beware*: Please understand that the fire marshal and local ordinances limit registration. There are no special exceptions. A waitlist will be started if capacity is maxed. (We are unable to predict when that will occur). We recommend that you register early.

Registration fees include the workshop, conference handouts, lunch for both days, and some of the required workshop materials. Registration fee is for both days. (Registration cannot be purchased for a single day for this event.)
