TOURNAMENT RULES



FORMAT: Team event; (4) bowlers per team, all men, all women, or mixed. Teams will bowl (3) games. Handicap based on 90% of 220 per game. Legacy In Motion Tournament will be sanctioned through USBC.

TEAM ENTRY: A team may enter the tournament multiple times provided one (1) member on the roster has changed.

PBA BOWLERS: Current/Active bowlers holding a Professional Bowling Association membership are strictly prohibited from participating in this tournament. Any bowler that has participated or won a PBA National or PBA Amateur Title in the last (3) years are also prohibited from participating in this tournament. Tournament Officials reserve the right to cross reference the participant roster against the Official PBA Membership records. A participant found to be in violation of the professional bowler restrictions will be immediately disqualified from the tournament. All entry fees will be forfeited. Any prize money or awards will be stripped and reallocated.

ENTERING AVERAGE: Entering averages will be derived as follows from bowl.com: (1) Bowler's composite average for 2025-2026, will be used as the entering average. If no composite average from 2025-2026, then the composite average, from 2024-2025 will be used. If the bowler does not have an average for either year, then scratch average of 220 will be used. **Ten pin rule will apply in computing entering averages. If the bowlers current average is ten pins higher than reported composite average, then current higher average will be used.**

SCORING FORMAT: The teams (3) ten pin score plus handicap will determine the overall teams score .

TEAM ENTRY FEE & BREAKDOWN: The entry fee, per bowler is \$55.00, or \$220.00 per team entry. Of the \$55.00 entry fee, \$39.00 is allotted for prize fund, \$16.00 is allotted for lineage and expenses.

SCRATCH & HANDICAP SINGLES: Bowlers have the option to participate in the Handicap or Scratch Singles event while bowling the team event. There will be male and female divisions for both the singles and handicap optional events. Of the total entries 1 of 4 will cash. Bowlers may cash multiple times. **NO OPTIONAL EVENT ENTRIES WILL BE ACCEPTED THE DAY OF THE EVENT.**

OPEN BRACKETS AND SIDE POTS: Handicap and Scratch Nassau will be available with Male and Female Divisions. Open Scratch and Handicap Brackets will be available in three Divisions. Divisions (1) 199 average and below, Division (2) 200 average and above. Division (3) will be Scratch.

APPLICATION ENTRIES AND MAILING ADDRESS: **APPLICATIONS WILL NOT BE ACCEPTED WITH PARTIAL PAYMENTS. ALL OPTIONAL EVENTS MUST BE PAID WITH THE ENTRY APPLICATION.** Mail entries to: Wonya Mitchell PO BOX 213 Groveland, Florida 34736. CASH RATIO/PRIZE FUND DISTRIBUTION: Of the total team entries, 1 of 8 will cash. Total pins plus handicap will determine standings from 1st place to the final paid position. **Teams that cash will have four individual checks mailed to the Team Captain. Team Captains will be responsible for distributing checks.**

Any rules not covered here will be rendered by the Tournament Director, and those decisions will be final.
