- Respond to user inquiries or support requests, if applicable.

#### 3. Sharing Your Information

We do not sell, trade, or share your information with third parties, except in the following limited circumstances:

- Service Providers: We may engage trusted third-party services (e.g., mapping or analytics providers) to support App functionality. These providers are bound by strict confidentiality agreements and only process data on our behalf.
- Legal Requirements: We may disclose information if required by law, such as to comply with a court order or protect our rights, property, or safety.

### 4. Data Security

We implement reasonable technical and organizational measures to protect your information from unauthorized access, loss, or misuse. However, no system is completely secure, and we cannot guarantee absolute security.

### 5. Your Choices and Rights

You have control over your information:

- Location Data: You can disable location services for the App at any time through your device settings, though this may limit map functionality.
