

# COVID 19 Pandemic-Health and Safety Precautions

In order to provide parents with the assurance you need that we at Masai's Playhouse are doing our part to keep your child and family healthy and safe I've compiled this list of health and safety precautions we take every day and on a routine basis. We've also added several new policies to provide an even safer environment due to circumstances surrounding COVID 19.

We hope that these steps taken and our new policies will be met with understanding and appreciation by all.

- Frequent hand washing by all staff and children in care
- Sanitizing of all kitchen areas before and after each meal and snack
- Steam mopping all hard floor areas daily
- Vacuum all carpeted areas daily
- Shampoo carpets biweekly
- Winix air purifiers in use in all childcare areas
- Filter cleaning daily and routine replacement of all Winix air purifier filters in childcare areas
- Sanitizing all hard surface, high traffic areas in childcare spaces using Force of Nature EPA approved sanitizing cleaner, Seventh generation disinfectant spray and wipes at the end of each day and routinely through the day.
- Sanitizing all toys and bins daily and disinfecting using a two step cleaning process biweekly
- Deep cleaning of bathrooms including wiping of walls and all surfaces on a weekly basis and daily spot cleaning
- Hand sanitizer available in play room and infant room
- Gloves and disposable changing mats at each diaper change
- Two step sanitizing of hypoallergenic changing mat after each change
- Sanitizing all infant toys, soft play equipment, bouncers and rockers daily or after each use
- Two step cleaning and sanitizing of nap mats after each use
- Face masks used for any children with pediatrician confirmed allergies, that are exhibiting allergy symptoms
- Sanitizing of cloth face masks after each use, using grapefruit seed extract, tea tree oil and vinegar, then air drying in natural sunlight
- Children whose parents sign a permission to administer form, receive a daily liquid multivitamin and elderberry dose with vitamin c and zinc.
- Constant hand washing by all staff and children in care. Hands are washed immediately upon entering, before and after meals and any other times as needed, with soap and warm water for a minimum of 30 seconds.
- No shoes are ever worn inside. Children enter, and remove shoes on the tiled floor at the door.

These policies will be applied in conjunction with our sick policy.

1. At no time will any persons, other than enrolled children be allowed entry to the childcare home, unless in an emergency situation, or when arranged in advance during non childcare hours.

2. During drop off and pick up, please ring the doorbell and step back off from the door. A marker will be placed at the doorway, marking the appropriate place to stand. Parents who would prefer not to wait at the door can call or text just prior to arrival so that your child can be ready as soon as you arrive.

3. All children in attendance will be required to remove their shoes and wash their hands immediately upon entry.

5. Any child presenting with ANY symptoms of illness, including those directly related/listed as a symptom of COVID-19 will be immediately isolated from the group

4. Absolutely no outside personal items will be allowed into the childcare home. This

related/listed as a symptom of COVID-19 will be immediately isolated from the group within the childcare home, a non surgical/non medical grade mask will be placed on your child and parents will be called to pick up immediately. Depending on the symptoms and severity of symptoms, your child will not be allowed to return to care until:

A negative COVID test result and 3 days symptom free

includes car seats, personal blankets, backpacks, toys or dolls.

OR 10 days at home AND 48 hours symptom free

OR 72 hours symptom free AND a physician's note clearing your child of illness.
