Both the winner and the 1st alternate from tonight's contest will be qualified to compete at the National Contest.

The following is a list of expectations set in place by the National Coordinators that all representatives that qualify to compete at the national contest should abide by. Your promoter may have additional requirements/expectations and if so, you will be provided them in writing.

**Expectations of a Preliminary Representative:**

- The appearance of a preliminary representative should be professional at all times.
- The preliminary representative agrees to keep a valid cellular telephone number in service and keep lines of communication open with their promoters.
- The preliminary representative shall return telephone calls and email correspondence in a timely manner.
- The preliminary representative agrees to assist with the promotion of the National Miss Comedy Queen Pageant.
- The preliminary representative is expected to motivate contestants and increase the contestant base for this preliminary.
- As a preliminary representative, I understand that I am required to attend the National Miss Comedy Queen Pageant and my failure to do so will result in being placed on a ban list until I return all prizes/monies to my promoter. I agree that any terms and/or conditions not outlined in this agreement are to be decided upon by Loc Robertson, owner of ANR Productions and/or the board of directors set into place. I further agree that the terms and conditions of this contract may change throughout the course of my reign and may change without notice. I agree by competing that I will be filmed/photographed and my image/likeness could be used for future promotion of any and all ANR Production events both locally and internationally. I further understand that I will not be compensated for this footage and authorize ANR Productions to use this footage as they deem necessary.

# **NATIONAL MISS COMEDY QUEEN GENERAL PRELIMINARY RULES AND REGULATIONS**

## **1. Eligibility**

Contestants must be at least twenty-one (21) years of age and must provide valid government-issued proof of age upon request.

## **2. Judging and Scoring**

Judging will be conducted using a cumulative points system. The highest and lowest scores in each category will be dropped (with **7 judges** or more).

- In the event of a tie within a category, the previously dropped high and low scores will be reinstated for the tied contestants to determine placement.
- In the event of an overall tie, the contestant with the higher Comedic Talent score will win. • Official score sheets will be provided by prelim promoters.

## **3. Categories of Competition**

Contestants will compete in the following five (5) categories:

- Casual Interview
- Presentation (in the theme of the previous National Pageant)
- Comedic Talent
- Outrageous Evening Gown
- 60-Second Spokeswoman

## **4. Drug Policy**

The use, possession, or distribution of illegal drugs during any ANR Productions event is strictly prohibited. Violation of this policy will result in immediate disqualification and possible removal from the venue.

## **5. Backstage Access**

- Contestants are responsible for the conduct of their helpers and dancers.
- Only one (1) helper at a time per contestant will be permitted backstage in the dressing room.  
This individual will receive one (1) complimentary backstage access pass.
- All additional helpers and all dancers must pay full admission.

## **6. Performance Restrictions**

Any form of entertainment is permitted unless it is illegal or poses a safety risk to contestants, judges, audience members, or the venue.

The following are strictly prohibited:

- Fire
- Nudity
- Live animals
- Excessive glitter or powder
- Excessive liquid
- Excessive food
- Any substance or material that may create a safety hazard or damage the venue

Failure to comply may result in administrative point deductions or disqualification.

## **7. Music Requirements**

All music must be submitted in adherence to the guidelines of the Prelim Promoter. Each track must also be labeled appropriately (example: "Name – Talent").

## **8. Theft, Property Damage and Personal Liability**

Any contestant, helper, or dancer found stealing, intentionally damaging, or tampering with another person's property will be immediately disqualified and removed from the venue. Legal action may be pursued if necessary.

Participation in this event is voluntary, and all contestants, helpers, dancers, and attendees assume full responsibility for their own safety and well-being. The Producer and event staff are not responsible or liable for any injuries, accidents, losses, or damages that may occur during participation in or attendance at the event. All individuals participate at their own risk and accept 100% personal responsibility for any injury or harm sustained.

## **9. Conduct and Authority**

Any contestant whose conduct is deemed demeaning, harmful, or damaging to ANR Productions, the Miss Comedy Queen Pageant, or its titleholders may be disqualified.

ANR Productions reserves the right to make final decisions regarding any matter not specifically addressed in these Rules and Regulations.

## **10. Administrative Points**

An administrative point deduction will be 5 points per infraction from the total score.

## **11. Additional Rules**

Applicable rules may vary by venue and are subject to amendment, modification, or supplementation from time to time at our sole discretion of the Board of Directors.

## **12. Changes**

The Board of Directors reserves the right, in its sole and absolute discretion, to amend, revise, supplement, or otherwise modify these rules at any time, with or without prior notice.

# CATEGORY DESCRIPTIONS AND SCORING SYSTEM

## 1. Interview (30 Points)

Time Limit: 5 Minutes

Attire: Casual, "come as you are" (drag or business attire optional)

Contestants will meet individually with the judges in a relaxed setting. Appearance is NOT part of the score for this category. While you may dress as you choose, remember this is a professional job interview.

Questions will not be political or religious in nature. This category represents the "business" portion of the pageant. Judges are looking for a contestant who demonstrates professionalism, confidence, and knowledge of the Miss Comedy Queen system.

Judging Criteria:

- 10 Points – Confidence, Body Language & Personality  
(Comfort level, professionalism, presence)
- 20 Points – Interview Content  
(Quality and completeness of answers)

*Note: It is not necessary to be funny in this category.*

## 2. Presentation (30 Points)

Performance Time Limit: 2 Minutes (administrative points will be deducted for exceeding the time limit)

Prop Setup/Breakdown: 1 Minute Total (not included in performance time)

Each contestant will present themselves to the judges and audience according to the selected theme. Contestants will introduce themselves as well as state their name and contestant number. This introduction will not be included within the two (2) minute time limit.

Contestants must provide their own music. Any performance medium is acceptable. Judges are looking for creativity, clarity, confidence, and overall effectiveness of the presentation. Judging

Criteria:

- 10 Points – Comedic Value
- 10 Points – Execution of Presentation
- 5 Points – Creativity of Presentation
- 5 Points – Microphone Ability

### **3. Comedic Talent (50 Points)**

Performance Time Limit: 5 Minutes (administrative points will be deducted for exceeding the time limit)

Prop Setup/Breakdown: 3 Minutes Total (not included in performance time)

Contestants may present any talent in any medium that does not endanger themselves or others.

Prohibited: Excessive glitter, powder, food and/or liquid. No fire, nudity and/or hazardous materials.

Contestants will be judged on ability, entertainment value, and overall effectiveness. If dancers or props are used, they will be judged as part of the performance.

Judging Criteria:

- 20 Points – Comedic/Entertainment Value
- 20 Points – Talent Quality  
(Lip sync, live vocal, dance, or other medium)
- 10 Points – Technical Execution  
(Costuming, props, dancers, stage use, sound quality)

### **4. Outrageous Evening Gown (30 Points)**

Time Limit: 1 Minute Minimum, 2 Minutes Maximum

Contestants will model a full-length, outrageous evening gown of their choice. The gown may be any color, material, or style; however, it must still function as a traditional evening gown.

The base garment must stand alone as a complete gown. Accessories such as headpieces, back pieces, lighting, or moving elements are encouraged but will be judged separately and should enhance—not replace—the gown.

Outrageousness may be expressed through:

- Materials
- Theme or concept
- Design innovation
- Music and staging
- Modeling and presentation choices

This is a fashion and modeling category—not a performance number. Lip-syncing should be minimal or avoided. Humor is not required.

Judging Criteria:

- 5 Points – Outrageousness/Creativity of Gown
- 5 Points – Modeling & Presentation
- 10 Points – Technical Construction & Proper Fit
- 10 Points – Hair, Makeup, Jewelry & Accessories

## 5. 60-Second Spokeswoman (20 Points)

Time Limit: 60 Seconds

Each contestant will receive a bag or box containing a random item. They must create and deliver a sales pitch within 60 seconds, convincing the judges and audience to "buy" the product.

Contestants will be judged on humor, clarity, confidence, and effectiveness of the pitch.

Judging Criteria:

- 10 Points – Comedic Value
- 5 Points – Clarity & Microphone Ability
- 5 Points – Effective use of time
