 - a. Membership presentation Kym Pierce she revamped the membership flyer to be more family and less pledge related; she has worked on the DS Youth Art Club to be self-sustaining and absorb all of the costs for After-School Program, Summer Arts, and Inspiration Square; these programs would become the club instead of separate classes; it will cost 65 for a Family Membership, 75 a year per child to be in the Youth Art Club, or 35 for members; at this point, Kym doesn't want help in the planning stages

Director's Report Kasey she has been involved in classroom management for After-School Arts, and Summer Arts; We have about 15 students for Summer Arts; Suima is done and was successful, she is working on Inspiration Square cutting out trees for fence which will have a lot of elements added; she has flags prepped for kids to paint to replace the winter ones, also to give a consistent look through town, she'll be working on an entry arch with a welcome sign community service workers are being used; HCCA Bonnie drove over from Cortez, Kasey supported her with gas money, Kasey and Bonnie taught, then kilns broke down right before the graduation– cost 750 to fix, she asked the high school art teacher, Anita Mays to help fire; Cora made certificates, Bonnie led them in presenting their favorite piece
