- b. Grants and fundraisers Catherine represented us at SKA Brewing we got \$270 in donations, but she could only go one Tuesday in July; she will check on next year and we can market it on Facebook to increase participation; Cora is working on researching grant support for Sandyha LPEA waiting; Walmart too many asking; Ballantine coming up in September, Kasey is meeting with their Board to give them a tour at 10:15 on August 22, Sandyha is coming; Moniker is touring on August 15; working on Creative District Tech Support grant; Chinook not good fit for DS, but possibly for SWRY; Good Deeds (Bonnie) grant applied for waiting; still have some Trauma monies coming (\$1860)
- c. Catherine wants to write an Annual Report of fundraising to use for grants who did we serve, who funded us; this exists in some way for the 990 and grants
