Call to Order 6:15

3. Treasurer's Report

a. Approve October Financials – discussion about question on a negative Contract Services cost which means it is a release of expenses. Anthony had question about what it means on Lease Hold Improvements on Balance Sheet. Melody has question on the Profit/Loss payroll expenses shown only as Other. Catherine says that the report was run wrong. Catherine will get with Cindy to run the correct report and ask about these 2 questions. Tabled until December's Board Meeting

General Fund Balance \$3232.21; Artist Sales account balance: \$2193.23; Grant for the CIRD is a receivable of \$1000 which will take about 4-6 weeks; we received \$600 today from the Detention Center for October, it will end at the end of 2019, we get 10% of for Dancing Spirit, since we are a pass through for Tim Murphy's program

b. Status Update on Operating Expenses –We have Ballantine's Grant still out there for 3000; Durango Realtors is still out there, but not secure; we need contract income, fundraising income, memberships, class fees, and grants; Sandhya is looking at others for best fit

i. Review space rent, 60 day notice to ELHI – Kasey is very concerned for our funding needs; Room 19, Studio B was inherited from Sharon Hunter, with \$376.48 rent; the dance program runs 9 months a year, we pay teacher \$18 per hour, she gets \$10 per student for about 4 students, for 4 times a week, Yoga pays us after the month at \$60; Room 18, Gallery has rent of \$379.08 used for office and meeting space, plus AA which pays \$30; Catherine – sees that we are making 50% of the expenses for Studio B; Gallery is opportunity to gain memberships and have shows; Anthony sees value of Gallery and sees Studio 2 B; Room 20 storage and kiln rooms – Kasey requested that ELHI back the rent down due to the original lease stating that it was not useable for classes – they will leave it until the end of our lease at the lower rate until August 2020; Melody was in favor of Studio 2B due to all of the people Sharon has brought in, we will lose our dance teacher at the end of the school year; Kasey wants to get back to artists and gallery focus Motion by Catherine to give a 60 day notice on Studio 2B and try to find a dance champion or let it go, Anthony 2nd
