  - b. Review 2019 Bonuses mistake with payroll last May; a bonus has a 22% tax rate, Cindy Humiston and Catherine adjusted the bonus amount so that the employees didn't have to pay extra for taxes; Kasey added up time spent over contract which was 942 hours for her, and 208 hours for Cora
  - Review payroll contract with ASAP Catherine says that then you can see it clearly, it's awkward with Quicken; payroll would be 65 per month less 15%, so about 48, and Quicken Payroll would be 35 per month plus 3.00 per employee, plus Cindy's time
  - Open saving account with goal for the year of about 2 months so about 5000; General Account has 26275.43, Artist Sales has 3128.39; Musser grant coming in late summer for 5,000; need 3800 without programs running, about 5000 with programs;
  - e. CPA? Cindy will do our bookkeeping for one more year; Recommending Laura Hokanson (Silver Spruce recommendation) because she is familiar with DS and has helped get us

Laura's cost is 600; Noveah's cost was 350, 4 Corners Accounting in Aztec that Cindy recommended. There are three transactions we need an accountant to do. Last year, we budgeted 1000 for audit. Cindy has a bookkeeper to recommend, so it may help to have an accountant that can work well with the bookkeeper; Decision: stay with who we have now and change after the new bookkeeper starts; Kasey signed contract for DS

f. Sales tax discussion – Catherine – we need to look at what tax is charged on; ok for fundraisers that are 12 days or less; other random sales require sales tax, then remit it quarterly; have to pay sales tax on aprons, bags, and t-shirts, clay bags, selling furniture,
