Since Our Last Meeting

Hello DS Board Members! We've had a busy month since our last board meeting. Things are moving on the building, we've had our first summer classes and of course, our BIG Fill Your Plate fundraiser.

Building Update

- There is movement in that big hole in the ground! Footers are complete, and stem walls should be done by July 4th. We are looking forward to a blessing ceremony (affectionately titled the Dream Maker Rising Ceremony) on July 26th at 11am.
- Money has been received from Moniker (\$10k), and there currently is \$530k in the 1st SW Bank account (\$10k Moniker, \$10k from TBK, and our original \$10k).
- Todd Gaver was paid \$13,644 from the TBK savings account for the April, May and part of the June invoices.

• We currently need to fundraiser \$62k+ to meet the \$1.2k starting number for the building.

Programs

Building Bridges Through Art-

- Camp Creative We had low attendance for Camp Creative, with two registered with scholarships that never attended. July's camp will be coming up next. There are currently 5 registered.
- Ignite Gymnastics did a clay critters class with 20 children in attendance
- Boys & Girls Club Boys and Girls Club has been attending art classes every Monday and Friday from 10:00-11:30. We will continue to have them until August 4th.
- Southern Ute Ed will be coming in for a 2 day drum making class on July 19th & 20th.

Adult Pottery – Open Studio on Saturdays is continuing through the summer.

Gallery sales were \$340.50 (double last month). June is slow, especially with the construction going on.

Public Art –due to construction, there are no new public art installations

Other - We need teachers for the upcoming programs (2023-2024) and time to get them trained.
