CONFIDENTIALITY, PRIVACY & SOCIAL MEDIA AGREEMENT

To protect Kori Michelle's privacy, personal brand, creative content, invited guests, and the privacy of all minors attending the event, all guests and/or their parents or legal guardians agree to the following terms as a condition of attending Kori Michelle's birthday party.

1. NO POSTING BEFORE KORI MICHELLE

Guests may take personal photographs and videos at the party unless otherwise instructed. However, **NO photographs, videos, Reels, TikToks, Stories, Shorts, livestreams, or other footage from the party may be posted, uploaded, published, shared publicly, or distributed on social media or any other public platform BEFORE Kori Michelle releases/posts her own birthday party video or gives permission for guests to begin posting.**

Public group chats, websites, blogs, or other social media/digital platforms

Guests should not attempt to "beat Kori to the post," reveal party content early, or share footage that could spoil Kori Michelle's official birthday content.

2. NO LIVESTREAMING

There will be **no unauthorized livestreaming** from Kori Michelle's birthday party.

Guests may not livestream the party or any portion of the event on TikTok Live, Instagram Live, YouTube Live, Twitch, Facebook Live, or any other livestreaming platform without prior permission from Kori Michelle's parent/guardian or authorized representative.

3. REQUIRED HASHTAGS

Once Kori Michelle has released her birthday party content and guests are permitted to post their own approved photos or videos, all social media posts featuring content from the party must include:

#korimichelle #justbeingkori

Additional appropriate hashtags may be added, but these two hashtags must be included.

4. RESPECT FOR KORI MICHELLE AND OTHER GUESTS

Guests agree not to post photographs, videos, audio, captions, comments, or other content that is embarrassing, inappropriate, misleading, defamatory, disrespectful, or potentially harmful to Kori Michelle or another guest.

Because minors may be present, guests are expected to use particular care when posting content featuring children or teenagers.

If a guest or parent/guardian requests that a particular image or video of them or their child not be posted, that request must be respected.

5. PRIVATE AND PERSONAL MOMENTS

Any private conversations, personal information, behind-the-scenes discussions, family matters, incidents, or other information learned or observed during the party that would reasonably be considered private must remain confidential.

Guests may not secretly record private conversations or private areas of the event.

6. COMMERCIAL USE

Photos, videos, recordings, or other content captured at the party may not be sold, licensed, submitted to media outlets, provided to gossip or entertainment pages, used in advertising, or otherwise used commercially without prior written permission from Kori Michelle's parent/guardian or authorized representative.

7. REQUEST TO REMOVE CONTENT

If Kori Michelle's parent/guardian or authorized representative determines that party-related content violates this agreement or creates a privacy or safety concern, the guest agrees to promptly remove the content upon request.

8. MINOR GUESTS

If the guest is under 18 years old, this agreement must be acknowledged and signed by the guest's parent or legal guardian.

By signing below, the parent/guardian confirms that they have reviewed these rules with their child and agree to help ensure their child follows them.

9. ACKNOWLEDGMENT

By signing this agreement, I acknowledge that I have read and understand the confidentiality, privacy, recording, and social media rules for Kori Michelle's 15th Birthday Party.

I specifically understand that **I MAY NOT POST OR PUBLICLY SHARE PARTY PHOTOS OR VIDEO UNTIL AFTER KORI MICHELLE HAS RELEASED HER OWN BIRTHDAY PARTY CONTENT OR PERMISSION TO POST HAS BEEN GIVEN.**
