PLEASE READ CAREFULLY

In consideration for being permitted to engage in Martial Arts classes and activities at Lakeville TSD (hereafter referred to as "School"), the undersigned (hereafter referred to as "Student") on behalf of him/herself and all and each of his /her heirs, executors, administrators, successors and assigns agrees and acknowledges as follows:

Student understands that this agreement may severely restrict or eliminate Student's and or his/her heirs, executors', administrators', successors' and assigns' legal rights to bring a claim against School for injuries to Student incurred while participating in martial arts activities.

Student hereby acknowledges and recognizes that martial arts training and its related activities are by their nature inherently dangerous and involve known as well as unanticipated risks of serious physical injury, emotional injury and in extreme cases possible death. Student understands that such risks of injury are involved in, but not Limited to, the training, running, jumping, kicking, punching, sparring, handling of martial arts weapons, breaking of boards and related objects incurred during martial arts classes, and while participating in martial arts exhibitions and tournaments. Student understands that there is an unpredictable nature of injury in, but not limited to, sparring, breaking of boards and related items, and practicing martial arts techniques that can not be eliminated without jeopardizing the essential qualities of the art, and enters into such activities voluntarily.

Student, on behalf of him/herself and all and each of his/her heirs, executors, administrators, successors and assigns, hereby voluntarily accepts and assumes all responsibility and risks involved in martial arts training and related activities, and further agrees to waive, release and hold harmless School, its owners, officers, members, employees, representatives, instructors, assistants and agents from any and all obligation and liability for personal injury to Student arising out of Student's participation in martial arts activities, classes, exhibitions and tournaments; the use of the School's premises; and from traveling to, participating in, or returning from said School, or any other martial arts related activities under School's auspices. (Provided the injury is not the direct result of intentional conduct on the part of the School, its owners, officers, members, employees, representatives, instructors, assistants and agents)

In the event Student brings a legal action against School, its owners, officers, members, employees, representatives, instructors, assistants and agents for acts and/or injuries to Student as part of Student's participation in martial arts training and related activities referred to above, and does not prevail, Student will be responsible for all reasonable attorneys' fees and costs of litigation incurred by School in defending the action.

I understand that any pictures of me participating in school sponsored activities may be used for publicity without compensation at this or any other time.
