For Interest in Seat A or C, return the form immediately (as these seats are currently open). For Interest in Seat B or D, return the form to TNHA no later than October 19, 2018.

General Information: TNHA has a 5-member board representing: Seat A Atqasuk and Anaktuvuk Pass, Seat B Point Lay and Point Hope, Seat C Wainwright and Barrow, Seat D Kaktovik, and Seat E Nuiqsut. Each commissioner is appointed for a 3-year term by Arctic Slope Native Association, LTD, on the recommendation of the village councils. To qualify as a Commissioner, you must be 18 years of age or older, a current resident of the North Slope Borough for at least 6 months, and willing and able to serve. Individuals who accept such appointments are expected to represent the interests of their representative areas, as well as, the overall interests of the region. TNHA has approximately 4 or more Board meetings a year, usually in Barrow and occasionally outside of Barrow. Board training and orientation occurs each year. Most of TNHA's programs are funded by the U.S. Department of Housing and Urban Development (HUD) pursuant to federal grant and procurement standards.
