Canada-Ontario Job Grant Application Overview

The <u>Canada-Ontario Job Grant (COJG)</u> is a government-funded subsidy that offsets the cost of training new and existing employees. The goal of this program is to help employers invest in their workforce by sharing the cost of training – ultimately, to support job creation, increase job quality or provide job advancement opportunities.

Program Benefits:

Eligible employers, including nonprofit organizations, can save up to 5/6 of training costs, with reimbursement of up to \$10,000 per trainee.

Contact Your Local COJG Service Provider

For training applications involving 25 or fewer participants, the COJG service provider will make grant funding decisions and manage/administer grant agreements with employers.

Employers should reach out to their local COJG service provider to confirm eligibility and schedule a needs assessment.

- Next: Locate an organization near you, visit their website, and reach out to them directly.

To fill out the application, you will need the following information:

- 2. Employee Information:
 - Number of employees you plan to train
 - For each employee: their job title, current wage, and details about the training
- 3. Training Program Details:

Additional Information

- 1. Ensure all documents are in order, including the training provider's credentials and a clear breakdown of costs.
- 2. The grant operates on a first-come, first-served basis, so apply early. COJG funding runs from April 1 to March 31.
- 3. Training must be completed within 52 consecutive weeks
- 4. Preference is given to Tier 1 applications the goal is to provide workers with the skills necessary to stay competitive in the job market or adapt to changes within their industry. This tier supports both employee retention and career advancement, helping organizations build a skilled workforce while minimizing the impact of layoffs.
- 5. A slight salary increase is viewed positively.
- 6. Keep records of all communications, payments, and receipts related to the training.
