The U.S. Navy is facing drydock capacity issues. St. Croix is a viable solution because of its geographical location in the Caribbean. The U.S.V.I. currently has a port of call for the billion dollar cruise line industry. U.S. - HART is uniting its P3 alliances to develop the Alexander Hamilton Drydock.

“If we build it they will come.”

“In October 2017 Megan Eckstein reported that the Navy’s surface ship maintenance and modernization requirements would keep rising, thus more ship repair yards are needed. The Navy plans to conduct about 35 percent more surface ship maintenance work. That figure will only go up if the service follows through with plans to increase the size of the fleet. Rear Adm. Jim Downey, commander of Navy Regional Maintenance Centers and deputy commander for surface warfare at Naval Sea Systems Command (NAVSEA), told USNI News in a Sept. 28th interview that his biggest concern is drydock availability.”

May the attendees of this summit have an enlightening experience as we all continue to work together to propel the Caribbean forward.

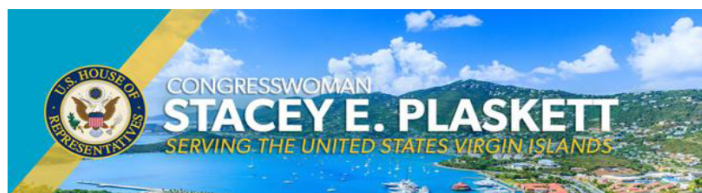

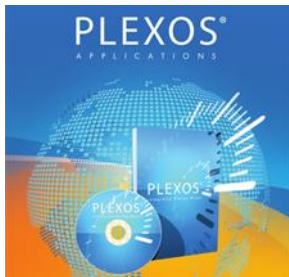
