AN ORDINANCE OF THE TOWNSHIP OF PATTERSON, BOROUGH OF FALLSTON, BOROUGH OF PATTERSON HEIGHTS, AND TOWNSHIP OF WHITE, BEAVER COUNTY, PENNSYLVANIA, APPROVING THE ENTRY INTO AN INTERGOVERNMENTAL COOPERATION AGREEMENT BETWEEN THE MUNICIPALITIES, FOR THE PURCHASE OF A CERTAIN EMERGENCY POWER BACKUP GENERATOR AND TRANSFER SWITCH FOR THE EMERGENCY OPERATIONS CENTER.

WHEREAS, Patterson Township wishes to purchase an emergency power backup generator and transfer switch for the Emergency Operations Center (EOC); and,

WHEREAS, the estimated cost of said purchase is Forty Six Thousand, Four Hundred Dollars (\$46,400.00); and

WHEREAS, Patterson Township is without sufficient funds to purchase said emergency power backup generator without entering into a joint purchasing agreement with Fallston Borough, Patterson Heights, and White Township; and

WHEREAS, there is also available to Patterson Township, a program administered by the Commonwealth of Pennsylvania, Department of Community and Economic Development known as the Municipal Assistance Program, through which the municipalities have been awarded a grant in the amount of twenty-three thousand, two hundred dollars (\$23,200.00); and

WHEREAS, the municipalities hereto desire to enter into an intergovernmental cooperation agreement, for the purchase of said emergency power backup generator utilizing Municipal Assistance Grant Contract No. C000053065; and

WHEREAS, the Township of Patterson, Fallston Borough, Patterson Heights Borough, and White Township have entered into negotiations for an Intergovernmental Agreement to effectuate the purchase of said emergency power backup generator and transfer switch utilizing Municipal Assistance Grant Contract No. C000053065 through the Department of Community and Economic Development of the Commonwealth of Pennsylvania; and

WHEREAS, the municipalities hereto desire to enter into the aforesaid Intergovernmental Cooperation Agreement, a copy of which is attached, made a part, and marked Exhibit "A"; and

WHEREAS, the municipalities are permitted to enter into the aforesaid Intergovernmental Cooperation Agreement through their enactment and adoption of an Ordinance authorizing the same, under and pursuant to the authority granted to the municipalities by 53 Pa. C.S.A. §2305.

**NOW, THEREFORE, BEING ENACTED AND ORDAINED** by the municipalities and it is hereby enacted and ordained by authority of the same as follows:

1. The Intergovernmental Cooperation Agreement attached as Exhibit "A" is hereby approved.

2. The municipalities agrees to be bound by the terms and conditions of said agreement and Municipal Assistance Grant Contract No C000053065.

3. The municipalities hereby authorize its President of Council or Board of Commissioners to execute the Intergovernmental Cooperation Agreement and any and all other documents necessary to effectuate the terms and provisions of the agreement and this Ordinance, all of the same to be attested by the respective secretary of the municipality.

4. This Ordinance shall become effective upon the date on which each governing body shall approve it.
