Minutes: Bryan Landman moved that the Council approve the minutes of the February 21, 2018 meeting. The motion was seconded by Fran Levinger, and approved by voice vote.

Police Report: Chief David Stanislawski presented his monthly report for February, 2018. The Chief explained the Do-Not-Knock policy used in Patterson Township, and we agreed to check on the relevant ordinances regarding solicitation in the Borough.

Fire Report: Chief Medlin - Absent. Vice-President Turnbull read the February report submitted by Chief Medlin.

Visitors: Xander Wilkinson, of 504 4th Avenue, 724-683-1852, updated the Council on his plan to join the National Guard, and his being unlikely to organize a block party this year.

Solicitor: Mr. Paganie presented Ordinance 280, increasing several Borough fees, and making it possible to increase fees in the future by resolution, rather than by ordinance. Ordinance 280 had been advertised in the Beaver County Times on February 26, 2018. Bryan Landman moved that Ordinance 280 be ratified, Fran Levinger seconded, and it was approved without opposition.

Code Enforcement: Dawna Pella - Absent. The report was read by Vice-President Jim Turnbull.

Communications: There were no communications received this month.

Tax Collector: Nadine Galbreath - Absent. The Treasurer reported -0- Real Estate Tax receipts for February, but nearly \$10,000 deposited so far in March.

Secretary/Treasurer: Jack Doyle - (1) Recent receipts have included \$23,279.04 for our Liquid Fuels account, and \$9,238.71 in February in Earned Income taxes. (2) The inspection of the boiler has been completed. (3) It was noted that the new clock in the meeting room was sent by the PSAB at no charge to the Borough.

Old Business: - (1) The Secretary was asked to set up a meeting with Josh Platt, of Intertech Security, for the purpose of providing access to the Police Department of the security cameras. The Secretary presented materials from Minuteman Press regarding violation notices to be used by the police. Relevant ordinances will be identified for violations and associated fines. (3) Reactions to the letter distributed to Borough residents were discussed.

Mayor - Mayor Tyger discussed tree trimming at 68 Darlington Road, necessary to clear the view of traffic signs. It was also asked about the possibility of placing a stop sign at 9th Avenue and Central Alley. Chief Stanislawski noted that a traffic study of the intersection would have to be completed first. The mayor also responded to a question about open burning, and was provided with a copy of the burning ordinance.
