THIS AGREEMENT is made on this day of by and between hereinafter referred to as "Adopter" and Liberty Sanctuary hereinafter referred to as "Organization."

Adopter agrees to pay the adoption fee of \$

1. Adopter certifies that he/she has never been accused or convicted of any animal rights misdemeanors or felonies.

2. Adopter understands and agrees that the equine identified in this contract will be co-owned by Liberty Sanctuary for the first year. After that time, the adoption is complete and the equine may not be removed from Adopter's personal supervision and control or removed from the address described herein, except for emergencies, training, shows, trail rides and other temporary situations without written approval of the Organization. In all decisions, the Adopter commits to protecting the welfare of the equine and will never sell the animal into slaughter or under market value.

3. Adopter agrees to uphold standards of care for said equines including maintaining good nutritional health, vet care, vaccinations, worming, dental care and hoof care.

4. Adopter understands Liberty wishes to track economic data related to this horse and agrees to supply Liberty with dollar amounts spent in the first year on fencing, shelter, training, vetting, hay, tack, equipment and any other related costs. Please send those quarterly to info@libertysanctuary.org.

5. Should the Adopter decide that the equine is no longer wanted for any reason, Adopter understands that the Organization will take back the equine and attempt to place it with another adopter.

6. If Organization has notification or knowledge of violation of terms of contract, Adopter agrees that an authorized representative of the Organization may enter the property where the said equine resides during normal business hours and without notice to determine if terms of this adoption contract are being complied with.

7. Adopter understands that should a violation of any of these terms in this agreement be found and in the judgment of a representative of the Organization, such conditions represent a danger to the health and welfare of the equine, Adopter hereby authorizes a representative of the Organization to enter the property at any time and without



cause or warrant upon the land where said equine resides and take immediate physical possession of said equine without recourse from Adopter.

8. Adopter further agrees that, Adopter will accept all responsibility for any action, damage or lien resulting from any action, directly or indirectly involving said equine while it is in Adopter's possession and under Adopter's care and control. Therefore, Adopter agrees and understands that neither the Organizations or its authorized representative, will be liable for any damages or injury caused to Adopter or any third person by the equine once Adopter receives delivery of the equine, including but not limited to damages or injuries caused by the fact that the equine does not behave or perform in the manner Adopter expected. Further, if any third person makes a claim against the Organization or representatives as a result of any conduct of the equine after Adopter has taken possession of the equine, Adopter agrees to indemnify and hold the Organization and its representatives harmless from any such claims, including costs and attorney's fee resulting from such claim. ☐

9. Adopter may personally return the equine to the organization or Adopter may arrange for equine's return to the Organization if Adopter so desires at any time during the equine's life at the expense of Adopter. In the event of the Adopters death, Adopters heirs are bound buy the terms of the contract. If Adopters heirs are unable to maintain the equine, Adopters heirs must also return the equine to the Organization as provided for above. ☐

10. Adopter agrees to cooperate with Organization, to give updates from time to time on the equine at the request of the Organization, including but not limited to current photos, equine related expenses, health issues, concerns, phones calls. ☐
