GUEST SPEAKER AT JUNE REPRESENTATIVE ASSEMBLY

Dr. Dereck Black

Dr. Derek W. Black is a professor of law and one of the nation's foremost experts in education law and policy. He focuses on school funding and equity for disadvantaged students. He has published over thirty articles in the nation's top legal journals. His work reaches beyond the legal community. In an era of dwindling public school resources and ever-expanding inequality and privatization. He frequently appears in the media. His essays appear in *USA Today*, *Washington Post, Los Angeles Times, Newsweek, and Education Week*. He is also a frequent radio and television guest

for national, regional, and local outlets.. Black is currently Professor of Law at the University of South Carolina. He began his career at Howard University School of Law, where he founded and directed the Education Rights Center. Prior to teaching, he litigated education cases at the Lawyers' Committee for Civil Rights Under Law.

His recent book, *Schoolhouse Burning: Public Education and the Assault on American Democracy,* warns that current education represents a retreat from our nation's foundational commitments to democracy and public education. The Tennessee Retired Teachers Association would like to welcome Dr. Derek Black back to Tennessee as our keynote speaker. His former high school teacher, President-Elect Dewayne Emert will introduce Dr. Black at the TRTA Representative Assembly on Tuesday, June 11 at the Embassy Suites in Murfreesboro, Tennessee. You will not want to miss his presentation and the RA!



Retirees Continue Their Commitment to Public Education



Throughout the weeks of the TRTA spring workshops, I was thrilled to witness just how much our Tennessee retired teachers believe in the importance of public education. Although many of our members retired twenty or thirty years ago, their belief in and commitment to public schools and public school educators has not waned.

TRTA members continue to stay up to date on legislation — most of it very harmful to our public schools. They understand that vouchers will steal much needed funding from our public schools and transfer that money to the unproven scheme of supporting private schools. Our members are outraged that these same legislators who received an excellent public school education themselves, are in support of using public tax dollars to supplement private school tuition. These private schools will not be held to the same educational standards as our public schools nor will these private schools be transparent regarding who gets accepted.

There are so many unanswered questions when it comes to how private schools will handle the enrollment of students. Just who will private schools accept? Will these private schools hire qualified teachers who can modify instruction for special needs students or will the private schools simply tell the parents that their local public schools can best meet the needs of their children? Will they look first at the student's ethnicity or the parents' income? None of these questions have been addressed, yet the voucher bill has a budget cost close to \$400 million. Teachers understand how devastating it will be for our public schools should these funds be transferred to a voucher system.

I want to say how much I appreciate our TRTA members for their support of public schools. We all know that when we retired, we left our position in our public school but we didn't leave the profession. My plea to retirees is that we continue to be the voice of reason. It is incumbent upon us to inform our fellow citizens that Public Education is one of the founding pillars of our society and offers every student an opportunity for equality.
