ASSUMPTION OF RISK, WAIVER, AND RELEASE FROM LIABILITY

- 4. **PREREQUISITE SKILLS AND TRAINING.** The undersigned acknowledges that he or she has the requisite skills, qualifications, physical abilities, and training necessary for proper and safe care of the horses and the facilities of LBL Equine Rescue and to participate in the activity itself.
