The Washington Park Areas neighborhood liaisons plan to walk through: 574-604 Panoramic Highway, 100 Adams, Muir Avenue, Mountain Lane, part of Redwood Avenue, and all of Washington Park. We want to familiarize ourselves with street and house locations as well as utility shutoffs. This will make it easier for neighbors to help you in case of emergencies like earthquakes. We don't want to intrude, so we will call and remind you we are coming beforehand. Aren't you glad your neighbors care enough to be there when disaster strikes! ## AM 1280: EMERGENCY RADIO STATION UPDATE

The radio frequency has been changed again. The new frequency is 1280 AM. We will be mailing stickers for you to put on your telephone, your radio, and your emergency handbook. There also will be signs along Panoramic Highway informing the public about his new local specific emergency radio information service.

The station will have recorded information for park areas during non-emergency periods which will be overridden by the Marin County Sheriff's Department during an emergency, like fire. This gives us that all important evacuation information so we all can get off the mountain safely. The station is still not operational, but we hope to have testing sometime in the next month. We will keep you posted.







#### PARCEL TAX UPDATE

We passed the parcel tax for fire and emergency services in June. When you receive your property tax bill, you will see this new assessment on to your bill.

Last week it was reported that Marin County would receive several million dollars back from the state as a result of the governor's signature on Assembly Bill 786. Depending on who you talk to the amount is somewhere between \$3.1 million and 5.6 million dollars. Some of the funds are mandated to certain budget items by AB786. However, a large portion is to go into the General Fund to be held as a rainy day fund.

The question many have is, of course, can any of this money be used to reduce or eliminate our new parcel tax. The short answer from the County Administrator's Office is NO. However, as of press time, this issue remains murky with many unanswered questions. To be fair to all sides we will continue to report once we have clarified the amount of available funds and how the County will disperse and reserve those funds.

## FIRESAFE MARIN TO STUDY PROPOSED PANORAMIC FIREBREAK

Firesafe Marin representatives Jack Rosevear (County Fire Marshal) and Wayne Clark (Marketing) met with Board Members Del Goetz and Keith Papulias on Thursday, Sept. 22 to discuss the feasibility and benefits of the proposed firebreak. Throckmorton Ridge Fire Safety crew on duty also attended. Discussion centered on the need to set standards for brush and tree trimming/removal and ways to get compliance from property owners. It was noted that residents aned the State Park have done an immense amount of brush and tree removal. The County has been most negligent in its failure to trim trees along the Panoramic right-of-way, citing budget cuts and lack of funds.

Our Association will submit maps to Firesafe Marin outlining the areas needing attention and filling them in on the State Park burn areas. When mapped and laid out topographically, it shows that we can create a defensible firebreak along Panoramic.

## **BOARD MEETING HIGHLIGHTS** SEPTEMBER 7, 1994

The State Park is donating wood to construct the Fire Danger sign at 4 Corners. It's up to us to get the sign completed.

A motion was passed to donate up to \$1000 to the Carter Collins Defibrillator Fund. We will contact Bank of Marin, who's handling the fund, to find out how much has already been donated and how much is needed.

The nominating committee reported that the following individuals have consented to candidacy for the Board of Directors in 1995: Del Goetz, Pres., Keith Papulias, V. Pres., Clif Davenport, Treas., Erika Teahan, Secy., Randy Barrow, Lila Daniels, Kathleen Delehanty, Barney Lenheim, and Bernie Moss.

Details of the Oktoberfest Fundraiser for a new siren were discussed. Keith Papulias has an 11 foot bar (pre-1906 quake vintage) he can loan to the Assn. for use in the Clubhouse.

The Mountain Emergency Team list will be published in the Lookout. Randy Barrow reported the AM radio station call letters are WNEG 346; AM frequency is 1280, and it's still not operable.

### PRESIDENT'S LETTER

Summer's over and, hopefully, so are most of the accidents on Panoramic Hwy. Panoramic is just what it says it is -- a great view of a lot of area. People come here from all over the world to experience what we get to see each and every day. While some folks are stopping to smell the roses, others are whizzing by in a big hurry to get "over the hill". The differences in speed combined with the lay of the land create a tremendous accident potential. And, we have the accidents to prove it.

Hikers, walkers, skaters, bikers, motorcycles, autos, trucks and motor homes all share Panoramic Hwy. The ones who seem to get hurt the most are the bikers. A neighbor of mine broke her collarbone when her tandem bike went over on Panoramic. Residents are complaining about cars speeding and want to do something about it. Suggestions for improving safety include widening Panoramic for a foot and bike path on one side. It's a terrific idea. Three years ago we suggested that the County widen the road when the new paving went down. "Too expensive" was the reply. Well, if we take a look at the cost of the accidents, it's a whole lot cheaper to pave an apron & restripe.

Personally, I think that bicycle owners should be licensed -- as they are in almost all other states -- and the tax money used to build bike paths. Fifty years ago, when I got my first bike, I had to pay \$3.50 for its license. Make the tax based on the purchase price of the bike, like they do on autos. Hit the \$2500 fancy mountain bikes with a \$50 annual tax and work it down to a minimum tax of \$10 per year. It would give our county over a million dollars a year to build bike paths. Cars and trucks pay a road use tax, why shouldn't bicycles. And, it could save lives.

Another lifesaver is a new siren. The one we have now is an old World War II air raid siren. Its location at the firehouse prevents it from being heard on the west side of Throckmorton Ridge -- especially towards 4 Corners. As one resident so succinctly put it: "What good is it to have a radio station if we can't hear the siren that alerts us to turn on the radio?" So dear resident, please dig into your larder to find some "white" or "gold elephants" that you can donate to our silent auction. And, please buy tickets or make a cash donation to the Oktoberfest. All proceeds will go to purchase a siren to be located on MWPCA property.


